#### Order

An Expression of Legislative Sentiment recognizing:

That January 18th marks the eighth anniversary of the passage of the Equal Rights Amendment by the State of Maine. (S. P. 782) presented by Senator NAJARIAN OF Cumberland (Cosponsors: Senator CLARK of Cumberland, Representative BERUBE of Lewiston and Representative NELSON of Portland).

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Najarian.

Senator NAJARIAN: Mr. President and Members of the Senate, today we remember the eighth anniversary of the day when the Maine Legislature ratified the Equal Rights Amendment. While ERA has not yet been added to the U.S. Constitution, this is a good occasion for us to remember the wisdom of the Legislature's action in 1974 and to reiterate the need for an amendment to the U.S. Constitu-

The Equal Rights Amendment is still necessary because thousands of state laws and many federal laws still discriminate against women solely on the basis of sex. Women are hurt by these laws in employment opportunities, in wage discrimination; in the manner in which the laws treat property and support in marriage and divorce; in social security, pensions, disability insurance; and in educational opportunities.

In economic terms we find the most graphic measure of this inequality. Women still earn on the average - only 59¢ for the \$1.00 that men earn. This gap affects all of us. It means a working couple really takes home 1 1/2 salaries when both work full time. It means that women on welfare find it extremely difficult to get off welfare because the laws work against them. And it means that as women reach the age of 65, they can look forward to joining the multitudes of elderly women who live below the poverty line.

The work incentive program, for example, is

required by statute to give priority to the placement of umemployed fathers, even though 3/4's of those eligible for the program are women. When women are placed by win, their average entry wage is only \$2.97 an hour while the average entry wage earned by men placed by the program is \$4.00 an hour.

But ERA is not just an economic issue. It is an issue of simple justice - of ridding our laws of outdated and unfair legal assumptions and practices. Only a constitutional amendment to the federal constitution can shatter this presumption. We earnestly hope that the Legislators in the remaining unratified states come to see this issue more clearly, and join us in support of the ERA

In the meantime, though, I am proud to be a member of a legislature that eight years ago took its stand for equal rights. I am glad that in Maine we recognize that the women and men of America deserve no less than a secure, constitutional guarantee of equal rights and equal dignity under the law.
