The PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Carpenter.

Senator CARPENTER: Mr. President, Ladies and Gentlemen of the Senate, on your desks this morning, I had distributed a number of these Agent Orange, Self-Help Guides. First, I would ask that if any of you do not need this to take back home, to any of your constituents, or do not have a place for it, that you return it either to me personally, on my desk, or the Senate Minority Office, as they are in rather short supply, and hopefully, at some point, they're going to be in rather large demand.

Ladies and Gentlemen of the Senate, I will be brief this morning. This is the same bill I presented to the Legislative Council, or it is the same thought, asking for funds to fund the Agent Orange Information Committee. I understand that there's a thought, among some of you, that enough is presently being done by the Committee. Enough is being done by someone in this area. It was said to me, by somebody, who I believe will be opposing me this morning, that they thought taxpayers money shouldn't be spent for this sort of thing.

My comment then and my comment now is that taxpayers money bought my ticket to Vietnam, and taxpayers money bought the socalled 'Agent Orange' ', which was spread around the country of South Vietnam for about ten vears. There are indications that about 17,000 Maine combat veterans, army, navy, air force, and marines, coast guard, were exposed to this substance about which we don't really know very much during the approximately ten years that it was used in Vietnam.

It was used as a defoliant. It was put out by Dow Chemical Company and some of the other larger chemical companies. It was very good. It was extremely good. It knocked vegetation off trees like you wouldn't believe. I've seen areas that were so thick you couldn't walk through them, and a week later didn't have as much vegetation as this Senate Chamber does.

The problem appears to be that it may have, and I don't stand here today to tell you that it did, but it may have caused some pretty severe, severely adverse side effects. That's something that this government of ours, at the federal level, is going to have to grapple with. It's just now beginning to grapple with it through some research.

What we need, what I think we need at the State level, is some help getting the information out to these 17,000 people about what the

federal government is doing.

There's a physical that is offered by the Veterans Administration, that is free to any veteran who may have been exposed to Agent Orange, at Togus. Any of us that were exposed are supposed to go get our physical, not that the physical is going to tell you anything, because they don't do fat biopsies. They don't check your system closely enough to find out if you still have dioxin in your system.

The most important part of this physical, in my opinion, is that it does an extensive medical history; regarding birth defects in veterans' children, regarding cancer, regarding liver problems, regarding chloracne, a new word that has been coined since Vietnam. Chloracne, which is just acne, persistent, long term chronic acne over all parts of your body, is the only thing that is presently compensated by the United States Government as related to Agent Orange.

So we do know that there is at least one physical problem. And yet today, we have only examined about 900, I believe, people who were veterans, who were in Vietnam, who were exposed to this. Why is this? Because many of them don't want to remember about Vietnam, don't want to know about this, don't know that there's a physical, and don't know that they many be able to get mileage, may be able, or that they might be able to stay overnight at Togus if they come from Aroostook, or Washington, or Oxford, or some of the other outlying counties. That's a possibility. This guide will give them the information they need to make an informed judgement.

If the physical isn't going to help, then why should they have it? The United States Government has extensive statistical data on the incidence of cancer, the incidence of liver problems, the incidence of birth defects among people of my generation, of your generation, of all generations. In order to compare that to the same disease incidence in Vietnam veterans, we've got to know what those people are suffering from. We can't do that unless we can do the medical history that is associated with this examination.

All I'm asking for, all this Committee is asking for, is the assistance to print these brochures, to put these brochures everywhere in the State of Maine where a veteran might trip over them, because they're not coming forward. They're not like World War I, World War II, and Korean War veterans. They have gone back into the woodwork.

Seventeen thousand combat veterans in the State of Maine, how many are in the Legislature? How many do you run into on a day-today basis that you know were in Vietnam? It was a dirty war, it was a nasty war, and nobody wants to talk about it. Nobody wants to remember it. They're gone into hiding. They're out there. You see them every day. Many of them now have long hair and beards, so you don't recognize them as GI types, but they're out there.

Some of them, I sincerely and honestly believe, are dying from this stuff, and I feel very sorry for them. There isn't one thing we can do about it, but maybe to help some of the ones in whom this disease has not yet manifested itself, maybe we can get enough data compiled, maybe we can get enough of these things out, to get enough data compiled to help somebody else down the road.

The Committee is doing nothing, we can't. We don't have any funds. If you look in the booklet, you'll see who is on the Committee. It's not a political committee, Dr. Nersesian, myself, Jim Tukey, Bob Comeau, Sterling Doughty, names that aren't household names in the State of Maine. I was asked to go on there because I am a veteran, because I was exposed to Agent Orange, and, probably because I'm a politician.

I'm not trying to make this a political issue, but what I'm pointing out to you is that every veterans' group in the State of Maine supports this, yet there is not one dollar today to print these brochures. Don't ask me where these come from, because they're being robbed from some other department. We don't have the money to get out nearly enough to the veterans.

There are civic organizations, and banks, and places like that that have been most cooperative as far as allowing us to use their facilities to leave these things lying around. But we can't print them. We don't have any money. That's what I'm asking for.

There's no price tag on this Bill. The original bill asked for \$10,000. If this Order passes the House and Senate, I would hope to be able to sit down with Senator Perkins, Senator Najarian, Senator Huber, and come up with a figure that would be necessary.

I'm not asking for mileage to serve on this Committee, I'm not asking for per diem to serve on this Committee, and neither is any member of that Committee. We're asking for enough money to print these little orange brochures that catch your eye, that have a map of Southeast Asia on them, so that some veterans out there could be aware that this is available, and maybe that's the reason that they're having some of the problems they're having.

We've got to document this, because mark my words, my friends, the day is going to come, in my opinion, my very unqualified, unmedical opinion, when Agent Orange is going to be linked to specific diseases in specific people. If we don't know who those people are, or where they are, we can't do a thing to help them. That's all I'm asking for.

No one else is doing anything as far as putting information out. No one, other than this Committee, this ad hoc, non-State, non-legislative Committee. We can't do anything until we get enough funds to print the darn bro-

chures. That's all I'm asking for.

I would ask you this morning to give me your support. If you want to vote against the Bill when it comes up, if you want to vote against funding it, if you're on the Appropriations Committee, that's a whole other battle. This is an issue that we, as elected Senators and Representatives of the State of Maine, ought to be discussing, because it affects 17,000 of our people, their families, and their friends

Mr. President, I would ask for a Roll Call. The PRESIDENT: A Roll Call has been requested

The PRESIDENT: The Chair recognizes the Senator from Knox, Senator Collins.

Senator COLLINS: Mr. President, the work that the Information Committee concerning Agent Orange is doing is good work. I applaud the interest of the Senator from Aroostook, Senator Carpenter in this endeavor.

The objection that I have to his proposal relates to who should be doing the work, who should be funding the work, that is going on.

I respect the persistance of the good Senator,

this is the fourth try that he has made. It was three times defeated for admission when it came before the Legislative Council

This morning as I was getting up and breakfasting, and then starting to drive to the State House, I saw an item on television that talked about Agent Orange that expressed some of the very same views the Senator from Aroostook, has expressed. As I drove the miles to the State House I was listening to my radio and I heard on two different stations the same information, the same appeal to Vietnam veterans to have an examination with their home town doctor and then to go to the V.A. for the help which is available there.

This problem was caused by the federal government, it is being responded to by the federal government through the Veterans Administration. It is being responded to by the media. Television, radio and the newspapers have given this topic a vast amount of space in the last month or so, and they continue to do so.

So for all of the merits that this program has, for all the good that is involved in the effort. I still present to you the view that the work being done by the federal government, by the veterans organizations, by the volunteers, by the press, the radio, and the television is an adequate effort to inform the people, who are willing to be informed, about the need for physical examination.

I submit to you that the State of Maine does not need to spend its money to help in this effort. I would, therefore, move that this Order

The PRESIDENT: The Chair recognizes the Senator from York, Senator Wood.

Senator WOOD: Mr. President, and Men and

Women of the Senate, I would remind you that several years ago when the DES issue was before this Body that we had the same arguments: the federal government was doing things with DES, the newspapers, the media, there were a couple of TV shows that were doing stuff with DES, and we decided as a Body that we should do something about DES. We funded a program that was run from the department to make children of DES mothers aware of the potential problems with DES.

I would argue that DES did not affect as

many people as this program does. I think that we have established the precedent, and I think, that we should take this step to help another segment of our population with a problem that was not created by the State of Maine.

DES was not created by the State of Maine. Agent Orange wasn't but we felt duty bound to help our citizens in that case, and I think, we should today in this case.

The PRESIDENT: The Chair recognizes the

Senator from Cumberland, Senator Conley,

Senator CONLEY: Mr. President and Members of the Senate: It is not my intention to belabor this issue, at all. This Order or this Bill, which was brought before the Legislative Council. was denied entrance into this Session of the Legislature by one vote, by one vote. The good Senator from Aroostook, Senator McBreairty, spoke of partisanship on many of the items that came before the Council's agenda. This clearly was one of those issues.

I don't believe the good Senator from Aroostook. Senator Carpenter, is asking for very much. He's asking for a hearing, for a hearing, to give some of those veterans from Vietnam the opportunity to speak out, to be heard, and to try to demonstrate to this Legislature that there is a need that's unfilled.

Last evening, as I worked through the night, I had the opportunity of listening to a radio show called "The Larry King Show," which was on WGAN in Portland. It's on an all-night talk show. There was a guest on that program last night. They had Mr. Max Cleland, a triple am-putee which you all know from Vietnam, who served as the head of the Veterans Administration during the Carter years

I had never had an opportunity to listen to

Mr. Cleland in the four years he spent as the head of the V.A., but it certainly was an eyeopener to me of the problems the veterans of lietnam, what they are going through since the day they returned from Vietnam.

I think not to allow the entrance of this Bill into this Session of the Legislature is a direct slap in the face to those who put their pride in their back pocket and provided a service for this country. I think it's unfortunate the Bill was not given the additional vote needed to be allowed into this Session of the Legislature.

I urge the Members of this Senate to join me and the rest of us to make sure that this Bill is allowed in, and that a fair hearing and opportunity is presented to these veterans and give them their day in court.

The PRESIDENT: Is the Senate ready for the question?
