Senator GILL: Mr. President, I'd like to just comment on the recognition that we're paying to Ingraham Volunteers. It has performed a great service to the community of Portland, and as of late, to the State in general, because of the communications that have been received through it by the teletype operators in the deaf community.

I might say that since it was begun in February of 1970, a trained volunteer has been there to answer all crisis calls. There have been over 100,000 hours of hot-line service provided: 3,600 hours of communications with the deaf community, and over 75,000 hours of crisis calls. These are all handled by trained volunteers under the able direction of Neva Cram. Since it has been in operation 12 years, I think it's time that we showed our appreciation to them.

Under Suspension of the Rules, the Bill Read Twice

The PRESIDENT: The Chair recognizes the Senator from York, Senator Hichens. SENATOR HICHENS: Mr. President, before we take action on this Bill, I have had a request that it be explained because some of the Senators naturally, and quite often I, wonder why we push a Bill through like this. I would like to defer to the good Senator from Aroostook, Senator McBreairty, and ask him if he can explain just what's going on up there in Aroostook County?

The PRESIDENT: The Chair recognizes the

Senator from Aroostook, Senator McBreairty. SENATOR McBREAIRTY: Mr. President and Honorable Members of the Senate, in the first Session of the 110th Legislature, we enacted the Maine Potato Quality Control Program. That program became fully operational on February 1, 1982, at which time rules adopted by the Board took effect.

The law establishing that program established certain information be included on any bag subject to the program, called the Maine Bag, and prohibited other information from being included on consumer packed potato bags that were not in the program.

It has since become apparent that many bags currently in inventory will be technically out of compliance with the law, and this will create a hardship on many people in the potato industry.
This Bill will correct these and other techni-

cal problems as follows: Section 1 of the Bill corrects an incorrect ref-

erence

Section 2 of the Bill clarifies the term "consumer packed". It does not include a master container.

Sections 3, 4, and 5 of the Bill changes and clarifies what is and what need not be a Maine bag. A Maine bag is defined to be any consumer pack of potatoes on which appears the word "Maine", or the shape of the State, except as otherwise provided.

Sections 4 and 6 deletes from the law the requirements that Maine bags shall contain a statement that the contents have been inspected and not the grade standards of the Board. and b) a consumer pack potato bag that is not a Maine bag may contain the word "Maine" only in the name and address of the producer, packer, or any other person, at the bottom of the bag in letters not taller than 1/4 of an inch and 2) a bag manufacturer's identification mark, or bag distributor's identification mark is made exempt from this chapter or title.

Section 7 of the Bill clarifies that funds appropriated for potato inspection by the bill establishing the Maine Potato Quality Control Program shall be used only for inspections conducted under the program. Requires the commissioner to separately account for all funds appropriated for the program, and provides that funds for the program, that were appropriated last year, shall not lapse before June 30,

It is my understanding monies appropriated to carry out the Maine Potato Quality Control Program will not be spent to subsidize inspection on any load shipped prior to February 1,

The PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Carpenter.
Senator CARPENTER: Mr. President, it gives me great pleasure this morning to rise in concurrence with my brother from Aroostook, Senator McBreairty. We've had a problem with this bill ever since it was passed last year. Sub-sequent to that passage, the Attorney General

had some thoughts on it.

It's a good program. It's going to assure anybody buying a bag of Maine potatoes, henceforth, that has either the shape of the State, or the words "State of Maine" on it that they're getting an inspected good quality product inside.

I had some reservations with the way this compromise was originally drafted. Jim and I worked on it last week and over the weekend, in conjunction with members of the other Body, and this compromise was sort of thrashed out.

We're not taking anything away from the program, I don't think, really, depending on how good a job in promoting this whole pro-gram the Department does. I think it's a good program. We need these minor changes in order to get the program off and running. Thank you.
