Senator MINKOWSKY: Mr. President and Members of the Senate, in the spirit of compromise this afternoon, I'm going to propose an amendment to this particular Bill, since I am a member of the Low-level Waste Siting Commission, along with Senator Trotzky. It's being done primarily for one reason. That is to follow what I consider the intent of the law as designed and passed last year.

For the record, I think it's of paramount importance to insert in there some of the provisions of the Low-level Waste Siting Commission. Number one, when this Commission was formed, they did start with an appropriation for 1981 to 1982 of \$5,000, and in 1982 and 1983, another \$5,000 as of last year. This is the law I hold in my hand.

Also, it's important to bring out, under Duties of the Commission, number 5, Compensation. Members, except State employees, shall receive reimbursement for the necessary actual expenses incurred in carrying out their duties. The only ones who have received travel are the members of the Legislature on the Commission. We do not get per diem

Number two, Assistance. The Commissioner of Environmental Protection shall assist the Commission in the conduct of its business, which has transpired during the interim period of time when the Legislature is not in session, with Commissioner Henry Warren as Vice-Chairman of the Low-level Waste Siting Commission.

Under Section 176, Low-level Waste Siting Fund, it's important to insert in the record, this Fund shall be administered by the Commissioner of Environmental Protection in accor-

dance with established budgetary procedures. Finally, in Section 3, Allocation. The expense for the administration of the Commission in carrying out the duties as set forth in the subchapter shall be paid for with such funds as the Legislature, I emphasize, as the Legislature, may allocate from the revenues in the Lowlevel Waste Siting Fund. That's just what I'm doing this afternoon. I'm going to what I consider Legislative Intent.

The original Bill itself called for a \$10,000 appropriation in the year 1981 and 1982, and another \$10,000 appropriation in 1982 and 1983. In my estimation, it's ridiculous to ask for this kind of revenue. I think, basically, that if anybody wants to travel and investigate this matter further, more than the Commission itself at the present time has done, it's incumbent upon then to appear, as I mentioned previously, before Legislative Council and request the additional monies. But to appropriate this money blindly, I think, is a very serious mistake.

The Amendment I propose this afternoon, Mr. President and Members of the Senate,

takes off the Emergency, and according to staff, again I emphasize, according to staff, the maximum amount or appropriation they came up with that could be utilized during 1982 and 1983 is \$2,500, not \$10,000.

I hope, Mr. President and Members of the Senate, you do Adopt this Amendment and send this Bill forthwith.
