Senator REDMOND: Mr. President, Mem-

bers of the Senate: I'd like to speak to the Order. Our Mother of the Year, Rose Allain, is from the community of Madison. She has been involved with children and providing leadership for many years. Her respect from her associates is well known throughout the State.

Rose has been a Girl Scout and involved in scouting for over 46 years. She is a member of the Daughters of Isabella and the Knights of Columbus Auxiliary. In October of 1981, she was named to the Board of Directors for the United People's Home, which houses mentally retarded adults in Madison.

Throughout the years, Rose has cared for her two sons and many other children. Her main contribution, however, has been the operation of a day-care center for nearly 36 years. The success at which she was davtime mother to numerous youngsters is shown in many letters. Children she cares for have all come to know her as Auntie Rose. The name is known to children of children she has cared for and is synonymous with being a loving and caring person. The children she cared for long ago always stop in to visit Auntie Rose when returning to the area, and can all relate the vivid memories of time spent with her through the years

Rose was not only a daytime Mother, but a guidance director and advisor to many, many people, and recognized expert at the art of taking care of children. Rose's activities have earned her recognition from her peers, scouting associates, as well as various service organizations

Girl Scouting has recognized her efforts in many ways, most notably the Thanks Badge and the coveted St. Anne Award. In 1969, she was awarded the Community Service Award by the local American Legion Post. The next year she was honored by coming in second as the American of the Year by the Madison Veterans of Foreign Wars. Rose's church contributions also led to her being nominated as diocesan representative for the State of Maine.

This past year has been especially rewarding for Rose. She was selected as co-parade marshal for the annual Father Raoul Festival Parade. In a related event, she was nominated for the annual Knights of Columbus Citizen of the Year Award. The Knights of Columbus recognized both Rose, her son Gary, and his wife Joan, as recipients of the Family of the Year Award in 1981. The Award was presented in special recognition of her continuing contribution to family life, even though the children are grown and no longer at home.

Senator SHUTE: Mr. President, I move the

Majority Ought Not to Pass Report.

The PRESIDENT: The Senator from Waldo, Senator Shute, moves that the Senate Accept the Majority Ought Not to Pass Report of the Committee.

Is this the pleasure of the Senate?

The Chair recognizes the Senator from Androscoggin, Senator Charette.

Senator CHARETTE: Mr. President, I'd like to speak on L. D. 1818, in favor of the Minority Report. I'd like to address myself to the women and men of the Senate.

This Legislation, L. D. 1818, as amended by S-382, simply allows the Commission to establish additional agency stores on a seasonal basis in areas where there is a great influx of people and traffic during peak tourist periods.

Our current State stores, as well as agency stores, are almost without exception, located on U. S. Route 1, while the bulk of the facilities providing public accommodations are located in areas east of U.S. Route 1.

Seasonal businesses are a way of life in our tourist-oriented State. What we are attempting here is to orient our business to the needs of our tourists, as well as the citizens of our State.

Some of the key points, this will provide a needed service in our tourist communities, alleviate traffic congestion, and provide additional revenues for the State, and gosh, we need that, estimated to the tune of about \$200,000.

The Committee Amendment, S-382, addressed some of the problems that came up in the hearing. I'd like to point out what this Amendment will do. It will, one, limit to ten stores. It will, also, give a limitation of one agency store in any municipality. Also, the definition of seasonal is to include only the period from Memorial Day weekend to the day after Labor Day.

Now, not only tourists from out-of-state visit Maine during this particular season. I, for one. as a Maine resident, do travel Maine quite a bit. We do have a beautiful coastline, and from York to Cadillac Mountain, certainly there is a lot of traffic and an increase of population that is far beyond what our stores can handle during this period of the season

I believe that Kittery on from York, Old Orchard, Camden, Bar Harbor, Boothbay Harbor, up Cadillac Mountain, who knows. This is why the limit of ten stores, this is a trial basis. I'm not sure that as I've heard, or through discussions, that this is the way to open up the doors to becoming a State with just agency stores

We're talking here about a season. We're talking about tourism. We're talking about as many as 100,000 people in one community. We ought to be able to provide this kind of service to those tourists, as well as, our citizens of Maine.

And so, I hope that you vote for the Minority Report. Thank you. The PRESIDENT: The Chair recognizes the

Senator from Waldo, Senator Shute.

Senator SHUTE: Mr. President, Ladies and Gentlemen of the Senate, the reason the Legal Affairs Committee, the majority of the Committee, took the position on this Bill that it did. is, we had a bill in here last session that supposedly would do away with all State liquor stores, and have agency stores. That was soundly defeated, I think it was near unanimous in both Houses.

Now it looks, to the majority of the Committee, that if the seasonal stores are opened, the original Amendment called for 15 now its down to 10. If the seasonal stores are opened, and you take a place like Camden, or Bar Harbor, or Kennebunkport, or Falmouth, of any other places, Rangeley, if the profits drop in those stores, and certainly they will if they put an agency store in that town, next year, at least in one year, the State stores in those towns will be closed. Then you will be running with merely agency stores. I don't think this is a direction the people of the State would like to have things

Just this fall, the Commissioner of Liquor Control closed a store in Winslow, a State store, a State store that was making a good profit, and intended to open another agency store in that town. After he got the State store closed, he said he was closing it, then he found out that he couldn't open an agency store because there was another State store within a 10 mile radius. And still he says that he does not want to open a State store in that town. He'd like to have an agency store. So he's had legislation put in to that effect, that would open up the State stores within 10 miles of existing State stores and agency stores.

So, if you think the extra consumption of liquor in the State would be a benefit to the State and the welfare system and the AFDC system, and the other things that go with it, probably you should vote for the Minority Report

I read a report here a short while ago that the \$32 million that we collect in liquor revenue, costs the State several hundreds of millions of dollars in broken homes, AFDC, institutions and everything else. So, I think it might be wise to keep the State liquor industry under control. If we're not going to provide a service for people like Winslow, our Maine residents, I think maybe we shouldn't be quite so concerned about the non-residents coming in the State, because usually you can get liquor if you want it. There are an adequate number of stores. I think

The PRESIDENT: Is the Senate ready for the question?

The Chair recognizes the Senator from Cumberland, Senator Conley,

Senator CONLEY: Mr. President and Mem-bers of the Senate: I always enjoy listening to my good friend, the Senator from Waldo, express his beliefs on the free capital system within this State and country. And one, being a convert and a true believer in that system. I was one of those who supported getting the State out of the liquor business last year.

Seeing the fact that the Legislature chose the road of not doing that, it seems to me that we are in the liquor business, and if we're going to continue to be in that business, then we should at least provide a service for those individuals who wish to purchase alcohol.

I think the point that has been made here is that populations in Maine generally swell tenfold during our so-called recreational months in that period of the summertime. It seems to me that if we are interested in making all of our tourists happy, then we should make some means, through that period, making the purchase of alcohol a little more accessible

If the concerns of the good Senator from Waldo. Senator Shute, are that of the regular State liquor stores, their business would drop off significantly, and the stores would close, perhaps it might be a good idea to sunset this particular Bill for a year. just to take a look at it and see how things would respond in the trade of alcohol.

I know that there are many in this Chamber. at least sitting around this morning in Room 327. there was a great deal of concern about the number of dollars that was going to be generated through the so-called "premium tax." I'm sure everyone is waiting at the bits now to be able to shovel out some of that money in all directions as to who can yell the loudest to get it, but the fact is that this might even bring in additional revenues, as the good Senator from Androscoggin has stated.

Unless we're ready to vote for prohibition, we're going to continue to have those problems. At least I think it's the intent of those who are interested in this Bill, that those problems may leave the State, particularly after we close these agency stores down on Labor Day.

The PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Minkowskv

Senator MINKOWSKY: Mr. President and Members of the Senate: after listening to the good Senator from Waldo, Senator Shute I certainly hope that the Senate is not mislead into believing that the only ones who have a problem with alcohol are the AFDC cases or people on welfare. If that was the interpretation I got from it, I think it's entirely erroneous. Some of the finest people I know, Senator, are on welfare, that do not partake in the spirits.

I was involved in the Bill last year that was defeated. The only reason that it was defeated is because the State wanted to maintain the same level of profit instead of giving the agency stores a fair profit, so they could operate

During that segment of time, we also checked into one other factor, the history of the agency stores presently operational in the State of Maine. It's totally amazing to me that there was not at that particular segment of time, there was not one single violation against any operational agency stores insofar as selling to minors or anything else, where we had several cases of State employees in our State-operated stores selling to minors.

I think from the viewpoint of revenues, at least for a limit of time that it calls for in this particular bill, is a very, very feasible, and a practical approach to people who visit our State, who possibly can obtain liquor, as they have in the past, from the State of New Hampshire, and leave their profits with them and still consume their booze in the State of Maine.

I really believe that Maine should be somewhat open along these lines, change its some-what antiquated philosophies, and allow this to materialze. If we are going to be known as "Vacationland," and as a tourist state, then I think we should actually open it to that particular area.

It's ironic to think that we have not progressed to this particular point, where we have recognized the job that the agency stores have accomplished so far in the State of Maine. I'm sure from their limited history, had they gone astray, there would have been a bill in this session or the previous session to abolish agency stores in the State of Maine.

This has not been the case. They have been a very, very viable store, a very, very convenient store. I think basically we should look upon this, at least, as a mechanism at the present time, in which to allow this to materialize as is proposed in this particular LD by Senator Charette.

I certainly hope that you do Accept the Minority Report, as amended.

The PRESIDENT: The Chair recognizes the Senator from York, Senator Hichens

Senator HICHENS: Mr. President and Members of the Senate: a few years ago, the Legislature bought the idea that we should have agency stores throughout the State to make liquor more accessible for people, and to cut down the costs of the State-controlled stores. We were told we were going to have a limited amount to test it out. Before that time period was up, the Commissioner took it upon himself to open up several more agency stores. So, we put the brakes on.

As the good Senator from Waldo has stated, last year it was turned down as far as going out of State liquor business, monopoly State, which was a very wise decision. I believe. Here we have another foot in the door, so to speak.

We've been told by two Senators from Androscoggin that we need the extra revenues. Again, the good Senator from Waldo has stated that these extra revenues are not really extra revenues. It costs the State more for every dollar that we take in, to take care of the problems that arise from it.

This last session we passed a Bill that gives the State of Maine the honorable distinction of having the toughest liquor laws as far as drunken drivers are concerned. We also passed a public drinking bill. We also passed a bill to

allow for greater rehabilitation programs and so forth.

Now, we want to increase the sales so that those problems will increase. To me, it is like throwing gasoline onto a fire to put it out.

The PRESIDENT: Is the Senate ready for the question?

The Chair recognizes the Senator from Waldo, Senator Shute.

Senator SHUTE: Mr. President and Ladies and Gentlemen of the Senate: somehow the good Senator from Androscoggin, Senator Minkowsky, has a way of not quite knowing what I'm talking about on this Bill. I hope I didn't give the impression that the only people that have trouble with alcohol are AFDC, mothers or fathers or children, or anything like that, because I know some very well-to-do people who also have some trouble with it.

Last year, as the good Senator from York said, we did pass a strong law concerning drunken driving. Ordinarily our State stores close at 6:00 at night, or I think the latest is around 9:00 at night. Now, you would like to have the agency store in those areas, the vacation areas, stay open until 1:00 in the morning, for those people that can't get what they need by 9:00 at night, then they can go down after the beach closes up and they can go get their liquor and have their party.

I think the one thing that should be understood here is that if you put agency stores in all the recreation areas in the State, and there's no criteria whatsoever for a recreation area, it can be Bangor, or Waterville, or Millinocket, or Presque Isle, or wherever. It doesn't have to be Kennebunk, or Camden, or Bar Harbor. Those State stores will be closing in those areas, because the Commissioner just closed a State store in Winslow, which was running a good profit. Now if your State stores drop in profit, certainly they're going to be closed by the Commissioner

As far as sunsetting this Bill, this Bill sunsets every day after Labor Day. I'm sure the Commissioner would never close stores as long as there's a sunset on this Bill. Once it's removed, he certainly would close stores

Of course it might be a way of getting rid of State employees, if that's the object of the thing, but that's not really what I'm over here for

The PRESIDENT: The Chair recognizes the

Senator from Cumberland, Senator Najarian. Senator NAJARIAN: Mr. President and Members of the Senate: the Executive Director of the Liquor Commission just happened to be before my Committee this afternoon, and he was asked about what happened in Winslow with the State liquor store.

He explained that the lease was up on the store in Winslow and that they couldn't negotiate with the owner of the property who wanted to raise the lease rent by about triple or quadruple and there was another party who was interested who outbid them and the State was not going to be held over that kind of a barrel. There was no other property available in downtown Winslow and that is why the store is being closed out.

The PRESIDENT: The Chair recognizes the Senator from Waldo, Senator Shute.

Senator SHUTE: Mr. President, I do not want to belabor the Winslow store, but I think that if we are going to talk about the Winslow store that we might as well set it straight.

The Commissioner came before the Legal Affairs Committee and he was 45 days late in getting his letter to the Committee that he was closing the Winslow store. We got it 9 days before he wanted to close it, it is supposed to be 60 or 90 days.

We had urged him through two letters to keep that store open. We had written letters to the Appropriations Committee and certainly the Appropriations Committee got a copy of the letter, all the members.

Two weeks ago he was in our Committee

room and we asked him what he was going to do about the Winslow store? He said, as much as I hate to tell you, I guess that I am going to have to look for a place to open a State store. Prior to this he had told us that he did not have money enough to pay the new rent

So we wrote letters to the Appropriations Committee urging them to appropriate more money for the Liquor Commission.

Today I heard that he was now waiting to see what happens to the bill on the agency stores because he would like to change the law so that he could put agency stores within a 10 mile radius of other State and agency stores.

As I understand it he said today that he had plenty of money to operate a store up there. That is what the House Chairman of the Committee told me

In view of the foregoing determination, I hereby certify that these petitions have met the constitutional requirements of the minimum 37,026 valid signatures. Since the petitions have previously satisfied the constitutional requirements in all other respects, under the provi-sions of Article IV, Part Third, Section 18, of the Constitution of Maine, I do hereby declare

In the event the Legislature rejects this initi-ative proposal, a referendum election will be called for November, 1982.
