Senator HUBER: Mr. President, I request a Division and would speak briefly on my motion.

The PRESIDENT: The Senator has the floor. Senator HUBER: I would move that this Bill be Indefinitely Postponed. I think that this Bill is unnecessary, and although, I appreciate the reasoning behind its introduction I do not think that we can legislate judgment in these mat-ters, and come out with a reasonable answer.

I think there may be bond issues smaller then \$2,000,000 which would be appropriate for bonding, perhaps depending on the condition of the General Fund should be bonded.

I do not think that this is a wise measure. I do think that it eliminates legislative judgment. I hope that the Senate will see fit to Indefinitely Postpone it

The PRESIDENT: A Division has been requested

Will all those Senators in favor of the motion by the Senator from Cumberland, Senator Huber, that L. D. 1782 be Indefinitely Post-poned, please rise in their places to be counted.
