The report in the newspaper this morning about the impending cuts is the provocation for this letter. The proposed cuts include 70 employees at Pineland Center, 17 at the six regional offices of the Bureau of Mental Retardation, 7 at the Levinson Center, making a total of 94. In addition, it is my understanding that 75 subsidized foster homes for the mentally retarded would be eliminated.

The effect of such cutbacks would force the Court to re-examine whether the State has fallen out of compliance with the Consent Decree of July 14, 1978.

I am writing you to apprise you of the Court's concern about any cutbacks in staff or number of foster homes. The State has made such excellent progress towards meeting the requirements of the Decree that, until the reported cutbacks, it has looked as though compliance and discharge by the Court could be achieved in just a few months. But if these proposed cuts were made, reaching compliance in the near future would be out of the question.
