Attached is the Final Report of the Highway Cost Allocation Steering Committee. This is a report of highway equity, not highway need. A statement of highway and bridge needs for Maine is under preparation for your consideration. The two documents should be used together to define the amount and form of user fees or other funding.

Recent action taken by the United States Congress with regard to the five cent a gallon increase in the federal fuel tax and other taxes and fees dedicated to the National Highway Trust Fund does not satisfy either equity or need in Maine. Although favorable to Maine it has, in fact, added last minute pressures to highway funding. The satisfaction of both future highway equity and highway needs in Maine depends upon thorough analysis of the impacts of the increases in the several taxes. This analysis will be completed by the Maine Department of Transportation, and a report will be prepared for the Legislature.

In the meantime, the legislation recommended by the Highway Cost Allocation Steering Committee is being developed by the Maine Department of Transportation.

Mr. President, Ladies and Gentlemen of the Senate, when this proposal came before us last week it rang a bell, somewhere in the back of my mind, so I set it aside. Being the State Senator from Penobscot and Piscataguis Counties, I represent the geographical terrain of which Baxter Park presides in, and serve on the Baxter Park Advisory Board, as well.
