I am pleased to submit the enclosed report on planned activities and recommended allocations for FY 1984 from the Alcoholism Prevention, Education, Treatment and Research Fund. Pursuant to 28 M.R.S.A. § 475, this report has been prepared through the cooperative effort of the Department of Corrections, Department of Educational and Cultural Services, Department of Human Services and the Department of Mental Health and Mental Retardation.

This document is the third report prepared by the four departments regarding recommended allocations from the Alcoholism Prevention, Education, Treatment and Research Fund. Martin:

In accordance with the provisions of 5 MRSA, Section 1128, the Board of Trustees of the Maine State Retirement System hereby notifies you that a 4% increase in retirement benefits paid to retired state employees, teachers and retirees of certain participating local districts, was authorized effective September 1, 1982. This was a cost-of-living increase. The Consumer Price Index (CPI-U), published by the United States Department of Labor, Bureau of Labor Statistics, increased 7.1% in the twelve month period ending June 1982.

In addition, the second regular session of the 110th Legislaturel enacted PL 1981, c. 702, Part U, granted those persons eligible for an annual adjustment in retirement allowances under the above referred to statute, an additional one-time cost-of-living increase of \$.50 for each year of creditable service payable in September 1982. Recipients of survivor or disability and other recipients of benefits based on criteria other than length of creditable service received a 2% increase in there allowances, also payable in September 1982.
