The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Bustin.

Senator BUSTIN: I move that the Senate Accept the Minority Ought to Pass Report

The PRESIDENT: The Senator from Kennebec, Senator Bustin, moves that the Senate Accept the Minority Ought to Pass Report of the Committee.

The Chair recognizes the Senator from Cumberland, Senator Gill.

Senator GILL: I would urge that the Senate Accept the Majority Ought Not to Pass Report. This Committee, the Health and Institutional Committee, heard no documented need for this particular vehicle.

The Department of Human Services has rules and regulations, in place, and I would like to quote from them. They require that generic drugs must be dispensed when their generic substitution box is not checked and those drugs are there Generically. The Department of Human Services will not pay a pharmacist for producing other than generic drugs when their generic equivalent is there, so there was no need.

The sponsor of the Bill has had some problems with a particular pharmacist, who refuses to carry generic drugs. That is a particular problem with that particular pharmacist.

We did bring the Department of Human Services in, the people who deal with the reimbursement situation with generic drugs, and there was no documented need at all for this. The rules and regulations take care of it effectively, and that's why that the Majority of the Committee signed the Report Ought Not to Pass

The PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Carpenter.

Senator CARPENTER: Mr. President, Ladies and Gentlemen of the Senate, I would concur with some of what the good Senator from Cumberland, Senator Gill had to say. However, I don't think I could go along with the idea that this is just an isolated incident involving one of the sponsors of the Bill. I'm the cosponsor of the Bill, because I was concerned, became concerned, that there were situations where generics were not being dispensed in programs that the State was providing.

This Bill goes one step further, as Amended, it does not mandate that in all cases the generics be offered, because we recognize that pharmacists are professionals. We didn't want to tie their hands, so we backed away from that and the language in the Amendment, which is H-23, the language in there is essentially the language that is now in the regulation.

I guess maybe, what we have here is a philosophical question of whether we are going to allow bureaucractic policy to dictate the way that the Generic Drug Program operates, or whether we're going to allow Legislative policy to do that.

It's our opinion that there are instances, they may not be widespread, there are instances where the intent of the Legislature is not being followed. This is going one step further in saying, okay, if the generic is available, if the same mode and type of delivery is available, then you should dispense the generic. I think there is a need, it may not be a large and overwhelming need, but I think that there is a need. and I hope that the Committee will Accept the pending motion. Thank you. The motion to Accept the Minority Ought to Pass Report.

The PRESIDENT: The Chair recognizes the Senator from Washington, Senator Brown.

Senator BROWN: Thank you, Mr. President. Ladies and Gentlemen of the Senate, I have some direct interest and concern over this particular piece of legislation and did a little bit of research with the local pharmacist in my own town. It was my understanding in talking with him that there was absolutely no need whatsoever for this particular piece of legislation, and furthermore, I think that even the Pharmaceutical Association has not supported the legislation, and that the Department already does, in fact, do all the things that this Bill is supposed to do. So, I would urge that you Accept the Majority Ought Not to Pass. Thank you, Mr. President.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Gill.

Senator GILL: May I just add to the Senator's information that we did ask the Department people to come back.—we asked them to do an audit of various drug stores as they licensed them, and if they found that there was some abuse to come back and we would be glad to have this legislation again in another Legislature. As of this point, there was no documentation and there was just absolutely no need, as we saw it, for the Bill.

The PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Carpenter.

Senator CARPENTER: Mr. President, Ladies and Gentlemen of the Senate, just to clarify two quick points. One, if there was absolutely no documentation, absolutely no showing of need, then why do we have this Department of Human Services running around the State, now investigating? That's my first point.

My second point is, in response to the good Senator from Washington, Senator Brown, it may be the strongest testimony yet as to the worthiness of this Bill, is the fact that the Pharmaceutical Association is opposed to it.

Thank you.
The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Bustin.

Senator BUSTIN: I concur with Senator Carpenter, and I believe that Senator Brown's testimony is the best one in support of this Bill.

If the Department had been keeping track of things they would have been able,-the Bill would not have appeared before my committee. We worked out this solution with the Pharmaceutical Association, and they concur that this may be the best way. They would rather see it not in law. How many times have we heard that? Of course, nobody wants to see anything in law. That this will make everybody pay attention to what should be done and it does cost the State a lot less to have those generic drugs (passed over the counter), prescribed.

One of the reasons I feel that they aren't doing that is because they may have something going with a drug company; they don't want to handle the generic drug. They may not be able to get other drugs if they are not dealing with a particular company. So, it's better for them if they just handle one line. That doesn't help the

consumer and it doesn't help the State of Maine.

I urge passage of the Minority Ought to Pass Report

The PRESIDENT: The Chair recognizes the Senator from Washington, Senator Brown.

Senator BROWN: Thank you, Mr. President. Ladies and Gentlemen, I stand corrected on the very important testimony that I gave awhile ago, in that the Pharmaceutical Association do not, rather they do, excuse me, they do support this Legislation. So, I suppose the strength of my earlier statements have completely been removed, and again, I, still, am convinced there is no need for this Legislation. Thank you, Mr. President.

The PRESIDENT: The pending question before the Senate is the motion by the Senator from Kennebec. Senator Bustin that the Senate Accepted the Minority Ought to Pass, as amended, Report of the Committee
