Senate called to order by the President.

Prayer by Reverend Douglas Morgan Strong of The All Souls Unitarian Church in Augusta. REVEREND STRONG: As the Women and Men of this Chamber start the efforts of yet another day, let us pause for a moment of remembrance; for the blessings of our lives, our homes, our communities, and our Country; for the privilege of being part of a family, for the privilege of belonging to a neighborhood of people; for the privilege of living in this State and a Country, where freedom is not simply a word but an opportunity for us all.

We pray that we may seek those things that are worthy, not simply for ourselves, but that we may share what is truly blessed with one another and with all humankind. Amen.
