Senate called to order by the President.

Prayer by The Reverend Winthrop E. Jackson, retired from St. Andrews Episcopal Church of Winthrop

The PRESIDENT: The Chair recognizes the Senator from York, Senator Danton.

Senator DANTON: Mr. President and Members of the Senate, this Bill is too well greased for me to try to stop it here today, I'm not going to even attempt to do that. I can't help but get up and just say something about this type of funding for a department.

It just doesn't look right to me that we should have taxes on Fire Insurance Policies that are sold by the industry and then have that department going around investigating fires. You know, with some great interest, I have observed that every fire that is investigated there's always a "suspicious origin" that took and started this fire.

Now, the department should be funded by general monies. It shouldn't be so obvious that it even looks as if there might be a little bit of collusion involved here between the insurance companies and the department. I'm not saying that there is; it just doesn't look right.

I have attempted, in the past, to slow down this type of legislation. I can remember a few years ago in here, there was a Sprinkler Alarm Bill that was introduced, and the Bill was amended down, quite abit to allow for local fire departments, volunteer fire departments to go around and inspect the motels and the hotels. The Bill was designed to take and provide safety for the people staying in those units. Instead of the department just laying back and allowing the local fire departments to do that, they went around, throughout the State, especially in my County they had subpoenaed fifty-eight hotels and motels into the local court in Biddeford, for not having proper systems, when it was the duty of the local fire departments.

So, today, I am going to vote against this. I just thought that I'd like to get up and put something on the Record, that in the future, the Legislature should look at funding the department.

Personally, I don't even think we need the department. I think the State Police can do a better job, because, whenever they have an investigation they have to call the State Police to investigate.

I'm going to vote against it, and I just thought that for the Record, Mr. President, and Members of the Senate I'd get up and say a few words on this issue.

This being an emergency measure and having received the affirmative votes of 22 members of the Senate, with 4 Senators having voted in the negative, was Passed to be

Enacted and having been signed by the President, was by the Secretary presented to the Governor for his approval.
