Legislative Resolves, Chapter 55 (1977), requests that we, the undersigned, submit an annual report on the status of fish passage at the Augusta Dam. Please accept this letter as evidence that we are meeting our obligations.

To the best of our knowledge, there has been no change in the proposed upgrading of the hydro-generating facilities at the Augusta Dam. We have had no additional responses from the owner of the dam and must assume that retro-fitting or upgrading of this site will be contingent upon re-issuance of the Federal Energy Regulatory Commission license due to expire in 1993.

The fish passage facilities described in the U.S. Fish and Wildlife Service conceptual report previously submitted to your respective offices remains a viable document. To date there has been no monies provided to implement the construction phase.

that we are prepared to meet at your convenience.

Senator Carpenter of Aroostook was granted unanimous consent to address the Senate, On the Record.

Senator CARPENTER: Mr. President, Ladies and Gentlemen of the Senate, with regard to what appears as Item 6-16 (LD 677), "An Act Concerning Veterinarian Examinations."

I just want to put on the Record a little point of clarification. This was my Bill. It appears on the calendar as a "Leave to Withdraw" Report, but in fact, neither myself nor the cosponsors were ever asked if we would take a "Leave to Withdraw" on this issue.

I fully expected the Bill to come out as a unanimous "Ought Not to Pass" because the Committee, in its wisdom, felt that there was another way through more subtle means to convey a message to the particular entity involved. However, I was quite shocked last night, to find this on the calendar for this morning as "Leave to Withdraw". I would just point out for the benefit of all the people, because I find that several people weren't aware that a "Leave to Withdraw" has to be approved by the prime sponsor and all cosponsors, according to our Rules, and it is not something that the Committee can do on its own motion. Thank you, Mr. President.

Senator Clark of Cumberland was granted unanimous consent to address the Senate, On the Record.

Senator CLARK: Thank you, Mr. President, Men and Women of the Senate, frequently in the pace that all of us experience, communication does breakdown; and I would concur that the good Senator from Aroostook was not contacted relative to his acceptance of a suggested, recommendation from the Committee on Business Legislation, as to whether or not, a "Leave to Withdraw" Report on LD 677 would be appropriate.

The Joint Standing Committeee on Business Legislation, in its wisdom, tenders an apology to the good Senator; if, we in fact, have violated any ethic rule, it was unintentional.

I would, also, place on the Record that the Joint Standing Committee on Business Legislation deemed a "Leave to Withdraw" Report less onerous than a unanimous "Ought Not to Pass" Report, in light of the merit that the Committee viewed the content of LD 677. There are some serious considerations that are contained in LD 677. The Committee has recently signed a letter to the Board of Veterinarian Examiners concerning our reservations regarding some of their practices. Those practices were addressed in LD 677. We would hope that we would not make similar errors in the future regarding lack of contact with sponsors.

I might say, that on an earlier "Leave to Withdraw" Section on page 7 of today's calendar, there is, in fact, an item in which I am the cosponsor, and I do not remember being contacted. Perhaps the good Senator from Aroostook has reminded all of us, who Chair Committees, ever so gently, that in fact, we should contact sponsors when "Leave to Withdraw" Reports are before them and before the Legislature. Thank you, Mr. President.
