The PRESIDENT: The Senator has the floor. Senator HAYES: L. D. 1074 is a Bill related to the present law requiring six hours of professional work to be taken for recertification by school teachers. It provides that the teachers be compensated at the tuition costs for these courses, accordingly it updates the 1967 rate of one hundred dollars for six credit hours and raises that level to three hundred and twentyfour for those six hours.

Senator VIOLETTE: Mr. President, Ladies and Gentlemen of the Senate, somewhat more seriously, here. Much to my displeasure over the last several years, and now something that has irked me all the more as I look at this today's Portland Press, and I have looked at some articles here, and over the last several days relating to a particular company doing business in this State, that being the McDo nald's Corporation.

This is a Company that has moved into this State and because of its large size and economy of scale has put a substantial number of smaller Maine locally owned businesses out of business. Has taken advantage of industrial revenue bonds under the guise of industrial expansion and through the use of cheap labor has put, as I mention again, many small business, small eating places out of business. That is not my primary reason for speaking this

My primary reason for speaking this morning, is that this is one very important element of our economy in this State is agriculture and once again this Corporation which doesn't use Maine meat, which doesn't use Maine potatoes, once again isn't going to use another important commodity produced in this State and that is Maine eggs

I think that somehow or someway this Legislature should go on Record telling these companies which come into this State and don't use any Maine products that we don't think that this is in our best interest, and that we are not particularly inclined and overjoyed with these kinds of businesses doing business in this

So, as far as, this Senator is concerned I just rise today to express my objection, on the Record to this Company and other such companies, but it is primarily with respect to this Company, most of the other such companies use various sources, use Maine agricultural products, whether it be potatoes for french fries and the like. I thank you, Mr. President.

Senator Hichens of York was granted unanimous consent to address the Senate, On the

Senator HICHENS: Thank you, Mr. President. I would rise to support the statements made by the good Senator from Aroostook, this morning.

As former Chairman of the Agricultural Committee a few years back, when Commissioner Dollop was the Commissioner of Agriculture, I made a formal complaint because McDonald's chain was using out of state potatoes, he contacted various authorities and said that the State of Maine did not have any authority to make this chain use Maine potatoes.

They used the excuse that Maine potatoes didn't make the kind of french fries that they made, as well as, out of state potatoes, and that was their reason. I know for a time that they did use Maine potatoes, but apparently with out my knowledge they went back to using out of state potatoes, again. I, too, was alarmed this morning when I read in the paper they were going to start using out of state white

I don't know what the purposes is, as far as the nutritional value, I don't think there is any difference between a white egg and a brown

I do echo the remarks of the good Senator from Aroostook that if they are making their profits in the State of Maine that as much as possible that they should be using Maine products

I do not think that they can use the same argument, that a Maine egg doesn't make as good a scrambled egg, or Egg McMuffin as out of state eggs.
