Constitutional Amendment

RESOLUTION, Proposing an Amendment to the Constitution of Maine to Provide Equality of Rights under the Law (S. P. 28) (L. D. 59)

The PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Minkowsky.

Senator MINKOWSKY: Mr. President and Members of the Senate, prior to the Enactment of this Constitutional Amendment and since Senator Clark is not present today, there was a question raised by the Maine Right to Life Committee through constituents of mine relevant to a certain question.

After speaking to our presiding officer this morning in behalf of my constituents and the Maine Right to Life Committee, I want to insert into the Legislative Record the question that was raised.

Now originally we went by the testimony that was presented at the public hearing and the question was raised then but they felt that it was of significant value that this question be officially on the Record.

The area relevant to the Attorney General's ruling of February 10, 1983 stated the following: "In the area where the Maine Equal Rights Amendment could have an impact on eliminating invidious or benign discrimination much will depend on the interpretation of the Equal Rights Amendment by the courts. Without a comprehensive Legislative history that goes beyond the breadth and depth of this memorandum it can't be predicted what interpretation will be adopted by the courts."

The question was raised for the Record this morning is the following: Is it the intent of the sponsors of LD 59 that the Maine State ERA includes a Right to Abortion or Abortion funding? That is the question.

I had addressed this question with Senator Clark who is not here this morning, and she was going to discuss it on the Record, but I had an opportunity, as I said previously, to discuss it with the President of the Senate and he assures me that the answer is No. Thank you very

much Mr. President.
The PRESIDENT: This being a Constitutional Amendment under Section 4, Article 10 of the Maine Constitution it requires for its Final Passage the affirmative vote of two-thirds of those Members present and voting.

Will all those Senators in favor of the Passage of this Resolve, please rise in their places to be counted.

Will all those Senators opposed, please rise and remain standing until counted.

Does the Senator from Somerset wish to be Recorded as voting on this matter?

Senator REDMOND: In the Affirmative.

22 Senators having voted in the affirmative and No Senators having voted in the negative, and 22 being more than the required two-third's of those present and voting the Resolution was Finally Passed and having been signed by the President was by the Secretary presented to the Secretary of State.

Senator PRAY: Mr. President, I present Senate Amendment "A" (S-61) and move its adoption and would like to speak to that.

The PRESIDENT: The Senator from Penobscot, Senator Pray offers Senate Amendment "A" and moves its Adoption.

Senate Amendment "A" (S-61) was Read. The PRESIDENT: The Senator has the floor.

Senator PRAY: Thank you, Mr. President. Mr. President, Ladies and Gentlemen of the Senate, this is a rather simple Amendment and if you have pulled it out of your books to look at it the Statement of Fact, does in fact, state what the Amendment does. It removes criminal language, naming specific organizations, such as the Maine State Employees Association and the Maine Association of Retirees, and in its place it states language that says "Organizations or Associations which represents State Employees or Retired State Employees" and this refers to a section of the law in which individuals submit names to be considered to serve on the Board, on the State Retirement Board. Thank you, Mr. President.

The PRESIDENT: The Chair recognizes the Senator from Knox, Senator Collins.

Senator COLLINS: Mr. President, recalling the discussion around this question that occurred two years ago, when a similar change in this Retirement Board was attempted.

I would like to inquire whether the Chairman of the Committee on Aging, Veterans and Retirement approves of this Amendment, and whether it has had discussion in the Committee? I note the absence in the Chamber of the Chairman of that Committee and the Minority Member of that Committee. This was a matter of considerable discussion in the past and, I think, merits the attention of those Members, and if it has not had it, and had it in the affirmative matter, I would hope that someone would Table this until those Members returned

This language. I recognize the desirability of having generic language, but at the same time this kind of language may result in so many different employee organizations becoming involved, that it becomes unwheedling. It may be a good Amendment; I'm really not sure, but at this point I do raise that word of caution because there has been considerable feeling among retiree groups about a proper balance among retiree groups in being represented on the Board. Thank you, Mr. President.
The PRESIDENT: The Chair recognizes the

Senator from Penobscot, Senator Pray.

Senator PRAY: Mr. President, Ladies and Gentlemen of the Senate, to respond to the first question that the good Senator from Knox, Senator Collins asked.

The Chairman of that Committee has not seen the Amendment, although I did have conversation with him. Due to other Legislative responsibilities he's not here today; thus, it would be my intention eventually to have someone Table this Amendment to give due consideration to those other Members of the Committee and other Legislators who may like to have an opportunity to evaluate this Amendment.

In reference to the naming of specific organizations, and as to whether or not if it would be unwheedling and cause any type of complicated problems, the existing language in the statute today, though it names these specific organizations, it also says that any other organizations, likely organized, to represent

either employees or to represent retirees can also submit a list of names for consideration. By listing these organizations to their specific names and then to continue that other type of language, I think, it's just a little bit repetitious, and this Amendment was an attempt to clear up some of that language and to give no one particular organization a special recognition over other organizations.
