Augusta, Maine April 27, 1983

Senate called to order by the President.

Prayer by the Reverend Julian Hall of Old South Congregational Church of Hallowell.

REVEREND HALL: Couldn't help but think as I looked out this morning, this looks like a rather representative crowd after Easter, or on any Sunday morning.

One of the great church leaders of this century was Harry Emerson Fosdick in the cause for justice and human rights. He wrote a book, obviously many years ago, and it came out of his own experiences of deep depression and then subsequently, as you may remember, he served for many years at the Riverside Church in New York. I offer this morning a prayer from this particular book, written by a person of the last century.

Let us pray! "O God, Who art, and wast and art to come. Before Whose face the generations rise and passed away, age after age, the living seek Thee and find that of Thy faithfulness, there is no end.

The PRESIDENT: The Chair recognizes the

Senator from Aroostook, Senator Carpenter. Senator CARPENTER: Mr. President, with respect to L.D. 904, I move that this Bill and all its accompanying papers be Indefinitely Postponed.

The PRESIDENT: The Senator from Aroostook, Senator Carpenter moves that L.D. 904, Bill, "An Act to Create Boothbay Region Waterfowl Sanctuary" be Indefinitely Postponed.

The Chair recognizes the Senator from Lincoln, Senator Sewall.

Senator SEWALL: Mr. President and Members of the Senate, I regret that the leadership of the opposition party has taken on this Bill which is a great magnitude to most of the State, but of very great importance to a small area in my region in Boothbay Harbor.

I discussed this rather thoroughly yesterday. No land is being taken in this: it is merely a water area, It is, I believe, what true sportsmen would do, we're trying to save a migratory area for ducks, it is a commercial, and certainly, it is the busiest boating area, probably in the State, in the harbor of Boothbay Harbor-not the place where hunters are too often.

The person I sponsored it for, is, probably one of the greatest duck hunters, sportsman, someone who has traveled all over the country, trying to preserve species of ducks. This is merely a migratory area. I ask for a Division on this and I hope that those of you who were with me yesterday will stay with me today. Thank you.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Usher.

Senator USHER: Mr. President and Members of the Senate, another point of information. I double checked with the Department yesterday, and the first time that the Department knew about any part of the problem down there was at the hearing.

The normal procedure is to go to the Department when you do have a problem in the area, and it did stem from vandalism in the area, that was testimony that was given at the hearing. There was only one person, which was Mr. Kelly, plus the sponsor that spoke for it, and at least eight or nine opponents to the Bill.

It was an issue that should have been brought to the Department first, and the first time was at the hearing.

The PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Carpenter.

Senator CARPENTER: Mr. President, Ladies and Gentlemen of the Senate, I think the Senator from Cumberland, Senator Usher has just delineated why, the major reason why, I moved this Bill's Indefinite Postponement this morning.

The Department has a process whereby people can at least make application to it for areas, such as this, to be set aside. As the good Senator from Cumberland, Senator Usher just pointed out, the Department never even heard about this. There was not any great outpouring of support from the area; there was one person who is intimately involved with this, plus the sponsors of the Bill, who came to the public hearing and testified. As the good Senator from Cumberland, Senator Usher has already pointed out various sportsmen's groups and the Department of Inland Fisheries and Wildlife were caught off guard and it did appear as opponents. It just didn't seem to me to be a need or a great outcry of support, even from the affected area. As the Senator already has said, there were some problems down in that area with vandalism or what not and the whole idea seems to have stemmed from this.

The PRESIDENT: The Chair recognizes the Senator from Lincoln, Senator Sewall.

Senator SEWALL: Thank you, Mr. President and Members of the Senate, I would only suggest that there is a process, that the person the Honorable Ransom Kelly for whom we put this Bill in, knows the process. He was on the Committee to which this was referred, for three terms in this Legislature. He understands it; he did have problems; he had discussed it and if they hadn't heard of it, it was surprising that they came in such opposition.

The only real—The Department didn't want to do this it seems, but they were very very happy to accept eight hundred acres of land which this gentleman gave to the State for a management preserve. They were happy to accept the lands, they were glad to take it and make it into a management area. This man is not ignorant of how this system works and people in the area decided that it is a necessary thing.

I don't understand what the great opposition is and not all the sportsmen's groups are against this. Let me explain to you, those of you who don't hunt, perhaps don't belong to sportsmen's groups as I do. I suppose that some of you know that I've raised black labs and showed them at field trials. I'm not exactly a "white sneaker" myself. For instance, Ducks Unlimited, a National Organization and this is exactly what they do, they make these sanctuaries all over the country and in Canada. They raise money by having dinners and auctions to make these sanctuaries so that we can have certain species of ducks preserved.

In Maine you can't shoot black ducks. Why? Because there aren't any. There are very few and they are trying to preserve them. This is the sort of thing done with private money and done in an area like this, where we're taking no land at all in a busy area where it's practically, people wouldn't be hunting there anyway. I don't understand it! Down in Cumberland County area we have the Roger Snowe Wildlife Sanctuary. Does it make a difference that he's a Democrat?

The PRESIDENT: Is the Senate ready for the question?

A Division has been requested.

Will all those Senators in favor of the Indefinite Postponement of this Bill, please rise in their places to be counted.

Will all those Senators opposed, please rise in their places to be counted.

17 Senators having voted in the affirmative, and 14 Senators having voted in the negative, the motion to Indefinitely Postpone LD 904 in non-concurrence, Prevailed.
