Senator KANY: Thank you, Mr. President. I move Acceptance of the Majority Ought Not to Pass Report

The PRESIDENT: The Senator from Kennebec, Senator Kany, moves that the Senate Accept the Majority Ought Not to Pass Report of the Committee.

The Chair recognizes the Senator from Aroostook, Senator McBreairty.

Senator McBREAIRTY: Mr. President and Honorable Members of the Senate, I would hope that you did not Accept the Majority Ought Not to Pass Report.

When the Land Use Regulation Commission was created, back in, I think 1969, plantations, unorganized townships, and plantations were put under the jurisdiction of LURC. LURC's duties were to extend principal sound planning, zoning and subdivision controls to the unorganized and deorganized townships of the State.

Recently, several towns have organized, and plantations, many plantations have adopted land use standards, land use plans and ordinances. This Bill would once they adopt sound land use standards would allow them out from under the jurisdiction of LURC and it would be treating them as other towns are treated. In fact, in many towns that are not under LURC do not have good land use plans. I think this town, the Capitol, is one of them.

I don't have any intent of allowing towns out unless they do adopt a plan that's satisfactory to LURC, once they do, I think they should be able to do so.

I hope you would not Adopt this, and I ask for a Roll Call.

The PRESIDENT: A Roll Call has been requested.

Under the Constitution, in order for the Chair to order a Roll Call, it requires the affirmative vote of at least one-fifth of those Senators present and voting.

Will all those Senators in favor of ordering a Roll Call, please rise and remain standing until counted.

Obviously, more than one-fifth having arisen, a Roll Call is ordered.

The PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Pearson.

Senator PEARSON: Mr. President and Men and women of the Senate, The argument on the other side of this Bill is very short, and I think, very clear.

What this Bill intends to do is, or what the position of the Ought Not to Pass, Majority position has is, that people who get out, towns who get out of the jurisdiction of the Land Use Regulation Commission would have to wait four years

This Bill would change that and what we intend to do is to prevent towns or unorganized territory from getting out of LURC just for the purpose of changing their zoning so that it would be less than desirable from the State's point of view.

There are always communities, we have had an experience over the last ten or fifteen years of towns, plantations, that have organized in order to get out of the Forestry District. We have fear that a number of areas in the State may simply adopt sufficient regulations to organize, get out of LURC and then revert to a chaotic situation in which there is virtually no zoning.

Now the good Senator from Aroostook, Senator McBreairty, has suggested to you that there are towns in this State that have no zoning. I suspect that that is true. He cited as an example the city of Augusta. I think that if you were to ask those people who have lived in Augusta all their lives, if they had a chance to do it over again, they probably would have had more adequate zoning and wish that they had in the past.

We are trying to keep an orderly process going so that towns won't, plantations won't simply organize in order to allow anything to happen-the wildest dreams one might think of.

The PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator McBreairty.

Senator McBREAIRTY: Mr. President and Honorable Members of the Senate, there are a couple of things wrong with the way that this is being handled presently. The Land Use Regulation Commission statute when it was passed said, "the Commissioner of Conservation shall prepare a biannual budget and shall submit it to the Legislature a request for appropriations sufficient to carry out its assigned task.'

Now this was done for ten years, several years ago when the cost component was passed they switched their budget to the property tax in the unorganized territory and continued to service the plantations and the towns that organized after 1971.

So there are real problems, I think, constitutionally with the funding of these services that is being provided these people. That is one problem

The other problem is that the town organizes, their organized, they're people, they belong to the State of Maine, they are just as capable of looking after themselves as any other town. Under the law the way it is now, LURC can hold a public hearing in Bangor and rezone all of Allagash and the people can hold town meetings and they can scream, they can claw, they can do anything that they want and they have to accept those regulations.

Now, if you want that for your town let's amend it and put these regulations on any town, all towns that do not have any zoning. I'll buy that if you want mine under it, let's put yours under it. It would be the same thing. Thank you.

The PRESIDENT: The pending question before the Senate is the motion by the Senator from Kennebec, Senator Kany that the Senate Accept the Majority Ought Not to Pass Report of the Committee.
