Senator Diamond of Cumberland was granted unanimous consent to address the Senate. On the Record.

Senator DIAMOND: Thank you, Mr. President. Men and Women of the Senate, a few weeks back the Transportation Committee and the Taxation Committee, and the entire Legislature for that matter, passed a Law L. D. 1378 the Highway Allocation Act, and the major thing of that Bill provided a five cent tax increase as we all know, also, in that Bill, which some of us may not have known, was a provision allowing double-bottom tractor-trailers to operate on our interstate and our turnpike. That was the agreement with the Federal Government when we put this Bill together.

A few days after we passed that law, a few days into April, Secretary of Transportation, Elizabeth H. Dole, issued a mandate adding to the list of interstate highway and turnpike several other roads including: U.S. Route 202 from the New Hampshire line to the Gray turnpike exit; U.S. Route #1 from Yarmouth to Freeport; U.S. Route #1 from Brunswick to Fort Kent; U.S. Route #1-A from Stockton Springs to Ellsworth; and U.S. Route 302 Fryeburg to Portland.

The Governor of the State of Maine, Governor Brennan, voiced his objections very articulately and very well, as did the Commissioner of Transportation, they both expressed their shock and dismay at this kind of added beyond agreement kind of a mandate. This entire Legislature issued a Resolution to the Congress asking that they reverse the decision made by the Secretary of Transportation. Every major newspaper in this State wrote editorials against it. The Republican Leadership in the House wrote a very fine letter to the Secretary of Transportation, Elizabeth Dole, asking that she reconsider this action.

As a result of all those complaints and protests, she has redesignated four of those highways: 202 from New Hampshire to Gray; Yarmouth to Freeport; U.S. Route #1 Brunswick to Fort Kent, shortened that to Houlton to Fort Kent; and also, Stockton Springs to Ellsworth. She left, however, Route 302 probably the most vulnerable highway that she had issued to be allowing double-bottom trailertrucks. Understand that these double-bottom trailer-trucks are twenty-eight and a-half feet for each trailer, plus the linking space, plus the space between the first trailer and the tractor and then the length of the tractor. So, Dan Webster, of the DOT tells me that that is about seventy-five feet long.

Tomorrow morning, I and several concerned people will be walking from Bridgton to Portland, or as long as daylight will allow, to demonstrate to the people who live on that highway, and use that highway that this is very very unsafe. We feel that as soon as people understand this, what has happened, they too will be very, very concerned.

Of that highway, 302, fifty-four point one/six miles from Fryeburg to Portland over six miles have pavement width of less than twenty-four feet, couple that with, if you will, seventy percent of that highway having gravel shoulders and you can see the dilemma when you have to pass a seventy-five foot tractor-trailer.

There are ten high incidents accident locations on 302, already. There are major built up areas in Bridgton where the good Senator Don Twitchell represents, in Naples and in North Windham understand that these doublebottom trucks are allow right now to travel on

this highway.

The Federal Highway Administration, itself, with its Director William Richardson, who met with our Committee, yesterday, on Transportation I might add, agreed with us that yes that is a dangerous highway for double-bottoms. He, also, informed us yesterday that all of those routes that I have mentioned that have been redesignated may be designated again at any moment, at any time by the Secretary of Transportation. So I would alert you, those of you that represent people in towns on those routes to be aware.

Several people have indicated their support, Senator Twitchell will be there tomorrow, and myself, Representative Don Carroll, Representative Gary Cooper, Representative Phil Jackson, and many others, we would like to invite any and/or all of you folks in this honorable Body if you would like to join us if you are concerned about these types of vehicles being on those roads. I thank you for your time. Thank you very much.
