The PRESIDENT: The Senator from Kennebec, Senator Dow moves that the Senate Reconsider its action whereby the Senate Accepted the Minority Ought Not to Pass Report.

The Chair recognizes the Senator from Androscoggin, Senator Charette.

Senator CHARETTE: Thank you, Mr. President, just some sixteen and a half hours ago we debated this issue quite at length, and I don't intend to repeat myself; however, I do have new information this morning and some of our esteemed Senators after last nights session, went out and tried their skills on video games and boy we do have some winners in this Body, and I know of one ace, especially.

Just a point of clarification in what I'm saying is that, even those operators that operate VDT's all day long enjoy, also, the same video games on their T. V. at home. So if this is so treacherous, as everybody seems to think it is, for eye impairment or vision, or whatever, I don't know why then we've got to allow that to continue in the homes. So where are we going next?

I would hope that the Bureau of Labor can, by its own self do its own survey and promulgate their own rules. So I would hope that the Senate Body this morning vote against the pending motion, and I would ask that the vote be taken by Yeas and Nays.

The PRESIDENT: A Roll Call has been requested. Under the Constitution, in order for the Chair to order a Roll Call it requires the affirmative vote of at least one-fifth of those Senators present and voting.

Will all those Senators in favor of ordering a Roll Call, please rise and remain standing until counted.

Obviously more than one-fifth having arisen a Roll Call is ordered.

The Chair recognizes the Senator from York, Senator Dutremble.

Senator DUTREMBLE: Mr. President and Members of the Senate, I think the good Senator from Androscoggin has hit it right on the nail. He said that the Department of Labor should collect data and promulgate the rules. That's exactly what this Bill does, exactly what this Bill does and that's what we want to do. We want the Department of Labor to collect data and statistics and promulgate any rules, if necessary if they're not necessary the Department of Labor doesn't have to do anything.

If there is concern this morning by different Members of the Senate and if there is concern by all the lobbyists out in the hallways this morning that this will affect business in the future, it is all for naught, because if there is no problem, they have nothing to worry about.

I think that just knowing that the Department of Labor wants this Bill and the Bureau of Personnel wants this Bill, suggests something to me. The fact that we did receive a letter from the Department of Human Services saying that there was a problem with some people, suggests something to me. I would hope that it would suggest something to you and that you would go along with the Reconsideration motion this morning. Thank you.

Senator HAYES: Members of the Maine State Senate, I want to explain to you why this Bill has been held and unassigned. The reason is that we have been awaiting an Attorney General's opinion on whether or not the additional student seat on the Board of Trustees would require a simple majority, or a two-thirds. We have now received an opinion from the Attorney General's Office that requires simple majority and this is the reason for the holding Bill.

The PRESIDENT: The Chair would state on the Enactment of this Bill that under Section 8, Part 1 of Article 5 of the Constitution, a twothirds vote of those present and voting is necessary.

The Chair recognizes the Senator from Penobscot, Senator Hayes.
