Senator HICHENS: Mr. President and Members of the Senate, you'll notice that under this communication that four members of the Committee voted against the nomination of

Mr. Kenneally and then under the next section, three members voted against the nomination of that gentleman. It should have been four; there was a lack of communication and I intended to have been with those four but it is on the Record that I voted for, I will be voting against the nomination when it comes up before us.

You will notice that this is a bipartisan vote with the four of us, two Democrats, two Republicans, and it is not that we are against Mr. Kenneally or Mr. Anderson, but the Governor had been implored, about being requested, to have a more equal distribution of members of the Commission throughout the State. Both of these gentlemen have served for two terms and many of these people felt, and the four members who voted against the nominations felt that there should be equal representation and we felt that the only way the Governor could be forced to make such an appointment would be to vote against these two nominees, and then repost one of the names and find someone else from another section of the State. We don't know whether this would actually work or not. I don't know that our intentions are going to have any influence on the Senate, but I feel that you should know that we have nothing against any of these nominees but the fact that we think there should be equal distribution of the Commission members throughout the State. Thank you.

The PRESIDENT: The Chair recognizes the Senator from York, Senator Wood.

Senator WOOD: Mr. President and Members of the Senate, I would rise to support the nominee here as well as the other two nominees. The Committee heard the testimony yesterday on these nominees there was no opposition: there was one gentleman that spoke neither for nor against any of the nominees, just pointing out the point the good Senator from York made about distribution.

Dr. Kenneally has served on the Harness Racing Commission for the past six years. He has seen that Commission grow from a fourteen million dollar industry to a twenty-three million dollar industry. The people that I talked to have found him fair, have found him hard working and conscientious and worthy of our support today.

I would point out that I think it is totally inappropriate to use the confirmation process as a bargaining tool to get the Governor to put other peoples' names up. We pass the Legislation that sets up the Maine Harness Racing Commission. We pass the Legislation that sets up all of these Commissions. If we had seen fit at the time to include areas, geographic areas, we should have put it in, but we did not. We left it up to the Governor. He made those choices. This past year we put in the Committee on Agriculture had the bill in that required confirmation of the Harness Racing. At no time did we discuss geographic distribution.

I would point out a number of Commissions, the PUC, whatever. Is there any requirement in those statutes that there be geographic distribution? I think we do a disservice to nominees when we suggest that because they come from Saco, or they come from Scarborough, that they will not have the best interest of the State at heart. I think that when we are elected we do not represent just one part or one section of our district. We represent the whole section.

I am convinced that looking at the nominees and their credentials that it really matters little where they come from but they are qualified and they will do the job, and I think it would be appropriate for the Senate to confirm all of these three nominees today.

The PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Erwin.

Senator ERWIN: Mr. President, Ladies and Gentlemen of the Senate, at our three hearings yesterday, we had absolutely zero opposition to any of the three nominations. Under neither for nor against on the third nomination there was one individual from Lewiston who objected to two members of the Commission being from the same general area but even he

had the highest praise.

In checking around trying to get a little background on the Racing Commission, one of the persons I checked with was Representative Ed Keller, who I think most of you know is a judge and is quite active working with these gentlemen. In talking with him yesterday afternoon and again this afternoon, he had, also, nothing but the highest praise for all three of these gentlemen that they didn't necessarily agree with the case that he had presented, but he said almost every time it was because I didn't present, meaning Representative Keller, a strong enough case. He claims that as far as he is concerned, all three are capable, dedicated and outstanding gentlemen.

I urge your support. Thank you.

I'm not sure that they in fact do have those preferential dates,
