Senator Pearson of Penobscot addressed the Senate relative to (SLS 328).

Senator PEARSON: Mr. President, with respect to (SLS 328) the Town of Benedicta on their 150th anniversary since it's founding, I would like to say a few words about it, I don't normally do this.

Benedicta is a special little place in Southern Aroostook County. It is a town really very rich in history. A hundred and fifty years ago, Bishop Fenwick of the Diocese of Portland, I would assume, or of Boston, bought half a township in Southern Aroostook County which eventually became known and was incorporated under the title of Benedicta because they were Benedictine priests. The original intention for Benedicta was to have Holy Cross University founded there. They changed their minds however, and it was established somewhere else, but in the mean-

time, a group of Irish families moved into Benedicta and their ancestors have been there ever since. The town is composed mostly today of Rushs, Qualeys, McAvoys, Duffys, Cummings and some Gantniers and that is just about the whole town.

It is really a very unique and very beautiful little town and this summer I would like to invite everyone of you to their anniversary celebration which is around July 2 and 3rd and 4th. This summer the Pope will be visiting North America. He will be in Moncton, New Brunswick, and Montreal, Quebec and it is the hope of the people of Benedicta that he will stop in Benedicta on the way as he goes from Moncton to Montreal. We have extended an invitation to His Holyness to do that and it is our hope that he will but even if he doesn't, we would like to have you come.
