THE PRESIDENT PRO-TEM: The Chair recognizes the Senator from Kennebec, Senator KANY

SENATOR KANY: Thank you Mr. President and Members of the Senate. I intend to vote in favor of this confirmation, but I just wanted to publicly state that I would hope the new Commissioner would be willing to address a couple of very, very important issues, to the State of Maine, and one is the issue of hazardous bridges, which in my opinion, exists and has not been looked into thoroughly yet.

The second problem, which I believe must be addressed, is the future of our railroad system.

THE PRESIDENT PRO-TEM: The Chair recognizes the Senator from Aroostook, Senator McBREAIRTY.

SENATOR McBREAIRTY: Mr. President and Honorable Members of the Senate. Dana Connors, as many of you all know, has presently been acting as City Manager of Presque Isle. He come from my Senate District and I think he is an excellent choice for our Commissioner of Transportation, and I commend the Governor highly for this appointment.

THE PRESIDENT PRO-TEM: Is the Senate ready for the question?
