# On Motion of Senator BUSTIN of Kennebec, (Cosponsors: Representative NADEAU of Lewiston, Representative BOST of Orono, and Senator CONLEY of Cumberland) the following Joint Resolution: (S. P. 772) JOINT RESOLUTION CALLING FOR AN

INVESTIGATION OF HEATING OIL PRICES

WHEREAS, a great many homes and businesses in Maine are heated with oil; and

WHEREAS, the price of heating oil in Maine has jumped from \$1.05 a gallon to \$1.24 a gallon since December; and

WHEREAS, suppliers' inventories of heating oil in New England are down by 38% over the same period, which may have contributed to this price jump; and

WHEREAS, the weather in Maine, since September, has been a little warmer than an aver-

age year; and WHEREAS, there have been no reports of international disruptions in the supply of petroleum: and

WHEREAS, these conditions have created a hardship for the people of Maine who depend on oil, with no apparent economic justification; and

WHEREAS, the Revised Statutes, Title 10, section 1105, prohibits unreasonable profits in the sale of necessities, including fuel of all kinds; now, therefore, be it

**RESOLVED:** That We, the Members of the 111th Legislature, assembled in the Second Regular Session, do hereby respectfully request that the Office of Energy Resources investigate the causes of the sudden rise in price, to determine whether it is justified or not; and be it further

**RESOLVED:** That the Office of Energy Resources investigate the inventory practices of the heating oil suppliers and work to ensure that adequate inventories will be available for use within this State; and be it further

**RESOLVED:** That the Office of Energy Resources refer to the Attorney General any evidence of price fixing or other potentially illegal anticompetitive activities; and be it further

**RESOLVED:** That the Office of Energy Resources report to the Legislature, on or before April 1, 1984, on the findings of their investigation, together with any recommendations they may have

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Kany

SENATOR KANY: Mr. President and Members of the Senate, I see no harm in this Resolution and I intend to vote for its passage. I do believe it would be more appropriate to memorialize **Congress and petition the Federal Government** to address this very serious problem.

I wanted to let you know that the Office of Energy Resources has been doing its job and is on top of this issue and has kept both the Public Utilities Committee and the Energy and Natural Resources Committee very well informed. In addition, John Kerry did write to all Legislators and we all received a memo from him on this topic of heating oil price increases, which was dated February 2nd. In addition, John Kerry has petitioned Chairman Miller of the Federal Trade Commission, Secretary Hodel of Energy and, also, the Attorney General of the United States, Mr. William French Smith, to investigate the reasons for the price increases. I believe that's appropriate and I do believe that an inquiry should be made to see if there is actual adjustment of the inventories nationally for the purpose of price fixing.

I wanted to share with you, once again, some of the information from John Kerry, Director of the Office of Energy Resources and I will repeat for you precisely what he said: The Office is entirely up on inventories in the State of Maine, by the way, and Mr. Kerry said: "As you know, heating oil prices have risen rapidly during the past few weeks. The principal reasons for this increase are the severely cold weather which affected the entire country and a significant drawdown of refinery inventories. During the summer and fall the major oil companies purposely accumulated less storage of heating oil than normal. As a result, inventories were not plentiful so the increased demand could not be met with ease. Another factor exacerbating the situation was the cold weather on the Gulf Coast which disrupted refinery operations. The price increases originate with the major oil companies and not with local Maine dealers. In fact, wholesale prices have risen faster than retail prices, which is an indication that some dealers in the State are not passing through all the higher prices." and, once again, I'm reading from the memo to all members of the Legisla-ture, dated February 2, 1984. "As long as the weather remains cold, the price increases will probably continue. Although product stock

levels are lower than normal, I do not expect supply problems. Crude oil stocks are adequate, and refinery operations have been increased to produce more heating oil.'

I won't go through the entire thing but there's just two portions of it which are important to all of us. "As of February 1, the average retail price for heating oil sold in the State was \$1.236 a gallon, an increase of 17% or 17.8 cents since December 1. Wholesale, futures and spot prices have increased as well. For example, the New York Harbor spot price for heating oil has risen 22% or 17 cents per gallon since the beginning of December. Last year, the average retail price as of February 1 was \$1.143 cents per gallon. However, last year we saw prices fall rapidly during the winter.

For the week ending January 20, 1984, **Energy Information Administration statistics** show that primary inventories of heating oil have dropped to 124.4 million barrels, a decrease of 23% or 37.6 million barrels since the beginning of December, an unusually large drawdown. Distillate stocks are 29% or 50.5 million barrels below January 1983 levels. Primary storage in New England has decreased 27% and is 31% less than last year. As of January 2, 1984, primary storage in Maine was 1.166 million barrels and has grown 3% since the beginning of December. However, Maine inventories are 19% or 275,500 barrels below last year's levels.

I won't go into any more detail, I just wanted to assure you that our Office of Energy Resources is doing its job and I would like to commend the Director, John Kerry, for doing an outstanding job and for petitioning the Federal Government to do its job to investigate this serious situation.

# (Off Record Remarks)

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Bustin.

SENATOR BUSTIN: Thank you, Mr. President. Men and Women of the Senate. I rise to defend the Resolution, I did not put it in without doing some checking on this, in fact, I did check with Mr. Kerry and he said "that would be very nice, Beverly, because I would like to have that kind of support from the Legislature for what I am doing and what I would like to do further."

Part of the Resolution, you will notice, calls for a report to the Legislature and even though we'd already had that put on, there are some other reasons I'd like to have Mr. Kerry delve into this further.

Some history that you should know from me and I hesitate to say this because one of the good Senators in this Body said "Everytime you get up to speak, Beverly, I always have to listen to your family problems." But in any case, I want to let you know that some years ago, I did work as the executive secretary of the Maine Oil and Heating Equipment Dealers Association, so I am not unaware of what's in the Resolution or what I'm asking for, I am painfully aware of what has happened and this has happened historically. It's because of the high price of heating oil, in general, that I submit this Resolution and because we can't afford those jumps in fuel oil prices in the heavy heating season. I would rather see a more flat demand curve, if you will, in fuel oil. Even though I can't call the economic curve on any kind of a product, it seems to me that we need to do something to answer the high price that people have to pay for their fuel oil in the cold weather and it is historical. Any time you have a cold snap you're going to have a rise in fuel prices. Now are you really telling me that that means we don't have that storage there? I don't believe it.

I spoke to two people who buy oil and resell it last night. One of whom told me that he had, the supplies were low from his supplier and that he was restricted to 3,000 gallons even though he could have delivered something like 12,000. I'm not sure that I totally believe all of that because then I heard from another dealer who his supplier, he said his supplier had plenty of oil, he never had a problem with supply.

So it is because of that that I would like to have it investigated further and one of the things that perhaps should have been done here was to do as the Governor in New Jersey has done and that is to let other states know how we are fairing and what's going on. I'm glad that they are getting together as a Northeastern Delegation and trying to do something about it and I think that only points out the problem and I would hope that you could support this Resolution. Thank you.
