I am pleased to transmit herewith the Motor Carrier Compact Report, prepared by the Maine Department of Transportation in accordance with Public Law 1983, Chapter 480, Section 21. The report outlines the considerable progress to date in the formation of Motor Carrier Tax Compacts, and it discusses Maine's intention to join the Regional Fuel Tax Agreement with the States of New Hampshire. Vermont, and Connecticut. Legislation is being drafted to permit Maine's joining this compact.

The appendices to the report contain the text of the Regional Fuel Tax Agreement, and the changes in the Maine law that are necessary to fully implement the agreement, and also to equalize the treatment between vehicles subject to the agreement and those vehicles that are not.
