Dear Members of the Legislature: Enclosed is a copy of the most recent report of Maine's Low-Level Radioactive Waste Siting Commission. The Commission previously reported to the Governor and the Legislature in June of 1982 and updated that report in December of 1982.

The findings and recommendations of the Commission are presented to you under the requirement of law for periodic report, (38 MRSA, Chapter 14-A, Subsection III) and because the Commission believes major policy decisions are most appropriately made by the Legislature. We hope you will approve of our findings and recommendations.

The Commission was formed by Maine Statute to recommend public policy for Maine under the federal mandate of the Low-Level Radioactive Waste Policy Act of 1980.

We had hoped to offer you both specific and final recommendations now, but national policy is in a state of flux. The Nuclear Regulatory Commission is investigating alternatives to shallow land burial facilities for low-level nuclear waste and the N.R.C. is in the process of developing amendments to its regulations which may be more appropriate for above ground engineered facilities. And those most involved in the low-level nuclear waste issue in Massachusetts and New York are considering recommending amending the existing Northeast Compact to make it more palatable to both to the large states and small volume states such as Maine.

Consequently, the Commission believes it is premature to make a final specific single recommendation which could exclude us from eligibility from a solution most desirable to most Maine citizens.

Please contact me or the other members of the Commission if you have any questions or if we can be of assistance to you or your constituents. More copies of either the entire report or only the recommendations which are contained on yellow pages are available.

THE PRESIDENT: The Joint Standing Committee on STATE GOVERNMENT has recommended that the nomination of Kathaleen A. Boland be confirmed.

The pending question before the Senate is: Shall the recommendation of the Committee on STATE GOVERNMENT be overridden: In accordance with 3 M.R.S.A., Chapter 6, section 151 and with Joint Rule 38 of the 111th Legislature, the vote will be taken by the yeas and nays. A vote of Yes will be in favor of overriding

the recommendation of the Committee. A vote of No will be in favor of sustaining the recommendation of the Committee.

Is the Senate ready for the question? The Doorkeepers will secure the Chamber. The Secretary will call the Roll.

On motion by Senator PRAY of Penobscot **RECESSED** until the sound of the Bell.

#### RECESS AFTER RECESS

The Senate called to order by the President.

Out of order and under suspension of the rules, the Senate voted to consider the following:

#### SECOND READER

The Committee on BILLS IN THE SECOND **READING reported the following:** 

Bill "An Act to Increase Legislative Oversight of the Fiscal Affairs of the Department of Inland Fisheries and Wildlife" (Emergency). H. P. 1628 L. D. 2143

Which was READ A SECOND TIME.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Üsher.

SENATOR USHER: Mr. President, I offer Senate Amendment "A" (S-296).

THE PRESIDENT: The Senator from Cumberland, Senator Usher presents Senate Amendment "A" and moves its Adoption

Senate Amendment "A" (S-296) was READ.

THE PRESIDENT: The Senator has the floor. SENATOR USHER: Thank you, Mr. President. Mr. President and Members of the Senate, the purpose of this Amendment is to try to save jobs, it is aimed at saving jobs, and I look for

your support. There are ten (10) people who start their layoff today: there will be six (6) biologists, and four (4) hatchery people who play a vital part in the Fish and Game Department. The Department is charged with protecting a resource and these people play a very important part in protecting the resource.

A few weeks ago there was a memo sent out by the Executive Branch to layoff twenty-five (25) people and make additional cuts in the Department.

The Committee has looked at this almost everyday this week. We have in the past two (2) weeks looked over and gone over and agreed with some of the cuts, as a matter of fact all the money raising cuts we agreed with. The people involved on the layoff some of those positions took care of themselves. People did move, people got jobs in different locations and we are down to ten (10) people which the Committee agreed on saving to protect the resources.

We are keeping the hatcheries open, the rearing station very important, the proposal was to close the Strong and Machias offices we have retained these two (2) offices to remain open for a year. The Warden Pilots will be demoted down to a warden, it is a demotion because of a cut in pay. We will lose the five (5) clerk typists, and a store-house position, plus the mileage will be cut by ten (10%) percent.

What we are asking for today is to retain these ten (10) people who play a very important part in the whole operation.

There were so many meetings on it that I can't keep you up-to-date on all of the meetings that we had, meetings with the Governor, and we are deeply concerned with what is going on. We feel that this is the only avenue that we have left and this is typical of the Legislature acting on the twelfth hour, I won't say the eleventh hour this is it.

I hope that we can get a unanimous support from this Chamber this afternoon and send it to the other Chamber and look for their support, also. I ask for your support this afternoon.

Senate Amendment "A" (S-296) was ADOPT-ED.

On motion by Senator MINKOWSKY of Androscoggin the Senate RECONSIDERED it action whereby it ADOPTED Senate Amendment "A" (S-296).

THE PRESIDENT: The Senator has the floor. SENATOR MINKOWSKY: Thank you, Mr. President, Members of the Senate, chairing a similar committee to the chairman of the Inland Fisheries and Wildlife, myself being on the Marine Resources Committee, I can understand fully the trials and tribulations that these people are going through, especially the biologists, and the people in game management.

What I am asking this afternoon, number one, does the people involved in this decision, on this amendment, have reasonable assurance that the Governor will sign the Bill? For if not we are just wasting our time.

Secondly, last week when I spoke on this issue all I was focusing on at the time was a report that was presented to us by an adhoc committee that the Commissioner had appointed. In discussion in the halls for the past few days it surfaced that within two or three weeks they will have resolved this particular situation. I have not received an answer to this and this is just sheer speculation.

My other concern we were talking of twentyfive (25) employees, today we are talking about ten (10) that means that there is fifteen (15) people either being transferred somewhere's else, or through attrition, or through retirement, or something has been materializing. My concern is for those people, also. What happens to them? Are they going to matriculate back to the Department by July? Or are they fully terminated with the Department? And have accepted positions in some other department in State government? These are some key questions, I think, should be answered so everybody could be on the same level of understanding of what is going on.

For if we don't my final question is this: if the Audit and Program Review Committee and the Committee on Inland Fisheries and Wildlife find so much incompetence in the Department and the administration of that particular Department then it is incumbent upon them this afternoon to tell us on the floor of this Senate that, that Department is not functioning properly, that those people in administration should be replaced. I hope number one that you people will address that.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Najarian.

SENATOR NAJARIAN: Mr. President and Members of the Senate, I feel really obligated to say something for the five (5) clerk typists that are losing their jobs. I said that if anybody, you know that if there was a need for replacing any of these people it ought to be the five (5) clerk typists. There are five (5) regional offices there is only one (1) clerk typist in each regional office and now there will be nobody to answer the telephone, nobody to write up the wardens reports and the wardens are going to have to do that themselves. I think that that is a very efficient move, but you know, generally on one is concerned about the females that lose their jobs.

From all my phone calls I guess I was pretty

much convinced that the hatcheries ought to stay open and those employees that are concerned with the hatcheries, but the Commissioner said that the biologist were doing (at thirty thousand cost to the General Fund) were doing work that college work studies students could do and I haven't heard any information to the contrary on that, and yet those positions are being restored.

Further of all of you who heard that speech at the Chamber of Commerce the other night this is absolutely Legislative meddling in the Executive Branch.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Pearson.

SENATOR PEARSON: Mr. President and Men and Women of the Senate, a biologist in this State that works for the Fisheries and Wildlife Department has a degree, at least, a Bachelors Degree and many of them Masters Degrees, as a matter of fact in my Senate District I have one that has his Doctorate. They deal with the lakes and ponds and streams of this State and the animals of this State in their area, they have become experts in their area. They know in my area Pushaw Lake, Cold Stream Pond, Eskutassis, and all the other lakes and ponds that are in my area, they have spent years learning about the uniqueness about that lake, those ponds, those streams and those rivers, and the forage that is available for the animals that inhabit the area, they know where the deer yards are they know all of the things that are technical that need to be known by a biologist.

For the love of me I can not understand how anybody can say that a work study student could do that job just as well. Number one a work study student can only work so many hours in any given year and earn so much money. So you would have one working for awhile and then you'd have to replace them. They would probably be in their freshman, sophomore, junior year of college. They would be constantly rotated in and out of that area. It is just not practical and it is beyond me why the Commissioner would say that he could replace that level of experience and intelligence with a work study student.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator McBrearity.

SENATOR McBREAIRTY: Mr. President and Honorable Members of the Senate, yesterday we had Doctor Colter come before the Audit Committee, he is I think a former head of the Fisheries and Wildlife Department at the University of Maine and probably one of the greatest authorities on fisheries and wildlife issues in the Country. He left us a little bit of information, and I am going to use that information now. The heading of it is: "The Value of Fish and Wildlife to the Maine Economy." It says: "people engage in hunting and fishing and other wildlife related activities in 1980", now that is in 1980 it is more now, "spent at least \$120,000,-000. in Maine.

An idea of the importance of the fish and wildlife resource to Maine's economy can be gained from studying the values of several other well known Maine products." He listed, "potatoes bring \$95,000,000; Blueberries \$19,-000,000; Dairy \$106,000.000; Poultry and Eggs \$118,000,000; Apples \$16,000,000.". It goes on to say: "Commercial Fisheries, Lobsters \$51,-000,000; Claims \$7,000,000.; Herring \$3,000,-000; Scallops \$7,000,000.; Flounder \$7,000,000.; Haddock \$5,000,000.; and all sea food amounts to \$101,000,000."

So this means that our inland fisheries and wildlife industry is probably second in Maine in adding to the economy. Now the Department of Inland Fisheries and Wildlife annual operating budget is approximately \$10,000,000. Now only \$4,000,000. come from residents license fees, the remainder is from nonresident and federal grants. This means that Maine's citizens are only investing \$4,000,000. to perpetuate a resources that in 1980 resulted in expenditures of \$120,000,000, in Maine. Now for years the license fees of Maine's sportsmen have paid for search and rescue. Presently the Commissioner estimates that we are spending between three hundred and four hundred thousand dollars of Fisheries and Wildlife money carrying out and enforcing environmental laws in the State of Maine. So I think that it is about time we realize the importance of this industry, and faced up to our responsibility and funded it so that we can keep these important people on Thank you:

these important people on. Thank you. THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Minkowsky.

SENATOR MINKOWSKY: Mr. President and Members of the Senate, since the other batteries of questions I asked especially about the Governor vetoing this Bill have not been answered I have to assume that the possibility is there that he will veto it, and the fifteen (15) employees are gone forever in other departments, but I wish that somebody would be up front to say exactly what they are.

But I call your attention to the Audit and Program Review Committee's report of agencies in 1983 just one particular point. At the base of page 80 it says: "Legislation recently enacted which raises license fees effective January 1, 1984 is projected to provide the Department with approximately 1.7 million dollars over the biennium, however a quick analysis shows that if the Department expenditures remain constant this amount will serve only to provide a breaking point. It will not allow for a cost of living increase, nor replacement of existing equipment, the addition of staff, nor build back an adequate cash reserve for cash flow purposes. Therefore," and this is the point I want to stress this afternoon. "Therefore the current fiscal situation will remain unresolved and worsen unless the Department cuts back on services and staff." Cuts back on services and staff from their own recommendation. 'Obtain another license fee increase or receive alternate sources of revenue.

Now I have no objection with the amendment this afternoon, I intend to vote for it, but I think that you people had better be up front to say exactly let's not band-aid this Department, let's face up to the problem and resolve it for them so that these people can get back to a normal lifestyle.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Diamond.

SENATOR DIAMOND: Thank you, Mr. President. Ladies and Gentlemen of the Senate, the gentlemen Senator from Androscoggin has raised two or three or four questions some of which no one could answer, others of which can be answered.

Number one, I do not know how the Governor is going to react to this. I don't know if he will sign it or not, that is not our decision right at this moment that is his. We have to decide if we want this amendment on, if we want this bill passed.

The question that the good Senator just asked on services and staff, and on alternate funding source is quite clear and it has been quite clear for the last two or three weeks but many people have been saying that indeed there needed to be changes in the Department. Like any department, the Department of Inland Fisheries and Wildlife is not unique if it were it would be a perfect pure situation where it would never need to be reviewed, nor would any changes need to be made.

Now the Audit and Program Review Committee did some real good things. We feel that way and so does almost everyone else who has read the report. We have changed somethings down there. We've condensed their management source from eleven (11) positions to five (5), and we have cleaned up a lot of the things that any department is apt to accumulate over the years. We have had good cooperation from that Department in making these changes and recommendations. The alternate financing source that we make that we suggest have been several, we made cuts. If you read on in the Bill L. D. 2077 you'll see some cuts that we have recommended. We have, also, eliminated other positions to be moved or eliminated. We have done just what this report says we have done and we are very proud of it.

This amendment before us now deals with a very specific problem and that is gutting or taking away from the real resource protection that this Department has claimed and in charge of making. That is our roll and I think that that is why many of you have said to me and other people why you feel that this probably should happen at this time, especially where it is the twelfth hour, as the Senator from Cumberland, Senator Usher has said. So the Audit report is tight and we feel very good about it. We have made some changes in management and we have suggested ways of saving money. We think that this amendment is very appropriate that came from the Committee on Inland Fisheries and Wildlife.

So if there are any other questions regarding the Audit Report I would be very pleased to answer them. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Pray.

SENATOR PRAY: Thank you, Mr. President. Mr. President and Ladies and Gentlemen of the Senate, I apologize to the Senator from Androscoggin, Senator Minkowsky, I had intended to respond to some of his comments earlier but he got up again before I had a chance to get up.

Ladies and Gentlemen of the Senate and Mr. President, in reference to what the Governor will do if this Bill reaches his desk is something that we could all speculate on for a great deal of time. Until he actually has it and is given the option to consider the entire Bill and as to whether or not this one provision of the Bill would deter him from signing it is something that only he will make, I think once that Bill reaches him.

I do not think that we should weigh our decision on a piece of legislation that is pending before us based on what we feel may happen down the road. We have to make a decision as to what we feel is the proper thing for the Legislative Body to do.

In reference to the Senator's concerns about what has happened since the report of the, I believe, twenty-five (25) or twenty-eight (28) positions, I think that originally there were twenty-eight (28) positions of which twentyfive (25) of the positions were filled. So we are talking about twenty-five (25) individuals. Probably they will tie into the remarks that the Senator from Cumberland, Senator Najarian when she made reference to the clerks. First of all she referred to them automatically as Secretaries, and first of all she referred to them as being female and I am not sure that that is true. I don't think that all of our wardens are male, but in reference to whether or not these positions are of a particular gender I am not sure.

I think that there is some concern about if the Fisheries and Wildlife Department is in financial concern that an establishment of priorities must take place. In that establishment of priorities I believe that it is the concerns of some of those, and the good Senator from Cumberland, Senator Usher has attempted to express it in the amendment that we are considering, is to establish the priorities that the biologists and the hatcheries at this stage are more important considering the financial condition of the Department. It is not to say that those other positions are not important, it is not to say that they are not valuable to that Department, but with the financial considerations or the steps that have to be taken I have to commend the Senator from Cumberland, Senator Usher in the propsoal that he has now presented for our consideration.

There is a publication that is put out by the

State along with a number of others, it is the annual report of Maine State Government. I would suggest that if any of you have an opportunity that you look up the various departments of State government, that includes the Executive Branch, the Legislative and Judiciary and goes through the various commissions and boards and departments. In there it gives you a basic breakdown of each department. Stating its purpose, its organization and programs that it implements.

I just would like to take a moment of your time on this late Friday afternoon to read you the purpose of the Fisheries and Wildlife Department. And I quote: "PURPOSE: The Department of Inland Fisheries and Wildlife was established to ensure that all species of wildlife and water resources in the State of Maine are maintained in perpetuated for their intrinsic and ecological values, for their economic contribution and for their recreational, scientific and educational use by the people of the State of Maine." It continues, that is the first sentence.

If that is the purpose and the charge of that Department, then, I think that these positions that we are addressing today are of paramount importance. I believe that the Legislative action is to express its concerns for the preservation of our resources which has great economic and ecological advantages to the State. These particular positons while it would be nice to have a clerk filing the reports for the various wardens throughout the State, I think that it is far more important that we have the educationally qualified individuals to protect the resources itself. That is of paramount importance and for that reason it would be my intention of supporting this amendment without concern of what may happen on the second floor. Thank you, Mr. President.

THE PRÉSIDENT: The Chair recognizes the Senator from Kennebec, Senator Kany.

SENATOR KANY: Mr. President and Members of the Senate, I am sure that we all agree on the importance of the Department and the work that it does and the people who attempt to provide those services to the people of Maine. I have not been directly involved, as many of you have, in dealing with this very difficult subject. I am surprised to see, or perhaps surprised not to see either in the amendment or in the bill itself any reference to the retirement provisions which have been alluded to by so many throughout the State. I guess that it was my understanding just from talking with all of you and people in the halls that there was a great deal of interest in changing the extremely liberal retirement provisions which have been in our statutes for so long. I am wondering why either this amendment with its attempt to deal with the very important personnel policy or the Bill, itself, does not deal with the retirement provisions. Secondly, I am wondering if in the personnel cost if someone present, who knows much more about this than I, could please illuminate for me the percentage of personnel costs in that Department which can be attributable to the very liberal retirement plan?

THE PRESIDENT: The Senator from Kennebec, Senator Kany has posed a question through the Chair to any member of the Committee who may respond if they so desire.

The Chair recognizes the Senator from Penobscot, Senator Pearson.

SENATOR PEARSON: Thank you, Mr. President, Men and Women of the Senate, with regards to the retirement provision. I would like to remind the Senator from Kennebec and all other Senators here today, that the charge of our Committee was to review this Department as an individual department. The subject of twenty (20) year retirement did occur. We thought at the time that we were doing this, over the course of the last year, that that subject might be beyond the purview of this particular Committee. Especially recently when it became apparent to us, known to all of us, the Committee on Aging, Veterans and Retirement had a bill dealing with that very subject matter.

Twenty (20) year retirement affects not only the warden force of this State, but also State Police, Marine Sea and Shore Enforcement Officials, it also affects Prison Wardens and Prison Guards and encompassed a lot more than we in our narrow field could address.

I am not opposed to that suggestion, but thought that it was more proper for the Committee on Aging, Veterans and Retirement to address that question than it was for us.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Dow.

SENATOR DOW: Mr. President and Ladies and Gentlemen of the Senate just a couple of comments one on the bill that is in aging for retirement. We had a study this summer on it, it is still in the Committee. We have been waiting for sometime, for some figures from the Governor's Office dealing with correction. That is a separate issue it will be dealt with in a separate bill.

Another question by the Senator from Androscroggin on the funding. This bill is not the total answer to the funding of the Fish and Wildlife Department. We are trying now and everybody on that Committee was concerned about everyone that got a pink slip. We are trying now to take care of this problem. The Committee is meeting everyday we are having a bill come out, we hope that will take care of the long range funding. Also, this bill gives us the line-item budget request that we have needed for a long time. I hope down the road two years from now, and four years from now we do not still have this same fight over, and over again. Thank you.

Senate Amendment "A" (S-296) was ADOPTED.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Najarian.

SENATOR NAJARIAN: Mr. President, I offer Senate Amendment "B" (S-297) and move its Adoption.

Senate Amendment "B" (S-297) was READ. THE PRESIDENT: The Chair recognizes the

Senator from Cumberland, Senator Najarian. SENATOR NAJARIAN: Mr. President and

Members of the Senate, this Amendment deletes section two from the Bill which said, the language which read, "The General Fund shall reimburse the Department in full for search and rescue operations." The reason I am offering the amendment to repeal that, take out that section is because it is open-ended number one. In the past we have been obligated to pay for search and rescue of nonsports people as I understand it. Since there is another bill coming out from the Performance Audit Committee addressing other areas of the Fish and Wildlife Department and since this is not an emergency I ask for your support in adopting this measure.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Pray.

SENATOR PRAY: Mr. President and Members of the Senate, I have no opposition to the Amendment being offered by the good Senator from Cumberland, Senator Najarian, but since it deals with repealing the section in the Bill I just want everybody to clearly understand what the existing law now states and that is under Title 12, subsection 7035, paragraph 4, sub-paragraph B, "The expense of the Department in search and rescue efforts shall be paid from the General Fund."

Senate Amendment "B" (S-297) was ADOPT-ED.

The Bill was PASSED TO BE ENGROSSED, as Amended, in non-concurrence.

Sent down forthwith for concurrence.

Out of order and under suspension of the rules, the Senate voted to consider the following:

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Usher.

SENATOR USHER: Mr. President, I move the Senate ADHERE.

THE PRESIDENT: The Senator from Cumberland, Senator USHER, now moves that the Senate ADHERE.

The Chair recognizes the Senator from Aroostook, Senator McBREAIRTY.

SENATOR McBREAIRTY: Mr. President, I move that the Senate Recede and Concur and I

ask for a Roll Call.

THE PRESIDENT: A Roll Call has been requested. Under the Constitution, in order for the Chair to order a roll call it requires the affirmative vote of at least one-fifth of those present and voting.

Will all those Senators in favor of a roll call please rise and remain standing until counted. Obviously more than one-fifth having arisen a roll call is ordered.

The Chair recognizes the Senator from Cumberland, Senator DIAMOND.

SENATOR DIAMOND: Thank you, Mr. President. Men and Women of the Senate, there are a lot of people in here, I think, who agree with the Senator from Aroostook, Senator McBreairty, that we are concerned about everyone and have a lot of compassion for what's happening. I think, also, it is also a real sense of realism and the final line is really not here, the final line is with the Governor.

I think everyone here who has been called by their constituents asking them to do all they can to save the Department or help the Department and especially take care of positions and jobs, I think everyone in this Senate wants to do just that. In order to do just that, I think we have to, to be in fact, as real as we can possibly be. And reality says to me, at least and maybe a few other, that there is a possibility of this Bill being passed and being signed. We can't certainly predict that but we can certainly hope for that. It looks like realism would dictate that ten people and the original presentation we had sent down to the other Body is probably the one to go with. Saying that I would, also, agree basically with Senator McBreairty from Aroostook that we do have a concern for everyone.

The Committee on Inland Fisheries and Wildlife if this Bill passes has a line-item budget authority. They can take that line-item budget authority and go to work on it Monday, or as soon as the Governor signs it, and deal with not only those positions we are not going to fund today or seal today, but other ones as well. So, even though, we're not all totally satisfied with this it seems like it's the best possible shot and also, resting on the fact that the Committee on Inland Fisheries and Wildlife still has a lot of work to do and can now do it. Thank you Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator McBreairty.

SENATOR McBREAIRTY: Mr. President and Honorable Members of the Senate, I think that it makes real sense to keep the people on, get our line-item budget and then layoff the people we feel we don't need, rather than lay them off and then try to hire them back. This is what this amendment that was put on in the House will do.

Now, I don't agree that we need all these people, but I think we do need some of what's going to be laid off here if we don't accept this amendment. I think it's a shame to lay them off and then try to hire them back. I think it would be a real disruption and I'd hope that you would Recede and Concur. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Pray:

SENATOR PRAY: Thank you, Mr. President. Mr. President and Ladies and Gentlemen of the Senate, as the good Senator from Cumberland, Senator Diamond, has already commented and I'd like to just, also, stress to the point that each and everyone of us in this Chamber are concerned about all of these individuals. The action, the position that I am about to take is not one that will guarantee that the Department will continue to operate with a full contingency of staff-people.

I stated earlier today the concern of establishing a priority in a tight fiscal situation. Usually, it would be somebody like the Senator from Aroostook, Senator McBreairty, talking fiscal responsibility and the Democrats talking about the concerns for the individuals.

I have a concern for each of those remaining 15 people, but my concern has been alleviated by the fact that I understand that there is other employment for them within the State in other unfiled positions. That these people, I believe there may be a couple who are not covered, but out of the 15 remaining individuals, they have been taken care of by other positions in other agencies in other departments. It is with that understanding that I am now willing to support the position that the Senate took earlier today to take care of those who protect that resource, from my opinion who are the most valuable in protecting that resource and those who have the expertise in the biological and those who are raising that resource at the hatchery. So for that reason in the hopes that this bill will become law that I am going to oppose the motion to Recede and Concur.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Pearson.

SENATOR PEARSON: Mr. President, Mr. President, Men and Women of the Senate. I've been wrestling with myself for the last half hour or so trying to figure out what I ought to do. I've been around for a long, long time, (eight or nine years now) and I've seen almost every parliamentary maneuver that could be ever thought of, and I have to ask myself the question of what's the best thing for my District and, of course, my State?

Sometimes, bills are amended to kill them with kindness. Sometimes bills are amended so that you put so much weight on them that they sink. I think, although I cannot be sure, that if we were to Recede and Concur the bill might be in a position of having too much weight. I want, I think everyone of those jobs are extremely important and I want them all, but I don't think I can have them all. I fear with the limited amount of knowledge that I have, that if I were to vote to Recede and Concur, and the Bill eventually ended up on the second floor for the signature down there, that it would be so heavy that it would be vetoed. Then I fear that we would not override. So, consequently, although I feel very, very bad about it, a half a loaf is better than none at all.

THE PRESIDENT: Is the Senate ready for the question?

The pending question before the Senate is a motion of the Senator from Aroostook, Senator McBreairty, that the Senate RECEDE and CONCUR with the House.

A Yes vote will be in favor of Receded and Concurring.

A No vote will be opposed.

The Doorkeepers will secure the Chamber. The Secretary will call the roll.
