In Senate Chamber Wednesday January 9, 1985

Senator **HICHENS** of York was granted unanimous consent to address the Senate On the Record.

Senator HICHENS: It is a well-known fact since I've been in the Legislature that I've always supported the Maine Milk Commission. I've been criticized sometimes and have worked sometimes against the Governor's recommendations to eliminate this Commission. I always felt that it had a very important part in our State function.

I was very dismayed this morning to read in the papers of action taken by that Commission yesterday, where they placed a price differential in the milk delivered to supermarkets, and milk delivered to small family stores. I do not know just why this action was taken. I have asked for some information on it and was not furnished that information: but I think this is a very discriminatory move by the Commission against these small "momma and papa" stores who are fighting to keep alive, so of speak, against the supermarkets; and then to have to pay six cents more a gallon for milk delivered to them, and consequently, have to raise their price in order to even break even in the price schedule nowadays, I think it is very unfair. Although, I have volunteered to cosponsor a bill to take care of this, I understand their action will become effective in February, and I don't know whether we can get that bill acted upon before that action does take place.

I think the Commission should be advised that the Legislature is not going to let things like this happen that are going to hurt our small businesses in the State of Maine, of which we were made so much aware of yesterday—the importance of them.

I would like to go on Record as being very much opposed to the action that was taken by them yesterday.

Senator HICHENS: Mr. President, may I again address the Senate On the Record, please.
