Yesterday evening in Lincoln, a very large crowd appeared from that area, and some people from outside that area, to talk about the High Level Nuclear dump site. In attendance at that meeting was Dr. Mark Loziel who is a geologist who works for the State of Maine, graduate of M.I.T. with a PhD. degree, who we are very fortunate to have working for the State Government. Dr. Richard Berringer, who is a Chairman for the Governor's Blue Ribbon Task Force on High Level Nuclear Waste and Senator Judy Kany who is the Chairman of the Advisory Committee on Nuclear Waste.

I would like to tell you, Members of the Senate, that I have never seen anyone become as knowledgable and preform as well and do as good as job as Senator Judy Kany has done and did last night as well as for the last several months on this particular subject. Every question that was posed she knew the answer to, or at least was the most knowledgable person there, at the meeting. The people in the Lincoln area, and myself especially, and Representative Clark, each one publicly remarked how we all appreciated her presence and her hard work. A lot of people don't realize, I don't think, what she has given up. If I am looking for Senator Kany on the weekend she is in her office, she is working eleven hour days, seven days a week, trying to be prepared as this State possible can be. This has not just been a recent occurrence, although I am sure that I was oblivious to it before. I now know many things that I didn't know before about the ground work she has laid.

Almost every one of the protection plans that have been designed by the people that control Maine's public lots have been affected by her advice so that we could be in a position of being able to defend ourselves when the Federal people came. She has been diligent in working with the Indians and getting them up to speed and encouraging them. It is just many things. I think that Senator Judy Kany has performed probably the most outstanding job that I have seen a Maine Senator perform since I have been in office.
