THE PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Webster.

Senator WEBSTER: Mr. President, Ladies and Gentlemen of the Senate. I would ask that you not support the Majority Report so that I can move the Minority Report. Let me explain, very briefly, what this Bill does.

We have two Bills, Committee Report "A" which allows the local registration of watercraft and gives the local town clerks a dollar increase to do this and I am supportive of that. As a matter of fact, Committee Amendment "B" does the same thing. The difference is, that Committee Amendment "A" gives an additional dollar to the Department.

Currently boats are registered for two years at a six dollar fee and we are going to raise that by a dollar. My feeling is, and many of us feel, that this Legislature and the current Administration on our second floor, has been unwilling to deal with the problem the Department has been in, the financial situation.

It seems to me that several years ago, the Legislature should have been willing, I have always felt, to give General Fund monies to help the problem the Department of Fisheries and Wildlife has been faced with. Unfortunately, we have done the same thing with this Bill as we have done all along, that is; raise more fees, pass on the problem to those of us who are using, in this case to the boat owners, rather than deal with the issue. One of the biggest industries this State has is Fish and Wildlife, we bring in more money to General Fund through tourism, through other means, than perhaps any other industry in this State. It is my feeling that this is just another fee, another increase, that is not necessary. The Legislature should look at the whole picture and if the Department needs more money, then we ought to get it from General Fund. For that reason I ask you to oppose the Majority Report and support the Minority Report. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Usher.

Senator USHER: Thank you Mr. President. Mr. President and Members of the Senate. The only difference between these two Amendments is one dollar. The one dollar is an increase when you register your boat. We used to register our boats every three years, it was nine dollars for three years. Due to the Tax Bill that passed a couple of years ago, that required an excise tax. Then they cut it down to two years and it was six dollars to register your boat. It became a hassle because everyone would have stickers all over their boats and would have to get an excise tax sticker every year These and only register their boat every two years. are all the problems that started to develop State-wide. Now, they want to register their boats each year and when they register their boats every year it will make it a lot easier. The original 120,000 estimated boats in the State is going to be cut down because we are still not through the two year period and three year period. We are going to need additional people to handle this workload for 120,000 boats all in one year.

We thought the additional dollar would be helpful, because we did not want to fall in the red again. We are starting to get back on our feet as a Department now, being responsible. The recordings of the snowmobiles and boats is all falling in line now and I think it is going to be a responsible Department financially. I think we need this additional dollar to make sure we administer the whole program properly.

THE PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Webster.

Senator WEBSTER: Mr. President, Ladies and Gentlemen of the Senate. When this issue was discussed in the Committee, some of us looked at the figures brought by the Department and thought them to be quite interesting. It seems that currently, anyone who registers a boat in the State either does so by mail of comes here, to Augusta, and register in person with the clerk. If this Bill passes, which I am in support of the concept of doing it locally, most of the work is being done by the Department now. At least the clerks that deal with the public, will not be doing it because if this Bill passes and follows through the way the Motor Vehicle has done, a lot of the work can be done locally in towns. People will go to their local town, they will register their boat there. Instead of having the Department deal with 120,000 people, assuming every town does it, maybe 400 or 500 towns, common sense tells me and tells many of us in the Committee, and perhaps some of the people who signed the Majority Report, that 500 people to deal with are much easier than 120,000.

There is some justification, perhaps, to giving the Department more money. The reasoning they give to me is not sound. I do not see how you can justify saying that you need more people, when before you were dealing with 120,000 people, now you are dealing with 500. It doesn't make sense, when they say they need more money because the clerks behind the counter can't run a computer. Well I would argue, if the clerks can't run a computer then we ought to get the clerks out and get some computer people.

The figures that the Department gave us were shady, to say the least, and did not influence many of us on the Committee. The feeling still seems to be that if we need money for this Department, let's not continue to tack on a dollar here and a dollar there, and five dollars here and five dollars there. Every time we put a new fee on the boat owners, the snowmobilers, and particularly the Fish and Wildlife people, the people who hunt and fish, it seems that sales go down. If the Department needs more money, then let's be up-front about it, let's give them more money, that is going to compete with other issues on the General Appropriations Table and give them more money. I would ask for a Division. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Pearson.

Senator PEARSON: Mr. President, men and women of the Senate. I don't want to pay another dollar. I don't think anybody does, but the fact of the matter is the Department of Fisheries and Wildlife relies on those kinds of monies to operate that Department, always has, always will.

We had a study here a year or so ago, it was two years ago now, and the Audit Committee, which I was a Member of at the time, was interested in it. Particularly, to talk about the finances of the Department of Fisheries and Wildlife. At that time, we came to the conclusion that some of the things we did along with the Fisheries and Wildlife Committee, could keep that Department solvent for awhile, but not for very long.

Everybody knew, at least I felt everybody knew at the time, that there was going to have to be other sources of money for that particular Department. There has been a long discussion about whether there can be any General Fund money, there was because of that, some additional General Fund money that was put into Search and Rescue, and that is an ongoing discussion. In the meantime, I don't think that it is unreasonable to ask for a dollar increase on boat registrations, in a Department that people depend upon, to keep Game Wardens in the field to enforce the law. It is just a case of whether or not they need the money. The answer is yes, they need the money. How do you provide the money? This is one of the ways you provide the money. We have had license increases over the years, and it is true that every time you have a license increase the number of people who buy licenses decreases. But, generally speaking, your revenue will go up. I can't help but think that nobody on the Committee would like to have a dollar increase. But, I also can't help but think that that is what you have to do sometimes, to do the uncomfortable and unfortunate, and bite the bullet and give them the money that they need to operate.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Usher.

Senator USHER: Thank you Mr. President, Mr. President and Members of the Senate. It has been almost twenty years, I believe it has been over twenty years, we have not raised the boat registration. It was nine dollars, but that was for three years. Three dollars a year. In my twelve years on the Committee, we have raised different fees, all different kinds of fees. Through the critical times that we were working on the budget, we did not touch the boat registration. This is the first fee increase for the boat registration, one dollar, and that dollar is only an increase for this area, they won't have to pay the dollar for the administrative fees if they register them in Augusta. If somebody registers their boat in Houlton, they would have to pay a dollar for the administrative service, if Houlton adopts this policy, or if Westbrook adopts this policy. But, they don't have to, it is an option that they can register their boats in their own town. If they continue to register them in Augusta they won't have to pay that dollar for the administration fee. The dollar increase is on the registration part of the boat. One dollar, the first time for a long time, and I don't think that is going to hurt anybody when they drive around in an \$8,000, \$9,000, \$10,000, \$20,000 boat.

THE PRESIDENT: The pending question before the Senate is the motion of Senator USHER of Cumberland to ACCEPT of the Majority OUGHT TO PASS AS AMENDED Report of the Committee.
