Senator ERWIN: Mr. President, Ladies and Gentlemen of the Senate. Yesterday we had a hearing on this matter which lasted for over two hours. There was one individual who came to the podium under neither for nor against. He did not say one word against the nomination. There was not a person who came forward to speak against the nomination.

This hearing was properly advertised and I am sure that it was known throughout the State. If anyone was opposed to the nomination, they certainly had a chance to come forward and have their day in court. There were many people who spoke in glowing terms in favor of the nomination. There were two people who are distinguished Members of the Legislature. One, a Member of our own, the distinguished Senator Jim McBreairty, of Aroostook, the other Representative Neil Rolde.

I don't think there is anyone that can cast any doubt on what a fighter Senator McBreairty is for our farmers and for the people that live in the rural area. Representative Rolde, I need not tell you, is a man of integrity and his principles; you know them. These two individuals have worked with Barbara over the years, and different people in different positions, like in the Audit and Program Review Committee, and they have had the opportunity to see them.

We had Members there that were diary farmers, some were sheep farmers, some were small vegetable farmers, many were Members of State organizations. They all had a chance at one time or another to either work with Barbara or to observe her capabilities. I have never seen a confirmation hearing where there were so many compliments given to one individual. And I repeat, there was no one that rose to oppose her.

When the Committee was questioning Barbara, she responded to every one of their questions. She did not try to evade any one of their questions. There was one Member of the Committee who was quite knowledgeable on both the State and Nation Agriculture. That individual asked many, many questions, getting down into the nitty gritty about what other States and what the Nation was doing. You would have been very pleased to see how capable and how readily Barbara responded to those questions. Ladies and Gentlemen, Agriculture is at a very critical point, not only in the Nation, but in this State. Agriculture will survive in the State of Maine. If is not only sufficient for a man or woman to be a good farmer, to produce a good product at a reasonable cost. There are many other things that ${\rm I}$ won't try to go into today with you, but there are many other aspects that we now must face if agriculture is going to survive. This appointment would be for ten months, or so. We must keep trying to improve Maine agriculture, to give it a better chance to survive, to help it all we can. We cannot let it flounder around until the next Governor assumes office. Ladies and Gentlemen, I request your help and support on this nomination. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator McBreairty.

Senator MCBREAIRTY: Mr. President and Honorable Members of the Senate. I am a retired farmer from Aroostook County. There is no way I could have succeeded as a farmer without the help from that lady from Perham, that you see around the State House from time to time. My district includes in large portions of the farming community of Aroostook County. During my twelve years in the Maine Legislature, one of my top priorities has been to support farmers to the best of my ability. Not only in Aroostook, but throughout the State of Maine. My desire to continue supporting farmers is why I am supporting the confirmation of Barbara Gottschalk as the next Commissioner of Agriculture.

Barbara has been a hard working, dedicated State employee for over seven years. Four of the seven years she has worked very closely with the Department of Agriculture. During 1979, Barbara as Senior Program Analyst, helped the Audit and Program Review Committee do a complete audit and review of the Department of Agriculture. During the audit, Barbara went through every program administered by the Department with a fine tooth comb. Because of her recommendations to the Audit Committee, they were able to eliminate enough outdated programs to make an annual savings to the State of Maine in excess of \$300,000 annually, without any ill effect on Agriculture. Barbara, in the past three years, has worked with the Department of Agriculture as Associate Commissioner, Deputy Commissioner and is presently acting as Commissioner.

During the past few weeks, I have talked to many members of the farming industry, not just in my area, but others. I have found no one who has found any complaints on how Barbara has carried out her duties while working for the Maine Department of Agriculture. At yesterdays hearing before the Agriculture Committee, many good people, from broad sections of the farming community, testified in favor of Barbara's confirmation.

No one, not one person, spoke in opposition. I have talked with all the Committee Members who voted against Barbara. Not one has given me sound reason why Barbara shouldn't be confirmed as Commissioner of Agriculture. Most of the reasons they gave me are too ridiculous to repeat on the Legislative Record. This morning, the Maine Senate has a perfect chance to prove that Maine strongly supports women in Government, and at the same time, make history, by confirming the first woman as Commissioner of Agriculture in the State of Maine, and possibly in the United States. Thank you very much.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Black.

Senator BLACK: Thank you Mr. President, fellow Senators. It has been my privilege to serve on the Committee of Agriculture in this Session. Sometimes you get into some interesting discussions. There are people in this State that would say Agriculture policies are decided here, but most of the basic policies are decided on a National level. Many technological changes.

I am one of the few commercial farmers in the Legislature, and I cannot say that this administration has been unresponsive to commercial agriculture. The person who has applied, has been in the Department, and I can't see but what the policies she was instructed to carry out, were carried our diligently.

There are many reasons given, why we shouldn't nominate her, but I think it probably best not to mention some of them. I can say many of the things that happen in this State, from the commercial stand point, is a result of over-production and until production is controlled, which has to be maintained at a National level, we are still going to have problems, regardless of who the Commissioner is. It is nice to be able to have a scapegoat of peoples' short comings. In the hearing that we held yesterday, there was not one single thing said against this person. Many people claim to be religious and humble and look at things objectively, and I think this is a very good chance to prove this point. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Carpenter.

Senator CARPENTER: Mr. President, Ladies and Gentlemen of the Senate. For those of you who attended the Democratic Caucus, at least, I had made some remarks in there. I simply want to, again, compliment Senator Erwin on the way the hearing was conducted yesterday, and his reflection of the testimony is exactly accurate. I voted against this nomination for reasons which I think probably are clear to most of you, but I want to make just a couple of points.

I think that, at least, partially the vote that you see against this nomination, unfortunately, are a result of the absolute chaos that are present in certain sections of Maine Agriculture and certain sections of the national agricultural economy. I hasten to add that that is not the fault of Barbara Gottschalk. It is probably not something that Barbara Gottschalk or any other Commissioner of Agriculture is going to be able to change, but it is a reflection of the frustration. But, I want to make one thing very clear, as a person who did vote against this nomination, I had attempted earlier on to express my thoughts, if you will, to the Chief Executive of the State. My description of this particular nomination, I think, is still accurate and the words I used with the Governor was, "the right person at the wrong time". I think that is what I still feel. Obviously that had no impact, but because I was involved in the no vote side, if you will, of this particular discussion, I am somewhat privy to those discussions, and to those reasons, because some of those people aren't here today, I just wanted to make sure that the record was very, very clear on one issue, which has been alluded by the last two speakers. And that is the issue of gender. Because I have been privy to that, I am able to stand here today and say that had never, never, not in my vote, or in the vote, as far as I know, the vote of any other of the people that voted against this nomination, in any way entered into the discussion.

It is unfortunate that this has been raised as part of the issue and I am very sad to see that, and there may be somebody in this Chamber who has knowledge that I am not aware of. As somebody who is involved in the discussions in the other sides of this issue. That issue never, never was mentioned. Thank you.

THE PRESIDENT: The Joint Standing Committee on AGRICULTURE has recommended that the nomination of Barbara Gottschalk of Brunswick be denied.

The pending question before the Senate is: "Shall the recommendation of the Committee on AGRICULTURE be overridden?"

In accordance with 3 M.R.S.A., Chapter 6, section 151 and with Joint Rule 38 of the 112th Legislature the vote will be taken by the Yeas and Nays.

A vote of Yes will be in favor of overriding the recommendation of the Committee.

A vote of No will be in favor of sustaining the recommendation of the Committee.
