THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Clark.

Senator CLARK: Thank you Mr. President. L.D. 2139 is the unanimous Committee Report. Mr. President and Members of the Senate, from the Joint Standing Committee on Judiciary, is the product of a lot of work and it originated from a bill which I had the pleasure of sponsoring, in the first regular session of this 112th Maine Legislature. The title of the original bill, L.D. 1505, was a bill to provide a fund for victims assistance. I am fully supportive of L.D. 2139, but I think it is important to lay some ground work for what was the original focus of the original bill, "An Act to Aid the Victims of Crime".

As I mentioned, the purpose of the original Bill, was to fund programs to help those who are among the most helpless of our State, the victims of crime, and we all know some victims. Because money is in short supply in too many levels of State Government and in too many areas of our State, it is understood although there was need to fund these programs, and I feel confident that the Committee on Judiciary did embrace the concept, that we couldn't go back to the taxpayers to reach into their pockets even further, to provide assistance to the victims of crime.

However, the plan was to make those who commit crimes fund the victims assistance program, by forfeiting the ill gotten games from narcotics trafficking, thief, and arson. However, this was viewed as a dedicated revenue plan and there are many among this Body, particularly who have harbor reservations about that aspect of funding.

So the concept of direct funding, through the forfeiture and liquidation of the profits of crime, was rejected, as I understand, by the Judiciary Committee. While the concept of expanding the forfeiture provisions of the law was embraced. That was an extension of the law that was addressed by the Committee and is indeed most appropriate and is embraced in L.D. 2139.

It does seem clear to me, that while dedicated revenue funding is not appropriate, that a strong statement has to be made so it is clear to all of us in this Chamber, as time goes on, that this Legislature intends sometime, to use the proceeds of forfeitures to assist victims of crime. We fund the perpertrators of the crimes to the extent that they are provided with supportive legal assistance, supportive counseling, advise, places to park, places to stay overnight, sometimes incarceration, but those same kinds of supportive services are not provided to victims of crime. When in fact, as a result of the crimes that have been perpetrated, upon them and their families, they need and gravely need the same kinds of supportive services.

The money is not tax revenue and costs to taxpayers would be nothing and would cost nothing to collect this money, rather the profits of crime is, in fact, a winfall to the State and should be used, I hope, in the future, not only to aid the State agencies and the law enforcement levels within all of those agencies, but these very special projects, not the least of them is to provide assistance for the victims of crime. Next year, in the 113th Maine Legislature, or than again, maybe in the years that follow. We as Legislators and citizens of this State, as well as the law enforcement officials, must look to funding the many projects which will come before us, as they always do. I hope this morning that we do remember those who are the most silent, the children, men and women, who have been victims and who wear with not much support, and not with much homor that label of victims of crime. For this Legislature needs in some small measure in the future, to talk and address their needs. Thank you Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Trafton.

Senator TRAFTON: Thank you Mr. President. In reference to this Bill which we are currently removing from the Table, I have some concerns. I have reviewed the Maine Agricultural Marketing and Bargaining Act of 1973, particularly section 1957, which provides in association with benefits of that particular act. In section 1957, it provides that in order for an association to become a qualified association, and therefore have the benefits of this bargaining act, it must show several things to show that, in fact, it is a true association. There are in section 1957, sub-section 3, A-E, those specific requirements that must be met in order for an association to qualify under this act.

Sub-section 6, of 1957, provides that that qualified association must submit an annual report. That annual report must contain the information into enable the Board to determine whether or not the association continues to meet the standards for qualification. This particular Bill changes that annual report section and it simply suspends that requirement to continually show that it meets the requirements of this act, therefore, the association can continue to qualify for the benefits of this Bargaining Act when it does not have the burden to prove that it is a qualified association under the Act. I am concerned about this and, therefore, I rise to express my concerns.

THE PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Erwin.

Senator ERWIN: Mr. President, Ladies and Gentlemen of the Senate. This Bill was heard before the Agriculture Committee when I, as Chairman, was preparing myself for the hearing and first started examining the Bill, I had my concerns about it. Those concerns were erased once I heard the different people that were there to testify. I think the 13 to 0 vote of the Committee, also, expresses their concerns.

There is a need for this legislation, there is an emergency on it and I am told if this isn't exacted by the 15th, there is really no need for the Bill, because of the negotiations and contract and etc. Some of the legal qualifications, I have help on, because I am not a lawyer, and I taint to debate a person that is and that portion will be carried by one of my colleagues.

I think if you notice, the other Chamber has passed this Bill to be enacted. I checked on the vote and it was 110 to 0. Nobody voted against Enactment. I have passed out a letter from the Farm Bureau President, Peter W. Currey, I would ask you during the debate to briefly look at that letter from the Farm Bureau. I don't often stand and ask for your favorable consideration on a measure, I do this time. It is badly needed. Thank you.

This being an Emergency Measure and having received the affirmative vote of 29 Members of the Senate, with 1 Senator having voted in the negative, and 29 being more than two-thirds of the entire elected Membership of the Senate, was PASSED TO BE ENACTED and having been signed by the President, was presented by the Secretary to the Governor for his approval.
