March 19, 1986

Senate called to Order by the President.

Prayer by Reverend James Cloyd of the Church of the Nazarene in Oakland.

REVEREND CLOYD: God of our Fathers; God of our Sons; we present ourselves before You this day for examination and direction.

Examine each and every one of our hearts, Lord, and let us see if there is any attitude, any propensity toward pride and self-glorification in us today. So many times the political process is seen by our constituents as a meaningless grappling for power and prestige. But we pray, that it will always be more than that, and that in our actions and attitudes we can help them to see that we view it as more than this; that we view it as an entrustment, a deputation to be the peoples voice in the great Hall of decisions and law. May each of these Senators be cognizant of their responsibility to be in harmony with and vote the voice of the people, and not just their own personal opinion. Democracy works well only when the people are represented well, and when the peoples voice and the decisions of their government are in one accord.

The commission given to each of these before You today is one that has many parts. Theirs is the hand into which the torch of time and traditions has been passed. The many that have gone before them and who have set a path of greatness and beauty for our State in its traditions and heritage now look upon them to carry forth the dream and to build upon it; drawing it ever closer to perfection. Again, the strength of that dream lies in the heart of the people these Senators have been called to represent. Let nothing be done in this Hall today, O God, that would disappoint the people or cause them to lose faith in that dream.

Secondly, theirs is a commission of the present. Every decision that they make effects the lives of so many. For one to believe that they have sufficient wisdom to do such a job is foolishness in itself. And that is why we turn to You, O God of wisdom, before we endeavor to even make an attempt. The lives and welfare of every man, woman and child living within the borders of the great State of Maine are effected daily by what goes on in this place. The father's ability to support the family; the mother's ability to run a household and see that its needs are well met; and the child's opportunity for a sound education, a stable home life, and a future to build toward are all things that are touched by the actions of this group of individuals before You today. May they be truly awed by the overwhelming responsibility of it all, and turn daily to You for strength, guidance, and wisdom.

Thirdly, to these is entrusted not only the fine traditions and heritage of the past, and the pressing responsibilities of the present, but the hopes and the dreams of the future as well. The kind of environment, both physical and moral, in which our children will raise their children is very much in the hands of these Senators who stand before You this hour. While our government functions by compromise and collective conscience, let them never compromise or surrender those principles which have made our State and our Nations great; and let them never choose a path that would yield high benefits for the present at the cost of our children's future. Let them always be aware of the many tomorrows upon which their actions today will have consequences for good or ill. And let them always see the faces of the children as they deliberate and decide the vital issues that will effect their future here in Maine.

And finally, Lord, let these Senators know that not only are they accountable to the past, the present, and the future generations, but they are most surely going to have to give account to You one day for all that they have done with the privilege You entrusted them with of giving leadership to this well favored State. Their actions are as stewards not simply of a political state, but of a very real portion of the creation of Your hand. And every act and decision which they make is done in obedience to Your command to man to subdue the earth and have dominion over it. And as surely as You have given that commission, You will require an account from each of us as to how we did what You commanded. Let these before You be able, in that day, to stand upright without shame and, because of their dedication to the principles of Your word and Your kingdom, hear You say to them, "Well done, they good and faithful servant." Amen.

On behalf of the Select Committee to Address Training and Employment Opportunities for Handicapped Youth Beyond School Age, I am pleased to transmit the enclosed Executive Summary of our final report to the Legislature. This Executive Summary provides background on our efforts to study the transition issue and prepare proposed legislation. I appreciate your support for this bill which may come before the Legislative Council this week.

Maine has made a considerable investment in special education for handicapped students. More than 1000 handicapped students leave Maine high schools each year; many do not graduate and an even greater number have inadequate plans for transition into necessary adult services. For the majority, unsubsidized employment and independent living will never be a reality without these additional services.

It is now time to create a smooth transition of services from school that enables employment and community living in the least restrictive manner for each student. We are confident that our proposed legislation would develop better services and therefore improve the lives of Maine's handicapped young adults. The proposed bill would create six local projects in Maine that develop innovative interagency approaches to this problem.

We apologize for the lateness of the final report; it was to have been delivered in January of this year. However, I hope you will agree that the short delay was necessary to address such a complicated issue in a comprehensive manner.

The Select Committee was composed of representatives of the many groups which play a role in the transition of handicapped youth from school to community living. Each of these representatives, and myself, stand ready to answer any questions of concerns you might have on this report and on our proposed legislation.
