THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Carpenter.

Senator CARPENTER: Mr. President, Ladies and Gentlemen of the Senate. This Bill is the medical malpractice bill, which has been discussed at great length in this Chamber, and elsewhere in this Legislature this term. As the Bill was proceeding on its' way, and after it was engrossed, the legal counsel on the third floor, the legal counsel to the Legislature, determined that there were certain technical flaws, and we have prepared an amendment to deal with it. It is in your book under filing number S-543. So, with the permission of the Senate, I will be backing this Bill up, amending it, in about five sections, but again, I assure you that there are no substantiate changes in this amendment.

On motion by Senator CARPENTER of Aroostook, the Senate RECONSIDERED it's action whereby this Bill was PASSED TO BE ENGROSSED.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Carpenter.

Senator CARPENTER: Mr. President, we have neglected to put in for the appointing authority of the Chair of the Mediation Panel to replace the Chair, if the Chair was unwilling, or unable to serve. That is the first item in the amendment. If the Chair is challenged by a party to the proceedings, we neglected to specify how that challenge was to be undertaken. We also clarified the authority of the Chair of the Mediation Panel, if you will, to issue subpoenas, that is the Chair's authority. It said in the original bill that the Maine Rules of Evidence did not apply because we wanted this mediation panel to be basically informal, along the lines of the Workers Compensation however, we didn't use any standard other Commission, than the Maine Rules of Evidence. So, we have now lifted the standard from the Administrative Procedures Act, and that is, such evidence upon which reasonably persons are accustomed to rely in the conduct of serious affairs. That is the language under the APA. We took out some wording in the next section, and the rest of it is simply clarifications, and in two instances there were typos involved. Then, because we are going to call professionals under greater scrutiny, it affects the number of complaints that are settled against them, within a period of time. We knew that we had to have additional staff, and so the wording that we used, we thought we would get twice as much staff in the Department of Human Services and the Attorney General's Office than we wanted, so we made sure that we clarified that.

Presently, the monies that are in the Home Base Care Account are being used and tapped for the match for medicaid waiver, resulting in a depletion of their resources that are needed to help the home bound elderly. The amendment then addressed the problem by turning back to the the Home Base Account \$500,000 of the surpluses in the ICF account. There will be left in that particular account, a cushion of \$500,000, plus they will continue to keep \$950,000 from the Home Base Care Account, to be utilized for the medicaid waiver. This will alleviate a very serious problem that exists right now, because since the advent of the medicaid waiver program, many elderly have been unable to be served because of the depletion of the resources of the Home Base Care Account. As you know, the Home Base Care program serves the need of those who are least able to care for themselves and this amendment will alleviate that need. Thank you.

Senator PERKINS: Mr. President, I would like an explanation of this amendment.

THE PRESIDENT: The Senator from Hancock, Senator Perkins, has posed a question through the Chair to any Senator who may care to respond.

The Chair recognizes the Senator from Cumberland, Senator Andrews.

Senator ANDREWS: Mr. President, Men and Women of the Senate. To answer the good Senator's question, this amendment addresses a bill that we passed several weeks ago, that dealt with the fuel assistance program. As you know, we made some changes in the program to allow municipalities that are currently administering locally that program, to continue to administer that under certain conditions. Because of a drafting error, we, in fact, amended a statute which we had repealed earlier. So this amendment, in essence, puts this bill that we discussed and passed several weeks ago, into the Division of Community Services section of law. There has been no substantive change, it simply places this statute that we passed several weeks ago in it's proper place in the books.

Under Title 1, section 71, Rules of Construction, sub-section 7, says words of a masculine gender may include the feminine, however, it is my understanding that under the recodification of the education laws, in Title 20-A last year, Title 20-A, sub-4 says, ignore this gender in neutral paragraph of Title 1. We are now repealing that ignore language, if you will, and we are adding a couple of more words and that is, where every reasonable, as determined by the revisor of statutes, nouns rather than pronouns shall be used, to refer to persons in order to avoid gender identification. The participants in controversy, have included Senator Clark, and persons who don't reside in this Body, but yet, who do reside on this floor, and it is my understanding that although this could arguably be a substantiative change, it is something that the Revisor of Statutes feels is necessary to help him clear up his books for now and in the future.

WHEREAS, the United States Food and Drug Administration has determined that methylene chloride may be present in coffee as a residue from its use as a solvent in the extraction of caffeine from green coffee beans at a level not to exceed 10 parts per million; and

WHEREAS, the methodologies used by the Environmental Protection Agency to evaluate cancer risks from methylene chloride have projected a risk that is 26 times greater than the United States Food and Drug Administration projections; now, therefore, be it

RESOLVED: That We, your Memorialists, respectfully urge and request the Congress of the United States to take immediate action to request further testing and evaluation of the safety and advisability of the acceptable level, if any, of methylene chloride allowed in coffee as a residue from its use as a solvent in the extraction of caffeine from green coffee beans; and; and be it further

RESOLVED: That the disparity between safe levels of methylene chloride as recognized by the United States Food and Drug Administration and the Environmental Protection Agency be reevaluated and explained; and be it further

Senator KANY from Kennebec was granted unanimous consent to address the Senate On the Record.

KANY: Mr. President and fellow Senators, I just wanted to mention On the Record that today is not only the statutory deadline for the Legislative Session ending, but it is also the final day that the U.S. Department of Energy will receive responses to it's Draft Area Recommendation Report, in which it announced on January 16, that two of Maine's granite bodies were selected for further consideration as a possible host for half of the Of course, there are one Nation's nuclear waste. hundred operating and licensed nuclear power plants in the Country, and we have been accumulating high-level radioactive waste from defense activities since the 1940's. That is a substantial amount of high-level radioactive waste that the U.S. Department of Energy is considering locating here in the State of Maine. The Governor's task force on high-level nuclear waste was able, with a great deal of effort and cooperation on everyone's part, to put together a very good document, and that did arrive, if all went as planned, in Washington and Illinois today. I do have just about five copies of the executive summary of that report here, and if there is anyone who would like one today, please come and see me afterwards.

Secondly, each of you has received the entire report from the Advisory Commission on radioactive waste, and we issued this report not only to the Department of Energy, and hopefully they received one at the Washington and Illinois offices today. Because of our statutory responsibilities to you to report to the Maine Legislature and to the Governor on the activities of the Advisory Commission during the Legislative Session.

There are many of you, if not all of you, who would rather see someone else have a copy of this document than yourselves. If that is indeed the case, I hope that you would ask a Page to deliver it to me, or if you would make certain that I get it, or one of the other two members of the Commission instead of just throwing them away, because we did only have five hundred copies printed and we have already had many requests. I would appreciate if we could get them back so we could distribute them.

I would also like to wish those of you who are retiring, well. I am going to miss each and every one of you, and I can't imagine that the Maine Senate will function without you. It is really kind of impossible to imagine that so many experienced, qualified, responsible veterans are retiring this year. It seems like a little bit too much. I especially would like to thank Mary Najarian, who really served as my mentor when I entered the Legislature, in the House, and who has been very special, always gracious to everyone, and I particularly thank her, but I have enjoyed each and every one of you and I just wish you godspeed.

Senator CARPENTER of Aroostook was granted unanimous consent to address the Senate On the Record.

Senator CARPENTER: Mr. President, Ladies and Gentlemen of the Senate. This is a day that I have both dreaded and looked forward to now for these last twelve years. Dreaded that it is always difficult for me to say good-bye to anything that I hold very dear, but look forward to, in that I have always felt badly for those persons who left here one session thinking that they were returning and didn't return, and never had the chance to say good-bye and thanks for the memories. I guess that is what I am doing here today. Twelve years worth of memories, almost one-third of my entire life is very difficult to sum up. I tried to jot down some feelings and some thoughts and decided that it was probably better to just let fly with whatever I was feeling. I almost got up this morning, when other Members who are retiring made their remarks, and then I decided that it probably would be better, especially after my colleague from Aroostook, Senator McBreairty, got done, I wasn't sure I could follow that act. Twelve years is a long time, and for somebody who sort of came out of the woods of Aroostook County, literally, from a one room school house, and when he was twenty-six years old, agreed as a favor to a group of people, to put his name on the ballot as a ballot filler, and lo and behold ended up down here. Some wonderful things have happened to me and many of those things have been as a direct result of my affiliation with this Body or the Body at the other end of the Hall, and with the individuals in the Body. I commented when I first ran for election in 1974, that I only wanted to go to Augusta for a couple of years, and if I could come home as idealistic as when I had gone down, that I would be very well satisfied.

Let me assure you today, even with all the agony and pain of the last few days of the Legislature and defeats that we all have suffered here and there, I go home today with a great deal of pride in the Maine Legislature, and I will continue to, as I have in the past twelve years, tell the people of Maine they have all the right in the world to be very, very proud. am very proud of my service here and the friendships that I have made. I remember when Sam Collins stood on this floor two years ago and made his parting remarks. He pointed out something to me that \boldsymbol{I} wasn't aware, Sam being the thorough person that he is, had gone to do some research, because he and his brother Don had both served in this Chamber and he wasn't sure that two brothers had ever served in the Legislature at the same time. Lo and behold, he came back and told me that three brothers had served in the House at one point together, from the towns of Howland, Dover-Foxcroft and Patten, and that their name was Carpenter. They were my great, great, however many, uncles. That made me proud.

To you, who suffered through law school with me for three years, I thank you very much for your patience. I only wish that Gerry Conley, Frank Wood and Sam Collins, and those people were here. I served in this Body for ten years, I was very honored to serve as the Assistant Floor Leader here for two years, and now these past two years, which have been my best two years, my most enjoyable two years of my twelve, I have served as the Chair of the Judiciary Committee. Nothing could have come to me as a greater honor or have given me greater pride. It is very difficult for me to leave here and I have thought about it now for the last few days, and the more I thought about it, the more difficult it got. As most of you know, I am attempting, at least, to come back to this city in a different suit of clothes, if you will, but regardless of that, I leave here, and I hope with your friendship. I can't say thank you enough to the people that I have served with here, and most of you have been here for a number of years with me now, regardless of political party, some of my best friends are on the other side of the aisle. Thank you to the people who have worked here, I couldn't begin to name all of them, I tried to list a few of them and I got the Kevin McVey's and those people, I look to, the Sue's, Peggy's, Marcia's, Molly's, Timmy's, Tommy's, Jim's, Henry's, and all of the people who have worked here, Carol Carothers, Judy Brown, Dan Paradee, Monaghan, I hope I didn't leave anyone out, I am sure that I did.

I say thank you so very much, there are some very special people, some very special friends that you make over the years. Persons such as Joy O'Brien and Charlie Pray, Paul Violette, and Pam Lovley, how could I possibly stand here and make any comments about my last twelve years without including Pam. To each of you, thank you, godspeed, and thanks for the memories.

Senator BUSTIN of Kennebec was granted unanimous consent to address the Senate On the Record.

Senator BUSTIN: Thank you Mr. President, Ladies and Gentlemen of the Senate. I am going to read a poem to you about this back row that I sit in because I am losing half of them and I thought it was appropriate. Senator GILL of Cumberland was granted unanimous consent to address the Senate On the Record.

Senator GILL: Mr. President and Members of the Senate. Some of the people who are leaving, I have had the joy of spending quite a bit of time with. Some of them have been here a shorter time, such as David Kerry, but I feel like I have known David longer than his time here, because I have known the family and have known him in the past a little. Michael Carpenter, I almost feel like a mother to him, I feel like the mother of the Senate, in spite of my young age. But Senator Carpenter and I have gone back a long ways, since all of my time in the Senate. I have lived through his baby horse, I have lived through various friends that he has had in his life, and I lived through him getting married and now his new expectant child, so I feel like I am going to be a grandmother to the child. Senator Trafton, we have not worked that closely together, but I had the pleasure of serving with Senator Trafton's wife, Barbara Trafton, in my first term in the Legislature, and we served on the same Committee together. Everyone here, we have some memories of.

Larry Brown, I wish he was here, because I sit here and I twinkle down at him, we have a little eye contact and a little body language that both of us understand and it makes it very pleasant during some of the more dull moments here. Sometimes Jim has earned the name of bull dog because he is dogged, he is persistent, but it certainly has paid off for the people in the area that he represents. Jim has an awful lot of information and if people would stop to listen to him, and many have, and did learn a lot from him. I have appreciated being able to work with Jim. He also is known as King of Sentiment, because he has acknowledged the people in his area, and $\, I \,$ also have a bouquet of flowers for Jim to give Doris, and I know Doris is sitting right in back of me. Doris is one of the balcony beauties, as is Myra. But they have been constant companions and constant workers and we have appreciated the effort that they have offered the Legislature and many people here. am going to turn this over to my seat mate Senator Perkins.

Senator PERKINS of Hancock was granted unanimous consent to address the Senate On the Record.

Senator PERKINS: Mr. President, Ladies Gentlemen of the Senate. It is my pleasure, and yet my sadness, to add to this occasion, and I would like to start with my good friend and loyal colleague, Courtney Stover, and of course where Senator Gill has laid the groundwork where, in essence, we are really honoring his wife, Ida, who through all this ten years of service, has been the one who has provided the homestead and kept things on an even keel at that level, so that Courtney could leave early in the morning and arrive late home in the evening. spending the day here on many occasions, I am sure not especially anxious to discuss what happened here, because if he is like the rest of us, he is not sure in many cases. Each of us campaign in our own way, and do things in our own way. Courtney never sends out a news letter, and yet he sends many letters, but he addressed them by long hand. His association with the people is not by the media, but by first hand eye to eye contact. He has done all his legislative career and has made a practice of dealing with the people on a first hand basis, and his integrity and reputation in his area can only attest to his success. Courtney if you would be so kind to take that to Ida with our best wishes and tell her although we will miss you, we wish you both the best.

I left for last my colleague, in my adjoining County, who was here when I joined the Legislature $% \left\{ 1,2,\ldots,n\right\} =0$ twelve years ago, and served with me, trained me and tolerated me on my first years of being on the Legal Affairs Committee, and taught me some of the basics of the good politics for Eastern Maine. Who, through the years, whenever there was a chance for help or a chance for guidance, or a chance that perhaps I was strained and not appreciating the touch and feel of the people in coastal and eastern Maine, he was one of the first to come and offer suggestions and offer that help which drew me back into a more rational pose. I don't think, through the years, that our votes you'd have more than two dozen votes that he and I varied on through our legislative careers. It has been my pleasure to work with someone who you could go to and get a distinct feel for the people that you are representing. Knowing that in the past few years Mel Shute has been able to provide that type of representation that others felt it wasn't worthwhile to run against him, I think is a tribute to any Legislator. Mel, if you would take that to Jan, and perhaps she would put that in the travel trailer and you could take that along the way and think of those of us here in the Senate in the next few months. Although you may have a great time, we certainly will miss you.

Senator BUSTIN of Kennebec was granted unanimous consent to address the Senate On the Record.

Senator BUSTIN: Thank you Mr. President, Ladies and Gentlemen of the Senate. I rise again to honor the seat mate on my right who I have enjoyed very much this last Session. But he went and got married on me, and besides that, he went and became an expectant father. We all know that this Senator is expecting that baby in June. What you may not know is that I also make babies. Now don't laugh at that. I am a grandmother, but I still make babies, they just happen to be cabbage patch babies. I still don't understand how you got this friendship with the Senator from Penobscot, Senator Baldacci, but I will try to understand this, and it is one of the many mysteries of the Maine Legislature. But I think Mel will most be remembered for his great prowess at the baseball bat. For a couple of those years, when he led us to many victories, and to you Mel, I wish you good luck and I wish you good health.

Courtney Stover, you are the Senate's eldest statesman in terms of your longevity in life. You are a true gentlemen. You leave us after a long and distinguished career of public service and local county and state government. I wish you best wishes in all of your future undertakings. You serve as a role model and an inspiration for all of us who are far junior to you in our age, and I wish you godspeed and good luck in your future.

Well, Senator Trafton. If I can't find him, if I wake up in the morning and the sun is out and the wind is up, I know he isn't going to be here. He is going to be out on that lake somewhere skin diving, windsurfing, sailing, ice sailing, I don't know what else he can do over there at Lake Auburn, but I know when he is going to be here and I know when he is going to be gone. I am amazed that he is here today, when I see the sun, but there is no wind so the Senator is here with us. I don't even have to call him at the law office because if I call him there, they say "you know where he is." To you Dick, I am not going to hold in account all the things you said against me when you ran against me for Majority Leader, because I would have to do the same to you, but best wishes to you. I am sure the Trafton name will continue to appear before the public for many Good luck to you in your future years to come. career.

We have eleven Members who are leaving and they served 68 terms in the Maine Legislature, 136 years of service is departing this year. To those of you who are not running again, consider yourself lucky, because you don't get any of these kind remarks, but I do wish you'd say just a few comments. I have enjoyed being here my five terms in the Legislature. I shall miss my friends and my colleagues. I have spent more than one-third of my lifetime in the Maine Legislature, it is a place that will have many memories. I shall miss my lunches with Senators Twitchell, Dow, Dutremble, Usher and Erwin, who I have lunched with often, a very bad, motley crowd, but nonetheless I have enjoyed them. I could not have been more fortunate than to have Senator Gill and Senator Perkins as my fellow Floor Leaders. They have worked with me and with us and I think, in that respect, they have been successful. I think they took the appropriate tact in terms of leadership. I shall miss my relationships with my colleagues. Senator Kany drives me crazy, but she is a good Senator. I'll miss Senator Gauvreau's words of the week, I don't know what they are sometimes, and when I turn to Senator Clark and she doesn't know what it is, we have to call in the staff to bring the dictionary. I shall miss my partner in crime, my Assistant in Leadership, Nancy. She has been all that I could have asked for. Most of all, I will miss my good friend Charles Pray, in my long tenure with him in the last six years. We have shared accommodations here in Augusta. It is a relationship that has grown, he has served this Senate well, in my opinion, and I shall take liberty of saying, as I'm leaving this body, and can't be held accountable for anything I am saying, I could think of no one that could serve better as President of this Chamber in the 113th Legislature. I only wish that I could vote for you, Charles. It has been my fortune to come from a very special place, there are those who have accused me of being parochial, but I have managed to live in a number of places in the last ten years. I have been accused in living in more districts than most Senators in this State. I have been honored to serve here in the Legislature and I have also been very proud to be the fourth generation of my family to serve in the Maine Legislature. I have been very proud to express my honor in being a French person here in the Legislature and also representing those people.

I thank the Members of my caucus most humbly for having allowed me to be their leader. I must admit it has been the best experience that I have ever had. Being Majority Leader, I certainly enjoyed the trips, and if I had known that I was only losing by \$2,500 to John Martin, you don't doubt that I would have asked for a couple of more. Maybe I can do something about that this year. Best wishes to all my colleagues in all of your future endeavors. Thank you very much.

Senator CLARK: Thank you Mr. President, I would share with you, Mr. President and Members of the Senate, a very brief little ditty. Senator CLARK of Cumberland was granted unanimous consent to address the Senate On the Record.

Senator CLARK: Thank you Mr. President, Men and Women of the Senate. I have been prepared for two days now to place on the Record a response to the statement of the Senator from Franklin, Senator Webster, with reference to L.D. 2069, which is the Nurses Practices Act. As you recall, that Bill came before us in the wee small hours of the Legislative Session earlier this week. I don't even remember what night it was, it might even been Saturday night, but I do know as prime sponsor of that measure, that it would not have been well received by my distinguished colleagues in the Chamber, if I had waxed eloquent on this Bill that evening. I think our priorities were unanimous in that we were anxious to depart the Chamber. It is necessary, in order to answer an inquiry which I will quote. Senator Webster of Franklin said, "It is my feeling that with every nurse that I have spoken to, except for one, has been concerned about the need for this legislation", he then went on to thank the Senator from Kennebec, Senator Bustin, for explaining L.D. 2061. He continued, "It is my feeling that this Bill is unnecessary, it is something that we are fixing that isn't broken" and then he went on to ask for a Division so that he had an opportunity to vote against it. As prime sponsor of that measure, I think that it is important that the Record shows why it was necessary. We enacted L.D. 2061. For L.D. 2061 is and was a Bill to update the law regulating the practice of nursing and to set in motion future changes in the educational requirements for licensure as a nurse in the State of Maine. L.D. 2061 is a Bill that was written by nurses, professional people in the State of Maine, because they believe as do the vast majority of Legislators that not only the consumer will be better served by clarifying and upgrading nursing education, but that quality health care must be provided for all of Maine people. The goal of that Bill is for the attainment of two levels of nursing education and practice to be in place by 1995. That is attainable today, because L.D. 2061 has finally been enacted and will shortly be signed by the Governor.

That achievement is the result of the concerted efforts of the good Members of the Joint Standing Committee on Business and Commerce, a massive coalition of professional representatives, and citizens, representing every aspect of nursing health care, education. the Maine Medical association, and not the least, our good friend and former presiding officer of this Maine Senate, Ken consumers, educators MacLeod. Nurses, Legislators have studied the issue of nursing and nursing practice in Maine since 1966. The Bill incorporates the results of twenty years of study and work on the issue of nursing education. The most recent study is that of a state wide task force on entry into nursing practice co-chaired by the distinguished Dr. Constance Carlson, President of the University of Maine at Presque Isle, and Betsy Perry an Executive Director of Androscoggin Home Health Agency, and including forty-two members representing consumers, health care providers, educators and Legislators. The report from that study, which was distributed to all of us in both Chambers in 1985, L.D. 2061 is a Bill which essentially has two parts. The body of the Bill which addresses the law regulating the practice of nursing now, and which will become effective this year, and the amendment to the Bill drafted so carefully by all of those that I have mentioned previously, which establishes goals for future educational requirements for nurses to practice at two levels, technical and professional. Changes in the body of the Bill are primarily included, or were primarily included to clarify and update functions of the board of nursing and our summarized in the amendment statement of fact. The definition of nursing has been updated with new language which is intended to neither restrict or expand current practice. The wording was developed to clearly authorize the Board of Nursing to define scope of practice and relationships with physicians for nurses with expanded roles. The size of the Board of Nursing has been increased from seven to nine, by adding one licensed practical nurse and one public member, a statesman had been added to allow the Board of Nursing to develop rules to address concerns of nurses who teach patients, families and their designated helpers in the community.

The amendment that was attached to L.D. 2061, will create a commission on nursing supply educational accessibility to determine if the 1985 recommendations of the state wide task force remain relevant for 1990 and modify those recommendations where they might see need. With the help of the Office of Data Research and Vital Statistics, the commission will study all factors related to nursing supply and educational accessibility. The intent of all the parties remains clear, that the future Maine nurses will be educated to levels, with a technical nurse prepared in a two year Associate Degree program and the professional nurse in the four year Bachelor of Science in Nursing program. The enactment of L.D. 2061, represented a significant step toward helping the nursing profession bring their minimum educational requirements into line with those of other health care professionals and to assure that nurses are prepared to meet future health care needs of all of Maine's people.

I thank you for your time this evening and I particularly thank the good Senator from Franklin, for asking the question, for which there was no response earlier. Thank you.

Senator MCBREAIRTY of Aroostook was granted unanimous consent to address the Senate Off the Record.

THE PRESIDENT: The Chair at this time would like to ask if the Sergeant-At-Arms would escort two individuals to the front of the Chamber for me, the Senators from Aroostook, Senator Carpenter and Senator Violette.

Over the past year, on several occasions, when the Presiding Officer has either wanted to take a break or come down and join in the debate, which commonly, is not capable of being done up here, it has been these two individuals who I have been so confused over all year, that I have called upon to come up and give me those breaks. As you all know, senator Violette, and of course Senator Carpenter over here, are easy to confuse sometimes, during the year, on a number of occasions, they have come up and presided over the Session to give me that break, and I would like to present to them these gavels for them to remember the break that they have given me. These, I have the names on. Senator Carpenter, if you kept that name card in front of your desk, I probably wouldn't have made as many mistakes, but I would like to extend my own appreciation for those breaks at this time to the two of them. Thank you very much.

While we have a few moments, I would at this time, make a few comments to the Membership in appreciation for the support that they have provided to me over the last two years as the Presiding Officer. Back on the 5th of December last year, when I was chosen by you to serve as the Presiding Officer, in my remarks I had stated 'that public life is regarded as a crown of a career and to people who seek it out, it is the worthiest of ambitions. Politics is still the greatest and most honorable venture.' I stated, at that time, that we are collectively one Body and the responsibility charged to all of us, is to proceed forward on behalf of the people of the State of Maine, as at this time we assess as to what we have accomplished in the last two years.

Each and every one of us, as individual Members of this Chamber, I think all of us can feel a sense of pride that we have carried out the obligations that our constituency have requested of us. We met those obligations, sometimes not always in agreement with each other, but in agreement in our own minds that we were representing the people who had elected us to serve, making our judgement based upon the values of the issues and the values that we hold for that constituency.

I would like to take a moment to thank several Senator Perkins and Senator individuals. representing the loyal opposition, the Minority Party. Over the last two years it has been enjoyable to work with both of them, I can't think of very many times that the two of them got upset with me. matter of fact, there was only one time that Senator Gill did. But, we have always had the great opportunity of communicating with each other, in talking about the process of the Legislature, legislation, the management of staff, and the management of the entire Legislature, and a number of times our dealings with the House as a collective Body. In addition, I would be remiss if I didn't mention those on my side of the aisle. Senate Majority Leader Violette and the Assistant Majority Leader, Senator Clark. Over the past two years it has been on numerous occasions that I have sought out their advice, and we have talked about the process, that we would continue on. Working with the committees, getting the bills out of committee, handling the floor debate so that the relationships of the Membership would always be at a high plane, in a high level. I think that we have been able to accomplish that. I can only remember in the past two years of two occasions that we went past eight o'clock at night in session, and it has been because of the cooperation that I have had, not only from the Members from the floor leadership, but the Members of the entire Chamber. The work that the Members of the committees did, and I know that sometimes I was the pest that was standing at the committee door asking when they were going to get their bills out, but the fact is, you met your responsibilities, the charge of hearing the bills, evaluating them, and reporting to us in a very competent fashion, that this entire Body learned to respect each and every individual committees' recommendation.

What the future may hold for any of us, those of you who have decided not to seek re-election and those of us who have decided to put ourselves back before the voter to decide whether or not, in their choice, we should return. I wish you the best of luck, as we leave here this evening, I know that we will return in a special session not too long off, that your endeavors be most favorable. The bond that has been built among the Membership of this illustrious Body is something that I am sure each and every one of us will always remember. I just want to thank each and every one of you for your support and your cooperation over the last two years. Thank you.

Senator VIOLETTE of Aroostook was granted unanimous consent to address the On the Record.

Senator VIOLETTE: Mr. President, Ladies and Gentlemen of the Senate. On behalf of the Majority Party and the Minority Party, I want to take some time to recognize those individuals, who without, this Senate would not operate. I want to thank the various members of the staff for all of their hard work on our behalf. Senator PERKINS: Mr. President, Ladies and Gentlemen of the Senate. I had hoped that I might create a poem after I heard the tryouts today, to succeed my good friend from York, Senator Hichens, as poet laureate, but with that failing, I would be very remiss if I didn't pay, with all due respect, to the staff in our office. May Ross, Jeanne Raynes and Helen Wing. Without the staff here that have worked for Paul, and Paul has mentioned all of them.

The feelings that they have had for us, and the fact that they have gone out of their way and tried to make us feel that they are not only working for that side of the aisle, but are working for the whole Legislature. Without them, the Legislature itself would not work. From early in the morning - Jim Gormley when we meet at 7 o'clock until late in the evening when the crew comes in for the cleaning and we pass another day and say we will see them again in the morning. Each and every one of them. Timmy, and to all of them, who in one way or another, make us feel like family, as we are a family. I think we, on my side of the aisle, say thank you to all of you, because without your friendliness and without your kindness, it would be a lonely task. Therefore, I would like to extend my thanks to all, and to my staff, and to all of you for your patience with us, because at times, we all require this in various stages in the Legislature. For this, may I speak for my party and say, thank you for your kindness. Let's hope that life deals you kindly tonight and the nights that follow. And that those who choose will join us back here again in the fall, those who do not, may life meet you on an even plane and that you will find the things that you so desire. Thank you.

Senator GILL: Mr. President and Members of the We have had a long, hard road with this particular Bill. It is one of the, if not the, last bills that we will be dealing with. I would just like to discuss family planning a little bit with you. The Family Planning Community Education and Information Program, sends a clear and positive message that adolescence is not the time for pregnancy. The program works in partnership with schools, it works in partnership with communities, parents and teens. It helps them to design programs that strengthen the teens ability to make the choices necessary. It is only in recent years, that the majority of teen mothers have chosen to raise their children as single parents, and they face almost certain poverty. Teenagers, who have children, who are children, and who have children, are almost certain to face a life of poverty due to interrupted education, to lack of job skills, and very early dependency on welfare. I would ask you, really, to consider this Bill. We have discussed it a lot. It is very important for you people in this Chamber, who know my position in the past, has always been in favor of life, pro life, and I view this particular matter as preventive measures used instead of looking at abortions later on. I think it is proven that the fact that we have so many teen parents who are choosing to keep their children, and wing their way through life, and do the best they can for them, they need all the help that we can give them as far as preventing unplanned pregnancies. We need to educate those teens, and this is the Bill that will help us to do that. So, would you please vote to have this Bill passed?

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Hichens.

Senator HICHENS: Mr. President, I stand here and ask you tonight, to vote for Indefinite Postponement of this Bill. We have had a concise explanation by the good Senator from Cumberland, Senator Gill, but I do not agree with her perceptiveness on what Family Planning offers to the young people in our State. I think Family Planning Services have taken a lot of young people away from their home for advice, the parents have left it up to the schools, the schools have turned it over to family Planning Services, and we have twelve year olds going to this Family Planning Services, being offered contraceptives, told that if they have to have sex that they have to take these contraceptives and so forth. If something happens and they get pregnant, that they may counsel them as far as keeping the child, they can also offer them the abortive services. I think this is a pro-abortion Bill, and in no dark or light, no shadows in between, and if you vote for this Bill, you are offering more services to the youngsters who are going to encourage them to have more sex.

THE PRESIDENT: The Chair recognizes the Senator from Knox, Senator Chalmers.

Senator CHALMERS: Thank you Mr. President, Ladies and Gentlemen of the Senate. The hour is late and I am probably a little over tired, and I probably should shut up, but I have to answer.

I have offered a bill for a family court. I, who say that the families are the most endangered species absolutely disagree with the good Senator, that this is a family Bill, this is a Bill to help the teenagers. This is a Bill to try to help the families stay together. I urge you to vote against his motion and in favor of the Bill.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Gill.

Senator GILL: Mr. President, we are talking about family life education here. Family life education does promote communication between parents and their children. It does promote respect for family values, and the values of others. It helps children to have fulfilling and healthful and responsible lives and it encourages that behavior in those lives. I feel so strongly about this, and for those of you who know me, you know how strongly I felt in the past, and I have come around to feel that we can't go along aborting people, and their lives. We have to prevent it up-front, and this is the means of doing it. I believe so strongly, that we should put the money in this area. Evidently, somewhere along the line, families aren't doing the job that they should be doing. Churches aren't doing the job they should be doing. So we have to help everywhere we can, in order to stop teenagers from becoming pregnant, because of lack of knowledge and education. I would ask you, again, to vote for this Bill.

THE PRESIDENT: The pending question before the Senate is the motion of Senator HICHENS of York that the Bill and Accompanying Papers be INDEFINITELY POSTPONED.

THE PRESIDENT: The Chair is please to recognize and welcome to the Rostrum, the Honorable Joseph E. Brennan, the Governor of the State of Maine.

(Applause, the Members rising)

GOVERNOR BRENNAN: Thank you Mr. President, Ladies and Gentlemen of the Senate. I was just across the Hall, over at the House. They are really an unruly, uncivilized group. Worse then that, they don't laugh at my jokes. I am glad to be here in a more dignified setting, a place which I had the privilege of serving for a couple of years, with President Pray calmly in control, and a distinguished group of Senators, ready to laugh at any failed attempts that I make at humor.

At the earlier part of this Session, I had a feeling that we were not going to be successful, and not much was going to happen. Well, I want to say now, it has been a very productive session for the people of Maine. I would like to congratulate all of you for your hard work, especially in the last week, when some of you had to work late into the night and far into the weekend. I think that the effort has truly paid off.

The 112th Legislature can now claim to its' credit, important coastal legislation, providing for better management, new piers and new access. The beginnings of reform in liability law, such as the Dram Shop Act, Malpractice Laws and the Municipal Liability Pools. Reforms and Professional Licensing Boards, the streamlining of the State computer operations, new group homes for our mentally retarded citizens, and energy sales tax exemption for our manufacturers, research and teaching to a modest degree in Canadian trade, land trades, which complete the Bigelow preserve. Programs for truants, dropouts and extension of the seasons at State parks, and many more accomplishments truly too numerous to mention.

But most importantly of all, you have addressed the needs of the University of Maine. This is the first critical step, and it is the hardest step with your far sighted act, years of discord put behind us, you have planted the seed of the new University of Maine at every campus in this State. The ground work is now complete, for an educational renaissance in our State. In the last few years, you have re-vigorated pre-school, primary, secondary, vocational and now higher education. I believe that this is unprecedented in Maine's history.

You truly have opened a thousand opportunities for our young, as was envisioned by Joshua Chamberlain, and by Aristotle's test that education should be the Legislature's chief concern. This Legislature has acquitted itself admirably. I especially commend this 112th Legislature for showing the courage to raise the money in an election year that made these reforms possible. The plain fact is that a good education costs money. If that money had not come this year, the momentum for University reform would surely been lost. I think that you faced some tough choices, and you came through, and I truly want to congratulate you.

There is one more tough issue that we will face together, before this legislature's work is done. That is the issue of Corrections. I intend to call a Special Session on this subject in the very near future, probably late in May. I am confident that together we can fashion some long term answers to this very difficult problem. I believe that you have done well, I think you can head home now for a well deserved rest and possibly a little campaigning.

But be careful about telling the voters how hard you worked while you were here. One Maine Legislator did this, and he learned to regret it. The Legislator said in a speech at the local rotary, "We work day and night in Augusta, there are no lunches or dinners, we have to sleep on cots in the corridors. It is research and work and work and debate, all day, all night, and all weekend." After hearing this spiel, one day a rotarian got up and said, "By God, you have done enough for our State and Country, go home and rest, I am voting for the other fellow."

Have a nice trip back and I look forward to seeing you for a couple of days, possibly late in the next month. Thank you very, very much.
