Senator CARPENTER of Aroostook was granted unanimous consent to address the Senate On the Record.

Senator CARPENTER: Mr. President and Members of the Senate. Just briefly, it sometimes troubles me when persons with long traditions of State service, either retire from the public sector, or in this particular case, become less active in public service. I would like to make a couple of comments. Yesterday, my Committee had under consideration, the nomination of Justice Elmer Violette, to the position of Active Retired Justice. Justice Violette certainly is not just going to fade completely from the scene, but 1987 will be the first time in my memory as a Member of the Legislature and somebody who has followed State Government, that there has not been a Violette in an active, full time service to the State. While we may have some things to say later on today, about the other Violette, the present Junior Senator from Aroostook, I thought I would just make a couple of comments about the former Senior Senator from Aroostook, and present Justice of Maine Supreme Judicial Court, Elmer H. Violette.

We have all known and loved Justice Elmer Violette. I have known Elmer Violette for the past 12 years, at least, as a jurist, and I think in that capacity, he has conducted himself extremely well. Elmer Violette is a man of compassion. He is a man of dedication, who has thrown himself into his work on the Supreme Court, to a degree which probably, if the truth were to be known, it has, in fact, injured his health.

Justice Violette came before my Committee yesterday, and informed us that his health was not that great, and that was the reason he was asking to step down from the Supreme Court and accepting a nomination from Governor Brennan to be Active Retired status.

Elmer Violette, both as a State Legislator and a State Senator from Aroostook County, and later as a Member of the Bench, in two different capacities, has has been a truly outstanding credit, not only to his area of the State, his County, his name, his culture, but to the State. The fact that Elmer Violette is not going to be sitting on the Maine Supreme Judicial Court as an active member, is truly the States' loss. I just wanted to share that thought with you, this afternoon, as this little bit of history, if you will, passes from the scene. In an active status, I suspect we are going to see a great deal more of Justice Violette sitting in a variety of different areas, as an Active Retired Judge. I know, speaking on behalf of the Judiciary Committee, and I'm sure in behalf of the entire Maine Senate, we would wish him nothing but well, and we are very pleased that his health has stabilized to the point where he can continue in this Active Retired role. Thank you.

I rise today, not to voice opposition with the appointment of Jane Bradley to the District Count, but only to voice my disappointment that with the many practicing and capable attorneys in Hancock County, they have, once again, been overlooked in the process. I feel, very strongly, that Jane Bradley's credentials are satisfactory, and she is very well qualified for this position.

But, I think the people within this district deserve representation, at some time, on this Court. I therefore, even though I will be voting for this candidate, because I think she has exemplary experience, exemplary credentials, I do have reservations of the appointment, because I feel that the people in my area are not being whole-heartedly considered.
