#### Senate at Ease Senate called to order by the President.

At this point, a message was received from the House of Representatives, borne by Representative DIAMOND of Bangor, informing the Senate that the House of Representatives Concurs with the proposition for a Joint Convention, to be held in the Hall of the House, at 10:30, for the purpose of electing a State Auditor to fill a vacancy, effective March 27, 1987.

THE PRESIDENT: The Joint Standing Committee on HUMAN RESOURCES has recommended the nomination of Dr.

H. Rollin Ives of Falmouth Foreside as the Commissioner of the Department of Human Services be confirmed.

The pending question before the Senate is: "Shall the recommendation of the Committee on HUMAN RESOURCES be overridden?"

In accordance with 3 M.R.S.A., Chapter 6, Section 151 and with Joint Rule 38 of the 113th Legislature, the vote will be taken by the Yeas and Nays.

A vote of Yes will be in favor of overriding the recommendation of the Committee.

A vote of No will be in favor of sustaining the recommendation of the Committee.

Is the Senate ready for the question? THE PRESIDENT: The Chair recognizes the Senator from York, Senator Kerry.

Senator KERRY: Mr. President, Ladies and Gentlemen of the Senate. I would just like to comment, briefly, on the hearing of Dr. Ives. I fully intend to vote for Dr. Ives this morning as I Committee. I think that there were many hard questions asked of him. I think that it is also important that the people of the State of Maine and, in particular, this administration and the Senate prior to our vote, recognize that those who testified on behalf of Dr. Ives primarily were representatives of the health care provider industry. I think in recent memory, many of the previous administrators for the Department of Human Services or the Department of Mental Health and Corrections, many of these agencies that provide direct services to the most vulnerable of our society, and certainly of our State, and provide hundreds of millions of dollars of services to people. There was not one individual from the consuming community there. I think it was indicative of the fact this is a very important appointment and, secondly, I think it is very important that people recognize at a public hearing dealing with an important young nation of this matter we cannot often times determine what the Governor will do and what the goals and objectives of the administration will be. I think in fairness to Dr. Ives, he did a very good job and I would like to have one note of caution.

We must make sure that the consumers of health care services and many of the other services provided by the Department of Human Services pay attention to the needs of the consumers of this State. I think this is one point that was not brought up yesterday as resourcefully as it could have been, mainly because there were not persons there testifying on his behalf, in this particular community.

THE PRESIDENT: The Chair recognizes the Senator

from Cumberland, Senator Gill. Senator GILL: Mr. President and Members of the Senate. I would like to inform you all that among many question that were asked of Dr. Ives yesterday, were things that were brought out with the fact that he had met with many of the consumer groups and individuals representing those groups. I think that the Committee, in all, was very satisfied and was really taken by his background and, in fact, we felt he could get along with all sorts of people. He made it very clear to the Committee that his intentions were to work with not only providers through the Governor's office, but with the constituency that those providers took care of.

There are a couple of other things that were made clear at the hearing and questions have arisen of him divorcing himself for him former health care associates. That was brought out in Dr. Ives' testimony and by the Governor's office the fact that he no longer has any affiliation with any health care

provider. I think that the Committee was really very pleased with the caliber of the individual and I think in time, Senator Kerry will see that this person will listen to and take care of all other needs of the people of this State in good order.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Gauvreau.

Senator GAUVREAU: Thank you Mr. President, Men and Women of the Senate. I hadn't plan to address this distinguished Body this morning regarding the nomination of Dr. Ives, but I do feel that it is incumbent upon me to respond briefly given the tenure of discussion of Dr. Ives' nomination. I think that it is fair to say and the entire Committee was very impressed with the integrity and the intellect of Dr. Ives. He presents himself as a person who is truly sensitive to the needs of the different communities which will be and are served by the Department of Human Services. It is certainly our role in this Body to articulate the needs of this advantage population which are served by the Department of Human Services. I think what the Senator from York, Senator Kerry was eluding to is the fact that the providers of health care are in a position to make their views known to this Legislative Body, and in fact have not refrained from doing that in the past several years. On the other hand, other populations do not have the same voice and it is important that we keep their needs and their interests in mind.

My perspective is that Dr. Ives comes to his position not with any given ideological biases or prejudices. In fact, he does present as a person with an open mind who honestly wants to hear the concerns of all the parties served by the Department of Human Services. I look forward to establishing a strong working relationship with Dr. Ives but I certainly think that in the discharge of our duties and our Committee, we have to be mindful to the sentiments expressed by the Senator from York. I am confident that Dr. Ives will work with us in addressing the needs of all persons served by the Department.
