JOINT RESOLUTION

IN RECOGNITION OF THE BICENTENNIAL ANNIVERSARY OF THE TOWN OF WATERBORO

WHEREAS, it is not a nation's wealth in gold or silver that constitutes its finest asset, but its pioneers like John Smith and several others, who wrestled successfully with the land and aided others in doing the same at the birth of our constitutional government; and

WHEREAS, the march to wealth and greatness of the Nation began in communities like Massabesic Plantation, in 1764 under the proprietorship of Colonel Joshua Waters, to the echo of the woodman's axe along the Pequaket Trail, as lumbering became its

chief industry; and WHEREAS, from Old Corner to the heights Ossipee Mountain, a beautiful rural town was shaped in the wilderness and incorporated as "Waterborough" on March 6, 1787, an historic year for the town and the Nation; and

WHEREAS, typical of the courage, vision and tenacity of that community an enterprising farmer, Captain Josiah Swett, built a 40-ton schooner "Waterborough," high on the east side of Ossipee Mountain and with 50 yoke of oxen drew her on sleds to the sea in the winter of 1820; and

WHEREAS, a people who can build a town such as Waterboro, can tame and comb it, can lift its resources into forms to fill human needs; a people building such a town and a state we're proud to live in are the really rich possessions of this Nation; now, therefore, be it

RESOLVED: That We, the Members of the Senate and House of Representatives of this the 113th Legislature of the great and sovereign State of Maine, now assembled in regular session, take this opportunity to unite with citizens from across the State and Nation to congratulate the Town of Waterboro on its 200th anniversary and offer our continual support and encouragement for the future; and be it further

RESOLVED: That a copy of this resolution be transmitted forthwith to the proud citizens of Waterboro in honor of this special occasion.
