Senator USHER: Mr. President, ladies and lemen of the Senate. I would like to take a gentlemen of the Senate. moment to comment on the Bill before us, L.D. 199, "An Act Regarding the Land Use Regulation "An Act Regarding the Land Use Regulation Commission." This Bill has the unanimous support of the Energy and Natural Resources Committee, the support of the Maine Audubon and the Natural Resources Council, the support of the Paper Industry Information Office and the Maine Forest Products Council.

The Bill provides a rational means of dealing with holdover Commissioners whose terms expired. It is simply a good government Bill.

Beyond noting this strong support, I would like to note, for the Record, that the Bill in no way affects the existing law establishing staggered terms for LURC Commissioners. A series of Attorney General's Opinions and a substantial body of case law supports the position that, in the case of boards and commissions with staggered terms. "The beginning date of the full term is the date of the expiration of the preceding term, without regard to the time served by the holdover." I am quoting here from Attorney General's Opinion #79-82. I urge your

support. Thank you.
