THE PRESIDENT: The Chair recognizes the same Senator.

Senator ERWIN: Thank you Mr. President, Ladies and Gentlemen of the Senate. This amendment corrects an error that was made in reporting the Bill out of Committee. The Fisheries and Wildlife Committee, after much discussion, voted unanimous Ought to Pass with a sunset provision. This amendment puts that sunset provision on the Bill.

One of the reasons, after much discussion by both the Committee and the people in attendance, of doing this is that it was brought out that in the field of guiding there are many areas where there are some serious problems. The Committee is putting together a request for a work study this summer with the obligation of reporting back in January a Bill to correct some of the errors that we have in the field of guiding. I repeat that this was a unanimous Ought to Pass Report of the Committee of Fisheries and Wildlife.

THE PRESIDENT: The pending question before the Senate is PASSAGE TO BE ENGROSSED AS AMENDED.

The Chair recognizes the Senator from Franklin, Senator Webster.

Senator WEBSTER: Mr. President, Ladies and Gentlemen of the Senate. Very briefly, I have several concerns about this legislation. I understand that it is an unanimous Committee Report, but with my concern, I would like to address a question to the Chair or any Senator who might answer.

question to the Chair or any Senator who might answer. The way I read this Bill, first, I would question whether the Bill is necessary, but assuming it is, the way I read this Bill, if I, being a scout master, decide that I want to take twenty-four boy scouts on a trip up to Moosehead Lake and I have eight parents with me and I decide, first of all, not to hire a guide, I am alright, the way I understand this law from looking at the legislation currently on the books.

My concern is that if I am really concerned about safety and I hire a guide to take twenty-four students and eight parents, I can't hire one guide I have to hire three. I guess I question whether that is a good idea. I understand that is a problem, I am very familiar of a particular case that happened up at Moosehead Lake last year, but I am concerned that we shouldn't pass legislation here in a hurry unless we know what it is doing and I don't think this Bill addresses the concern that are out there. I would question the needs of this Bill and I would like to have the question answered as to whether I can take twenty-four kids and eight parents on a trip without hiring three guides. That is my question. Thank you.

THE PRESIDENT: The Senator from Franklin, Senator Webster has posed a question through the Chair to any Senator who may care to respond.

The Chair recognizes the Senator from Oxford, Senator Erwin.

Senator ERWIN: Mr President, Ladies and Gentlemen of the Senate. I am sure that most of you are aware this is my first year as serving as Chairman on this distinguished Committee and I don't pretend to be an expert in this field. There are many areas and differences and services where a guide is required. If I understand the question, we have twenty-four students, students, not boy scouts. If they were boy scouts we have a rule that, I think, the limit is eight. If we take another category of students and eight parents we have thirty-two people. Again, I repeat, I am not an expert on this and don't pretend to be, but if the distinguished Senator from Franklin County, Senator Webster, would like I would get a written opinion on this matter and present it not only to him, but to this distinguished Body. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Webster.

Senator WEBSTER: Mr. President, Ladies and Gentlemen of the Senate. Previously, the good Senator from Oxford, Senator Erwin, stated that he is going to request a study on this issue and it would seem to me that when we do have a study it is

authorized so perhaps he can address this matter then. My concern about this, and I have a number of them, but my main concern and I spoke to Mr. Mackey who is the Legal Counsel to the President, and he indicated to me that this is a very gray area in law. My concern is that we don't pass something until we know what we are doing.

I would hope that we would either Table this Bill or I will vote against it. It is totally up to the Members of the Body what they want to do, but I am not going to support this until I know what it does and if it is necessary. Mr. President, I request a Division.

THE PRESIDENT: The pending question before the Senate is PASSAGE TO BE ENGROSSED AS AMENDED.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Pearson.

Senator PEARSON: Mr. President, Men and Women of This is not an unusual Bill, but it is the Senate. an unusual situation. This Bill has money on it and normally would go on the Appropriations Table. I am not asking you to do that, I am asking you to Pass this today, but I wanted to tell you why we are doing that, which is very unusual. It is \$14,000 and it is money for a filing system so we can record liens on agricultural products.

For example, if a potato farmer had a lien on his potato crop that lien would be filed in a central place in the Secretary of State's office so that anybody who is going to loan money would know that there is a lien on the crop and that sort of thing. The problem was that when this was enacted last year, there was a sunset put on the language that has expired, so we are in an unusual and awkward situation. What I am saying to you is that the law has lapsed and we need to put it back on the books.

This being an Emergency Measure and having received the affirmative vote of 27 Members of the Senate, with No Senators having voted in negative, and 27 being more than two-thirds of the entire elected Membership of the Senate, was PASSED TO BE ENACTED and having been signed by the President, was presented by the Secretary to the Governor for his approval.
