THE PRESIDENT: The Chair recognizes the Senator from Washington, Senator Randall.

Senator RANDALL: Thank you Mr. President, Men and Women of the Senate. This morning, I bring to your attention this amendment. I do so because of a recent action on this and a very, very close discussion, in fact a tie discussion recently. I am not an expert on taxation nor have I ever been

involved with the Taxation Committee. It was one of my aspirations when I came to Augusta thinking of what choice of Committee would be to want to focus on the the taxation issues, but I have been involved in other committees and have found them to be very exciting and stimulating.

This morning, however, I would like to address this motion. The amendment allows local governments to decide where the Declaration of Value form shall be disclosed. This does not, in any way, affect the purpose of the initial Bill.

It simply would allow a local municipality to choose if they want to offer this information through their local tax assessors or if they would prefer that the information be available at the County Registry of Deeds office. So, this is allowing an option to municipalities. I think that this particular piece of legislation comes with very solid support from the Committee where it was heard.

As I say, it was just recently brought to my attention through other discussions and, today, I would like to have it at least brought to the attention of the Members of this Body, that there is an opportunity here to allow local communities to decide if they should like to keep these records at the local municipal level, or if they would prefer to send them over to the County Registry office. is simply all this amendment deals with. That

I know you will hear much discussion of a variety of things, as this issue is discussed, but the purpose of this amendment, if I may just reiterate it one more time, and if you look at the Statement of Fact for just a brief minute. It allows a local government to decide where the Declaration of Value form shall be disclosed. Now, as a Senator from Washington County, I represent almost 40 Some of those communities are large and communities. some are small. Assessors are often times just part time positions in the smaller communities with a minimal reimbursement. They now have this record on file. What we are simply doing is allowing the municipality to say "Well, I would prefer that you check out this information at the County Registry of Deeds office rather than my having to tell this to you here locally." So, it is allowing the municipality to decide and not to second guess how this legislation is to be interpreted, but I guess that many larger municipalities would be more than willing to have this available right at the local assessors office. But, for some of the smaller communities, it might, indeed, be more accessible, if it were in an office that were opened on regular business hours rather than trying to catch a part

time assessor and have that information there. So, basically what this amendment allows is the option of local choice. Many times, as we are here in Augusta, we come under the influence of our lobby groups. I tend to do that myself. I tend to hear from the individuals in the halls and this is the way people think. I think if we remember all of those people that we talk with as we campaign around our districts, we would remember that there is some concern out there for having local control and having the option for local control. I think this is just one small instance where we can provide that option for local control without a great deal of expense and without a great deal of confusion and still not detract from the legislation in any fashion. Thank vou.

Senator TWITCHELL of Oxford moved the INDEFINITE POSTPONEMENT of Senate Amendment "A" (S-14).

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Theriault.

Senator THERIAULT: Thank you Mr. President and Members of the Senate. I wish to say that I hate the original Bill with a passion, and I hope I have an opportunity to vote against it. I equally dislike this amendment. I feel that if this information is available at all, it should be available to all. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Washington, Senator Randall.

Senator RANDALL: Thank you Mr. President, I request a Division.

THE PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Twitchell.

Senator TWITCHELL: I would like to give you some reasons why I oppose this amendment. When a person goes to the Registry of Deeds office, he brings two forms with him. You have a form that is called a Declaration of Value form. One form is filled out and sent to the Bureau of Taxation and one form is sent back to your local town assessors. The Registry

of Deeds office has no sales information whatsoever as to the price that is on this form. Therefore, over my way, I live out in a rural area and you have to travel hundreds of miles, sometimes, to the County building to find out all of this information. Sometimes you even have to hire a lawyer to find out this information, it is costly. Almost everybody at the hearing was for this Bill. It does speed up the process and I hope you will go with my motion to Indefinitely Postpone this amendment.

Senator BALDACCI: Mr. President and Members of I would hope that there would be just a the Senate. little bit of discussion on this particular issue before we pass this Bill to be engrossed. It is my understanding that, as the law stands now, if I bought a house, that transaction would be recorded at the Registry of Deeds and that information would be sent to the local town assessor for the purposes of assessing taxes. The way this Bill is drafted, it would allow that information at the assessors office to be made public.

I recently bought a house, last May. I feel that information of that particular sale is a matter between the buyer and the seller, between the attorney and the assessor. I was reading the Bangor Daily News this morning, and I noticed there is a big page here called Real Estate Transfers. On that page of transfers, it talks about everybody that has changed property conveyed to so and so, and on what particular date. There wouldn't be too much of a problem to put the sales price of that house next to it. That bothers me because I do not think it is more than a gossip column because right next to it they have the court news. Then right next to that they have the police beat. I don't think that it is anybody's business what the people that are involved in making those big purchases of how much it was. Now, if there are requirements that are on the books at the federal level or at the state level that make it necessary that they have this particular information to do a proper job of appraising them, I stand to be corrected. The fact of the matter is, Т think the system that is in place now is good. I don't see any problem with it and I would hate to see this law become in effect in the State of Maine. Mr. President, I request a Division. Thank you.

Senator THERIAULT of Aroostook moved the INDEFINITE POSTPONEMENT of the Bill and Accompanying Papers.

THE PRESIDENT: The Chair recognizes the same Senator.

Senator THERIAULT: Thank you Mr. President, Members of the Senate. First, I wish to apologize for the confusion that I caused yesterday. What happened was that I signed the wrong jacket so it was my error. What I have done for the last two days indicates that we can inadvertently make some errors and this is what happens, quite often, when someone passes a school bus. There are a number of reasons which exists why someone could pass a school bus. The first, and probably the most important, reason is that the school bus driver does not proper alert the traveling public of their intentions to stop. Another reason is the weather conditions much be such that it is impossible for you to stop or even visibility could be so limited that you are not aware of a school bus ahead of you.

Probably the most common reason why someone would pass a stopped school bus is because they are probably day dreaming, and I am quite familiar with that, personally, because I travel around three hundred miles one way every time I come to the capital. There are many times that I am wondering why I haven't gone through Ashland yet and the reason is that I have already been through Ashland. This happens, I'm sure, to all drivers at some point in time. I am sure that does not, in itself, make a criminal nor does it make anyone who inadvertently passes a school bus a criminal. I don't think our laws should treat that as though the offender is a criminal. We would be criminals to do so.

I think that the present law on the books is sufficient to alert us that it is not proper to pass a stopped school bus. In addition to that, the judge has certain discretion in assigning a penalty or fine. Presently, the judge can fine you from anywhere to \$50 to \$500. In addition to that, the Secretary of State has the authority to suspend your license for whatever reason they might have such as repeat offense or whatever. I am quite sure that most people that pass a stopped school bus do not do it intentionally. To illustrate, I know of at least two incidents where the people that are most concerned with the enforcement of these laws and most concerned with setting the proper example, like State Troopers, have passed a stopped school bus. One happened quite recently another one happened a few years ago in the St. John Valley, and that one was a fatality. It does happen and it is not because it is intentional. Consequently, I think that the penalty should be such that for those individuals that inadvertently without malice or without intent pass a stopped school bus should be handled more gently then those who do it intentionally. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Sagadahoc, Senator Cahill.

Senator CAHILL: Thank you Mr. President, Men and Women of the Senate. The reason a school bus is yellow is a warning and it is a warning for all drivers that might not be as attentive as they should be. It is a warning sign, a sign to wake up, to realize, to expect that maybe the unexpected will happen. That is why a school bus is bright yellow. Very briefly, this Bill would make the penalty reflect the severity of the crime or the traffic infraction. The State Police testified that next to OUI, they feel this is the most severe of traffic infractions.

On motion by Senator CAHILL of Sagadahoc, supported by a Division of at least one-fifth of the Members present and voting, a Roll Call was ordered.

THE PRESIDENT: The pending question before the Senate is the motion of Senator THERIAULT of Aroostook, to INDEFINITELY POSTPONE the Bill and Accompanying Papers.

A vote of Yes will be in favor of Indefinite Postponement.

A vote of No will be opposed.

Is the Senate ready for the question?

The Doorkeepers will secure the Chamber.

At this time, the Chair noted the absence of the Senator from Androscoggin, Senator GAUVREAU and further excused the same Senator from today's Roll Call votes.
