Senator KANY of Kennebec, moved that the Senate ACCEPT of the Majority OUGHT NOT TO PASS Report.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Dillenback.

Senator DILLENBACK: Thank you, Mr. President. Mr. President, Ladies and Gentlemen of the Senate. It is always a pleasure to speak to the Senate when you have a Bill that you know is not going to pass. However, I feel that this has to be defended. We had a Bill previous to this, for seven days prior to election, in Legal Affairs that we did not pass. We thought that it would be an impossibility. On this Bill, it is only one day. If you have spoken to your town clerks or registrar of voters, you will find that they would be delighted to have this Bill.

There really isn't a great problem during normal elections, but when we have a referendum or an election where there is a great deal of controversy. You are apt to have bus loads arrive on the day of election. Then there are special elections and they cause problems. It just seems to me that the average person should have enough discipline to be able to register at least one day before an election. It doesn't seem to make sense.

The University students and speciality groups all rush in on the day of the election. I don't think it is right. That is the only position I have to take on this. This, as you see, is a partisan vote and I respect your decision. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Pearson.

Senator PEARSON: Mr. President. Men and Women of the Senate. This particular Bill has been around for a long time. It always intrigues me as to why anybody would want to put any obstacle, except for the legitimate residency requirement and this type of thing, and age requirements, any obstacle in the path of a voter. Why is it so wrong to allow somebody to register and vote at the last minute? That is better than not doing it at all.

I know that the town clerks, city clerks, registrars of voters are inconvenienced by people who come in at the last minute. But, that is their job. If there is a little inconvenience that they have to put up with in order to further the ends for democracy, then I would say they will just have to put up with it. I have never understood the argument that says they don't want people to register on election day, or the day before, or the day before that. I expect, and I haven't read this Bill, but I would expect there is an exception for the person who has a birthday on that day, there usually is on those kinds of Bills.

You know, we have a deadline that takes place today, on people who want to keep their license plate. I was talking to one of the members of the other body, yesterday and he said there was a long, long line of people down here at the Augusta Motor Vehicles Department, at least a half hour long, to do that. It is human nature for many of us to put things off until the last day. But, that doesn't mean that it makes it any worse.

THE PRESIDENT: The Chair recognizes the Senator from Lincoln, Senator Sewall.

Senator SEWALL: Thank you, Mr. President and Members of the Senate. I stand to support my colleague, Senator Dillenback, this morning and to explain to Senator Pearson why, exactly I am doing that and why I would want to put an obstacle in the registration to vote that day. Back several terms ago, Bath was in my district and I campaigned door to door and knew the area pretty well. I carried Bath, I think, by three votes as part of my district. After the election, I went and looked at the new registrations, those people who had registered on voting day. I noticed there were a lot of people living at a particular address, that registered on voting day. There were twenty plus new registrations at one home address. It was out by Hyde School, so I assumed, of course, that these people were connected with the school in some way. Perhaps teachers or something of that sort. But, that was not the case. I went and I found the house where these twenty plus people registered. It was a one bedroom residence with one person living in it. I was dismayed by this. I figured that these people had all voted, and I knew they had all registered and they had voted. So, I went back to the clerk and asked if they had checked with these people, and was told that yes, they had all given this one residence in this one bedroom, small house, twenty plus people.

I went back and checked and there was no record of these people. On election day, it was too late to do anything about it. They had registered, the clerk didn't have a chance to check where these people were, where they came from and where they actually lived. The election could have been changed by that. A lot of things could have happened. People could have won and lost elections, and I do not think that is in the best interest of the public and that is why I am supporting Senator Dillenback this morning.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Kany.

Senator KANY: Mr. President and Members of the Senate. Of course, fraud is a crime and that is the way it is, and very few, if any people have ever been convicted in this State for election fraud. I thought it was kind of important to remind people of that. We do have a State where we have people take great pride in voting and in their voting integrity. We do have a grand tradition in this State of trying not to disenfranchise anyone who may have, either moved before or people are often dropped off voting lists for various reasons, whether they have moved within a municipality or whatever.

I think it would be a shame if that person who was dropped off of a voting list, went to vote on an election day, if they could not re-register. I entirely agree with the Senator from Penobscot, Senator Pearson, and I, too, believe very strongly that we make our laws not for the convenience of the government workers at any level, but for our citizens. I encourage you to go along with the motion before you, which is the Majority Ought Not to Pass position of the Committee.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Dillenback.

Senator DILLENBACK: I am glad the Senator from Kennebec, Senator Kany, brought up fraud because

there has been instances where this has happened. Do you think the volunteer who goes to you small town and counts votes, is going to go to court, that the person they gave the ballot to was a person that they

are claiming is creating the fraud. This has happened. The people say "No way, I couldn't be sure it was the same person, a thousand people went by me and I couldn't prove that they created fraud or not." Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Matthews.

Senator MATTHEWS: Mr. President, fellow Members of the Senate. I will be very brief, but there are times that as a State Senator, I find myself shaking my head about the issues that we seem to deliberate on in this Legislature. I did a little checking and I really wish I didn't have to say this, but I feel it is important enough to mention on the floor of I did a little checking about the this Senate. report out of the Committee. It seems that all of the Democrats are against this Bill and the distinguished members of the other party wanted to deprive people the right to vote on election day. There is an issue here, ladies and gentlemen, and that is the Constitution. The very corner stone of that Constitution is the right for citizens to vote. Putting obstacles and denying people that right, denies them the very liberty of citizenship in this Country.

This should not be a Democrat issue and it shouldn't be a Republican issue. It has been in my tenure in this Legislature, over and over again. The countries that wish to deny their citizens the right to vote and participate are all countries we all know very well. Countries who do not believe in the rights of democracy as we do. I have traveled throughout my district in three elections, have gone door to door in all three, and I can tell you that I have met many citizens that for the first time, want to find out what the procedure is in voting.

Yes, there are citizens out there that are not as enlightened as some Members of this Body, that wish to participate and have been motivated to do so on election day. What is wrong with that?

I would just like to read a little quote here, and it taken from Lyndon Johnson. It dealt with another issue of the right to vote. In 1965, a speech on the Voting Rights Act. All of you people in this Body, I am sure are acquainted with the Voting Rights Act. " Many of the issues of civil rights are very complex and most difficult, but above this there can and should be no argument. Every American citizen must have the equal right to vote, there is no reason we can excuse the denial of that right. There is no duty which weighs more heavily on us then the duty we have to insure that right." That is the issue here today, insuring the right of the citizens to vote in this this great nation of ours. I will be voting against this Bill very, strongly to insure that right. Thank you. verv

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Clark.

Senator CLARK: Thank you Mr. President, Men and Women of the Senate. The pending motion is to Accept the Ought Not to Pass Report from the Joint Standing Committee on Legal Affairs. Many of us who

have served here, in the years past, have been around this before. Those of you who are new with us this year, could have heard the same words you are hearing this morning in earlier debates. As a matter of fact, last evening I spent some time going through some files to research the editorials in Maine's papers and found one, the latest being March 17, 1987, from the Gannett Press that is entitled, "Voting, Keep it Simple". They would suggest that there is no good reason why Maine's law allowing voters to register right up and including election day should be repealed. The majority of the

Committee on Legal Affairs concurs. I think it is particularly unfortunate that the signers of a Committee Report come down on either side of the political aisle. That is how it has been in the past, and that is probably how it will be in the future.

This side of the aisle, has voted consistently to retain voter registration privileges for Maine citizens on election day. There is no documented, wide-spread abuse of the system and those of us who serve in public office have an inherent right to pursue any allegations that would support abuse of this privilege of voter registration. Whether or not one is a volunteer or not, and I would submit that there are no volunteers who register voters nn election day.

There are election wardens, town clerks, registrars of voters and or people whose names have been submitted by both political parties and who have been called to the polls to work the polls. They earn the might sum of a minimum wage that day, they They are not volunteers and they have a job to do and there are times in some communities in our State that I acknowledge that it may be inconvenient as people line up to register to vote.

Maine ranked first among the states, and I quote from the editorial on March 17, 1987, "in terms of the percentage of the voting age population, which turned out for the 1984 presidential election, it is entirely probable that the election day registration law contributed to that record. The Maine system works, in short, by making it as easy as possible for citizens to qualify to vote." While the system, as we acknowledge, may sometimes cause headaches for our town clerks, registrars of voters and other local election officials, the problems are still not overwhelming. The bottom line is that election day registration ought to be framed and is currently framed to encourage the widest possible participation. Maine's current election day registration law does just that. It is as simple as that and we, this Body, this morning, would be wise to preserve it. Join with the Majority Report and Accept the pending motion of Ought Not to Pass. Thank you Mr. President.

THE PRESIDENT: The Chair recognizes the Senator

from Hancock, Senator Perkins. Senator PERKINS: Mr. President, Ladies and Gentlemen of the Senate. I think I, like the good Senator from Cumberland, have heard this song before. At each time it has been, I guess, the ogres of my party who have been blamed for disenfranchising or whatever happened to be the case at each point. I am not sure that is the case and I would have to differ a little bit from some of the excerpts that have been used by my good friends today. Because when one becomes disenfranchised there are manv methods to approach that. If my vote is nullified by someone's vote who is ineligible, I disenfranchised. If the count is added or delete am If the count is added or deleted by disenfranchised. someone whose vote is ineligible, they are disenfranchised. I think that is the approach that the Minority Report is taking here today.

Each of us got and retained our seats here by the elective process. So we were interested in getting as many votes as were our opponents. So, therefore, each of us are interested in getting votes and we are not interested in turning any of them away. The wars have been fought the laws have been made and whether you reject to a court ruling and you appeal it, or whether you reject to a school ruling or a tax assessment, there is a time frame within which you must act. The Senator from Cumberland referred to this as being a discipline and it probably is. I,

for one, am in an area where there are many people who for one reason or another have crops and are transient, I have enjoyed the plurality in that district and of course hopeful that those who transients would perhaps support me.

I can't tell, but if they are transient and they are registered in another municipality and find themselves on election day there, I will make every effort to do that under the existing laws. In my area, many of the clerks have expressed the exact concern the Senator from Cumberland expressed here today. I find it a little difficult to accept the abuse or, perhaps, the charge that we are not as tolerant or not as interested in votes as the other. I just ask you to consider that to be disenfranchised works many ways. If yours is nullified by someone's whose isn't, then that is just as bad a disenfranchisement as the one who is turned away because he wasn't there in a timely manner to register.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Clark.

Senator CLARK: Mr. President, when the vote is taken, I would request a Rc11 Call.

THE PRESIDENT: A Roll Call has been requested. Under the Constitution, in order for the Chair to order a Roll Call, it requires the affirmative vote of at least one-fifth of the Members present and voting.

Will all those in favor of ordering a Roll Call, please rise in their places and remain standing until counted.

Yesterday, at the Augusta Civic Center, three different Committees heard three different Bills dealing with millions of dollars of concerns. One of them was to increase revenue sharing to local municipalities from 5.1% of all the sales tax and income tax that we now have added into our formula to 7% because of the municipalities losing money and heavy reliance on the property tax.

Another Bill was increased aid to education, chaired by Senator Estes, of York and another Bill was on an increase in circuit breaker on property tax for elderly people in the State. All of those Bills were very important Bills. All of them carried a heavy price tag. People came from all over the State, elderly people, town managers, members of town council, superintendents of schools for those three hearings.

Today's newspaper, the two major newspapers in the State, carry articles on the following: The biggest articles are on the lobster plate, the other biggest article that I have seen in the papers this year, while we have been in legislative session, is on the so-called "Cat Bill". When I go home, people say to me, "Don't you have anything better to do down there than..." and then they will say this and that. As though that were the only thing we were doing here. Now, I notice in the Chamber there is one member of the press, a very able person, as a matter of fact, I think we are blessed with a lot of able people. If not the reporter it is the editorial policy of the papers that bother me.

They are getting the information from these people who are assigned here, but they choose to put on the front page of the paper the lobster plate all the time in my area. The other day the Cat Bill, as though we have not done anything else and are not considering anything else. People back home really think that we are not doing anything else down here except addressing those kinds of Bills. I don't mean to say those kinds of Bills are not important, because they are, but in perspective there are a lot of other Bills that ought to have some play in the paper too. Bills that have far reaching consequences that they have chosen not to put on the paper. I think while their criticism of us and that we could do a better job is well taken, I think that they could do a better job too. Thank you.
