THE PRESIDENT: The Chair recognizes the Senator

from Aroostook, Senator Theriault.

Senator THERIAULT: Thank you Mr. President, first of all, I would like to request a Division. Mr. President and Members of the Senate. It was extremely difficult for me to oppose my good Chair, the Senator from Kennebec, Senator Dow, and also to oppose my good Transportation seat mate, the Senator from Sagadahoc, Senator Cahill, but I felt compelled to oppose it. I would like to explain to you as to why I did. Of course, on the surface, it seems like a very safe position to vote for this Bill because it seems that you would satisfy all concerned, those that want the lobster plate and those that do not want the lobster plate. But, there is more to it than this. First of all, I want you to understand that if we do vote this Bill in, it means that we would have to come up with an additional \$800,000 up front, right now, in order for us to stamp lobsterless plates. In addition to this, it would mean that we would have to retain nine temporary employees that were hired for this plate issue, we would have to retain them for an additional year or

I also want you to understand that, up to this point, we have spent approximately \$800,000 in the purchase of materials for the lobster plate. Now, some might argue that we will get this money back, this may be true, and there is also a possibility that the state could make a slight profit and this might be mentioned also. But I want you to understand that this money might come to us over a very long period of time. We are also making an assumption that we will get our money back if there are enough individuals interested in purchasing the lobsterless plate.

Also to note is that regardless of whether this Bill is passed or not, every individual that will be getting a vehicle registration will be getting a lobster plate, initially. It is only after a period of one year, the first of July, 1988, that the choice becomes effective and at that time you could get a plate without a lobster. So, consequently, everybody will be issued the lobster plate at least once.

To carry this a little further, I consider myself the pothole expert of the Senate. Of course, it is self proclaimed and I want to explain why I consider myself that way. First of all, I travel the furthest of anyone to the Capitol. Secondly, I am from Aroostook, and being from Aroostook I want to tell you that I feel that I have met more potholes than anybody else in this Chamber. I am sure that my good friend, the Senator from Washington County would probably want to claim that title also. I want to begin by telling you what I consider a pothole. pothole is a hole in a road that is of significant magnitude to be able to permanently dent a wheel on your vehicle. Now, there are times when I travel the three hundred miles to the Capitol, that the time doesn't go by very fast. There is some dead radio space where I can't get a station, I have tapes which tend to put me to sleep. So, consequently, it is dangerous to listen to those tapes so what I do is I count potholes.

I would like to explain that a little bit. there are more than ten potholes in ten feet of road distance, I consider that one pothole. On the trip down here it has been averaging out about to one hundred potholes per mile. Now, carrying this a little further, I did a little research and found out that it costs approximately fifty cents to repair one pothole. If you carry the mathematics a little further, if we devote this \$800,000 towards repairing the potholes in this state that we could repair the potholes on approximately sixteen thousand miles of road. If I remember correctly, we have about twenty

one thousand miles of road under the state care. Consequently, this would be three quarters of all the potholes in this state that could be repaired if we use that \$800,000 to repair the potholes.

To carry this a little further, we have had serious flooding conditions in this state, yesterday and last evening. Maybe that \$800,000 could be spent on replacing or attempting to replace a bridge that might have fallen in. So I ask you, in closing, what is more important? To spend \$800,000 on a lobsterless plate that we could really do without, or to try to fix the potholes that we have in this state? Thank you.

THE PRESIDENT: The Chair recognizes the Senator

from Sagadahoc, Senator Cahill.
Senator CAHILL: Thank you Mr. President, Men and Women of the Senate. You will be pleased to know that I do not consider myself a pothole expert, but after this mornings ride to Augusta of thirty five miles, it took two hours and thirty minutes, I have become an expert on back roads. I do appreciate the courtesy the Senate extended to me yesterday, when I tried to make it home from Washington and was delayed in an airplane. I am glad to be back in Maine and I am glad to be standing in the Senate today.

I would like to tell you that when the Legislature voted on the lobster license plate Bill last year, I was one of five descending votes from the other Body, so I have not changed my position on the Bill. I agreed to be a cosponsor not because I am an anti-lobster person, as many of you know, I live in Sagadahoc County and Sagadahoc County has a good deal of fisherman and lobstermen there, I am not anti-lobster, I enjoy lobsters. I agreed to cosponsor this Bill because of the dozens of people that have either called or written to me to express their displeasure of having to put a lobster on their license plate. It made me think that maybe this Legislature made a mistake last year and just maybe this Legislature got caught up in the enthusiasm of those wonderful school children from Saco, and I commend those wonderful school children from Saco. I think they did an outstanding job with their lobster license plate campaign. But just maybe we got really caught up in their enthusiasm and passed the legislation without really thinking about it. would like to bring it to your attention that this Bill, or the Minority Report of this Bill, before you now does not take away the lobster plate, but instead gives the people of Maine a choice, whether they prefer a lobster license plate or a lobsterless license plate. It is an alternative, it will become effective after July of 1988.

It raises in revenue \$960,00 of projected revenue and an expenditure of \$760,000 for a net increase to the highway fund of \$200,000 and my district today could use \$200,000. I have heard a lot of people say that this is a frivolous piece of legislation and I have to tell you, as you all know, it doesn't effect state policy a great deal, but it has been fun. Whenever an issue draws as much attention as this issue has drawn from the public, the dozens of letters, the dozens of phone calls which I have received and I know you have received, we cannot call that frivolous. Many people called or wrote to me that would never write to me on another issue and when we involve that many people in the legislative process $\, I \,$ say, "good for the Legislature and good for the people of Maine."

THE PRESIDENT: The Chair recognizes the Senator

from Aroostook, Senator Ludwig.

Senator LUDWIG: Thank you Mr. President, Ladies and Gentlemen of the Senate. With your permission, I would like to read a letter which I sent to one of

the students from Saco, following his request that I vote to kill L.D. 47. I am sure you all received similar requests.

Dear Seth, Thank you for writing to me regarding your concern for L.D. 47. Although I was not a member of the Legislature when you and your school mates did such an effective job of lobbying the law makers to put a lobster on the Maine license plate, we have all heard about it. You are to be commended for learning and for following the democratic process and should not be offended by a chance to learn even more about it. The fact is, no laws are set in stone, with the possible exception of the Ten Commandments. In fact, the vast majority of Bills which come before the Legislature, would not create new laws but seek to amend laws which already exist. Some laws are created to help certain segments of society and it is only after they have been around for awhile that other segments of that same society realize that they are being harmed by the law and seek to amend it so it may more accurately reflect the needs of society as a whole.

As Members of the Legislature, we are responsible for responding to the reeds of the people in the districts we represent. When our constituents feel a law has been passed which does not represent them, or seems to benefit one area of the State at the expense of another, they tend to resent it and seek to amend that law. That is exactly what happened in the case of L.D. 47. Like its sponsor, Representative MacBride, I come from Aroostook County. Given the choice, it is safe to say that for the people in our area they would have preferred a potato or a tree on their license plate, given a choice. Although, we have nothing against lobsters, per se, we often cannot afford them and we feel no particular infinity for them. In your letter, Seth, you spoke of working very hard to get, "a more representative license plate for Maine", but in all fairness I must ask you if a lobster truly represents the entire state, or just that portion of southern and coastal Maine, most frequented by tourists.

At a time, when many good people are working hard to unite the two Maine's does not the lobster focus even more attention on the prosperous part of the state while depriving the other Maine of its share of publicity. The people who were responsible for L.D. 47 are not asking that you remove the lobster from your license plates, they are merely saying, there is more to Maine and we do not feel the need to add anything to a license plate which already shows the rest of the world that we are proud to live in Maine. Thank you.

JOINT RESOLUTION MEMORIALIZING THE MEMBERS OF THE UNITED STATES SENATE TO VOTE TO OVERRIDE THE PRESIDENT OF THE UNITED STATES' VETO OF THE FEDERAL HIGHWAY LEGISLATION

WE, your Memorialists, the Senate and House of Representatives of the State of Maine in the First Regular Session of the One Hundred and Thirteenth Legislative Session, now assembled, most respectfully present and petition the members of the United States Senate, as follows:

WHEREAS, President Reagan vetoed \$88,000,000,000 federal highway bill passed by the United States Congress which would have provided the State of Maine with badly needed funds; and

WHEREAS, of the \$60,000,000 earmarked for Maine, \$25,000,000 has already been committed leaving a critical need for the remaining \$35,000,000 for 125 projects statewide which are threatened by the President's action; and

WHEREAS, the \$35,000,000 generated for Maine under this legislation must be received in time for Maine's short construction season, which work may not be possible if delayed further; and

WHEREAS, the United States House Representatives recognizing the plight of the states overrode in a bipartisan fashion, the veto by a vote of 350 to 73 and now the matter is up for final vote in the Senate; and

WHEREAS, yesterday, April 1st, the State of Maine was hit by record-breaking flood waters causing the Governor to call the State of Maine a disaster area that decommissioned numerous roads and bridges causing millions of dollars in damages; now, therefore, be it

RESOLVED: That We your Memorialists, do hereby respectfully urge the Senate of the United States Congress to vote to override President Reagan's veto of the Federal Highway bill so that this State can recover its roads and highways from its worst flood disaster of the century and to permit the start of the state highway construction program as planned which is otherwise in serious jeopardy; and be it further

RESOLVED: That suitable copies of this Memorial, duly authenticated by the Secretary of State, be transmitted to the President of Senate in the Congress of the United States and to each Member of the Maine Congressional Delegation.

Which was READ.

THE PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Webster.

Senator WEBSTER: Thank you Mr. President, Men and Women of the Senate. First I would request a Division on the Adoption of this Joint Resolution. Before we vote on this matter, I would like to bring out a couple of points. About one hour and a half ago, the Legislative Council met to discuss allowing this Resolution in. At that time, it was brought to our attention that a vote was being taken in Washington at 11:00, which is five minutes ago, on this matter. The intention of the Council and the intention of the sponsors, at that time, was that we would allow this Resolution through so it could be passed and sent onto Washington.

It seems to me, at this point, that this Resolution and the idea of this Resolution are frugal

since the issue has already been debated and voted upon in Washington. I would suggest that perhaps you might not even want to consider this at this time. Thank you.

> Senate at Ease Senate called to order by the President.

The President requested the Sergeant-At-Arms to escort the Senator from Cumberland, Senator CLARK, to the Rostrum where she assumed the duties as President Pro Tem.

The President then took a seat on the floor of the Senate.

Senate called to order by the President Pro Tem.

THE PRESIDENT PRO TEM: The Chair recognizes the

Senator from Penobscot, Senator Pray.

Senator PRAY: Thank you Madam President, Ladies and Gentlemen of the Senate. The issue that is before us, at this time, and the arguments that have been made by the Senator from Franklin, Senator Webster, that the issue has come and gone, in reality has not taken place. Very similar in Washington, as it is here in Maine, when sometimes you schedule something for a specific time, the clock seems to stand still. I have been in communication with Washington a couple of times, this morning, and just a few minutes ago from the Rostrum, itself, and they have not yet taken a vote in Washington. It is still an issue of importance to the people of this state and we still have an opportunity to let those who represent us in Washington, to understand significance of this particular issue. Resolution before you, clearly is aimed at the United States Senate, who have the opportunity to provide us with a highway funding package which is very important to this state. Very important because the issue is now before them for us to say or feel in some way that by the United States Senate not voting to override the veto that the President could put another proposal before the members of Congress and that proposal would be passed in a matter of days, is not as assured as a vote to override the existing proposal that is before them. This Resolution is very specific as to the implications that it has for the State of Maine. The financial impact of our state and we are well aware particularly because of the natural occurrence of events in the last few days of the conditions of our highways.

On the previous Bill, the Senator from Aroostook, Senator Theriault, for a while discussed potholes and talked about the conditions of the highways in the state. I think that it is very important that we have this and we have it at this particular time. This Resolution is not aimed in a partisan fashion, I was disappointed that the vote of the Council broke down along party lines, but I feel there is a misinterpretation by those of the other side of the aisle that it was a partisan attempt. It is not, we think that the highway situation in this State is paramount to the problems that are being addressed by the Governor that we presently have. Governor McKernan has stated that economic development is a main thrust of his administration at this time, part of the economic development strategy of this state is going to clearly include the infrastructural needs of our state. Those infrastructural needs cannot be delayed any further then they presently have been. There is a great deal of need out there from Madawaska in the north, Kittery in the south, Bethel

to the west all the way to Calais to the east. I am sure, before this Session is over, we will hear more about the latter route which I just referred to. I hope at that time the Senator from Franklin, Senator Webster is standing up advocating the passage of such highway proposals and programs.

The issue is paramount and we have to act now, we have to send a message to those who represent us in Washington, those in the United States Senate that we need this Bill. I would hope that we could send a very loud and clear message. Madam President, request a Roll Call when the vote is taken, so that we can show the support that we have for this type of legislation that is pending in Washington. Thank you. THE PRESIDENT PRO TEM: The Chair recognizes the

Senator from Cumberland, Senator Dillenback.
Senator DILLENBACK: Thank you Madam President,
Ladies and Gentlemen of the Senate. I attended a meeting with former Governor Brennan, a town meeting type of thing in the town of Falmouth. One of the things that he stressed during the whole meeting was the deficit that the Federal Government has and the monies that the President is spending. I reminded him that the President did not spend the money that the Legislature spent the money. The thing that bothers me about this is that we have a great deficit in this Country and here the President is trying to do something to save some money. We call it pork barrel and it definitely is a pork barrel. Mass transit in California and a tunnel in Massachusetts. Now, I understand the concern about the State of Maine, and particularly after the problem we have had in the last few days, we need money here and we will have money here. The President is going to put out a Bill and it may take several weeks to get it, but weather sometimes holds up contractors, other things happen and I think that it is a shame that we cannot sit here and support a President who is trying to save us some money. No, we are going to do something else, we are going to say he is wrong. I certainly hope that this is not an issue to embarrass Senator Cohen, who has been assured we are going to have money for the Topsham - Brunswick bridge and those items that are necessary for the State of Maine. I cannot in honesty vote for this and I hope the rest of you will support your President. Thank you.

THE PRESIDENT PRO TEM: The Chair recognizes the

Senator from Penobscot, Senator Emerson.
Senator EMERSON: I would like to pose a question through the Chair to someone on the Transportation Committee or anyone else who would like to answer it. This refers to the Federal Highway Program, and it speaks about sixty million dollars being allocated with the State of Maine. Down in the Resolution, it speaks about the need to

pass this Bill so that this state can recover its' roads and highways from the worst flood disaster of the century. The question is, can this money, that is allocated here, be used for flood damage?

THE PRESIDENT PRO TEM: The Senator from

Senator Emerson has posed a question Penobscot. through the Chair to any Senator who may care to respond.

The Chair recognizes the Senator from Kennebec, Senator Dow.

Senator DOW: Thank you Madam President Members of the Senate. To try to answer the question, the flood money is not part of this Bill that was vetoed. It shouldn't have been in the Resolution, although federal monies we are hoping will be coming forth to help on some of the disaster. There is a time element here this morning, and I would rather that we vote on this issue so that we can send it down to Congress because we need the

construction money now, our season is very short and there is a tremendous amount of roads out there that need this construction money. If we would not wait until after the vote is taken in Congress and pass this Resolution, it might help some. Thank you.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Hancock, Senator Perkins.

Senator PERKINS: Thank you Madam President and Members of the Senate. Although I agree with the thrust and the intent for my state, I find myself falling into the old word a day late and a dollar short. This piece of legislation has been before the Congress for three months. Where were we? If this is of such importance to my state, then maybe we should have hindsight, and it is always handy to have 20/20 hindsight, maybe we should have been passing an order or a memorial of this type three months ago. But to wait until the eleventh hour when they are meeting and say that this does, perhaps, in my mind not pass the straight face test. I don't think there is a Member in this Chamber who is not cognizant of the need of the roads in this state and this is a state as a whole. But I think, at this stage, to pass legislation after having listened to the amount of deficit and the amount of over spending and pass something of this magnitude with the spending for the magnitude that is here for the State of California and the State of Massachusetts, it is indeed foolhardy for this budget. I think what we can do best is hope that the Congress will act as expeditiously as the President has promised and the Senator has promised and that we get our budgets in order and get everything ready to cooperate and then re-address the situation and address it economical and a fiscally responsible manner.

While a Roll Call is handy to point fingers at this and that, I will be one of those who will vote

for the fiscal responsibility of the matter.

On motion by Senator PRAY of Penobscot, RECESSED until the sound of the bell.

After Recess

Senate called to order by the President Pro Tem.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Kennebec, Senator Dow.

Senator DOW: Thank you Madam President Members of the Senate. Not to prolong the discussion any longer on this Resolution, I just want to make a couple of points. One is the good Senator from Hancock had asked where we were earlier in memorializing the Congress and I have a vote that was taken on February 20, 1987, doing exactly the same thing as we are trying to do today. To pass a Bill to get the money that the highways in our state need. To answer one other question made by the Senator from Cumberland, Senator Dillenback, it is not the Highway Trust Fund that is in deficit, it is some people in Washington who are trying to take some of the Highway Trust Fund to cover another deficit. It is not over spending of that fund and we do need money and we need it very soon for a very short season. Thank you.

Senator from Franklin, Senator Webster.

Senator WEBSTER: Thank you Madam President. Ladies and Gentlemen of the Senate. Just very briefly, most of you know of the current outcome of the last several days, some of the damages that have been done by the recent storm, I happen to represent one of the hardest hit areas in the state. I am somewhat concerned about this Resolution which might

lead in the people in my district and the people in this state to believe that this Resolution would do something to help their situation. I think we all realize and it has been mentioned before, that this Resolution is worded wrong, because there is a section here that states something to the effect that it is going to benefit or is concerned that it might help the issue being debated in Washington today might help the flooded areas. We know, the Members of the Senate, that is not true.

I just want to bring that to the attention of the and on the Record that by passing this Resolution it is not going to help those areas in my district and the areas of the state directly with the highway fund that is being debated in Washington. There are funds available, we know that, and hopefully they will be coming in our direction. But passing this Resolution is going to do nothing to help what has happened here in Maine in the last several days.

THE PRÉSIDENT PRO TEM: The Chair recognizes the Senator from Androscoggin, Senator Gauvreau.

Senator GAUVREAU: Thank you Madam President, and Women of the Senate. The thing that many of you will recognize is that it is extremely rare that I would get up on a Bill dealing with Transportation, a topic on which I am not particularly familiar. But I do feel compelled to rise, at this point, to express my concern as to the tenor of the debate, not only in these Halls, but also in the U.S. Congress, dealing with the Highway Bill which is currently being discussed in Congress. It strikes me that there is another agenda which is being addressed in discussion of the Highway Bill and unfortunately it bears very little relationship to the needs or perceived needs of communities throughout this Country and in this State for improvements in our Transportation network. It is apparent, unfortunately, that the discussion in Washington and in this State has boiled down to not whether or not there is, in fact, a legitimate need for transportation investment program as articulated in the Highway Bill in Congress, but whether or not we ought to endorse the current President due to problems he unfortunately he finds himself in as a

It seems to me that we really ought to divorce ourselves from the political problems that the President may or may not have in discussing this particular measure and address it on its' merits and solely on its' merits. I submit to you, Men and Women of the Senate, that the average mayor could probably care less about whether or not the override is decided upon strictly partisan considerations and would rather want the issue to be addressed solely on its' merits, whether or not the proposed expenditure of public funds is, in fact, excessive. There is one other point I do feel compelled to mention, and that is it is my understanding as far as the funding source, the funding on the Highway Bill is generated from the Federal Gas Tax, and I believe that there is a separate highway trust fund, which is, in fact, funded by the gas tax so we are not talking about diverting monies from the Highway fund to go into other unmet social needs. Thank you.
