In Senate Chamber Monday April 6, 1987

Senate called to Order by the President.

THE PRESIDENT: The Chair recognizes that same Senator.

Senator ERWIN: Thank you, Mr. President. Mr. President, Ladies and Gertlemen of the Senate. I am sure that most of us have had and will have people who are terminally ill or near terminally ill. We all have our pride and when you reach a stage such as that, we want people that we know, we don't want strangers coming in to see us with a terrific loss of weight, if we have had cobalt treatment, perhaps a loss of hair. Physically, our pride tells us that we want our friends to see us in a condition like that, not a perfect stranger.

This amendment would let people that are in those conditions request by name, an individual to help them with their voting. Thank you.

THE PRESIDENT: The Chair recognizes the Senator

from Kennebec, Senator Kany.

Senator KANY: Mr. President and Members of the Senate. I rise to oppose the amendment and I ask for the Indefinite Postponement of the amendment before us, and I also request a Division. I hesitate to oppose the the gentlemen, the wonderful Senator from Oxford, Senator Erwin, because I understand the sincerity when he offers anything to this Senate. I do favor the unanimous report of the Committee on Legal Affairs. Because the Committee rewrote the Bill which had been offered to us, which more or less required that a clerk of any municipality offer voting at a nursing home. We amended that particular Bill to make it clear that the clerk after a particular day of offering voting a nursing, could not allow a candidate whose name appeared on the ballot, to take an absentee ballot to a person at a nursing home, or a congregate housing, or a licensed boarding home.

We wanted to remove the candidates from the ballot process, because we think it is important to the integrity of the political process, and to politicians in general, that their name not be implicated as possibly intruding into the voting process. We, last year, totally re-drew the absentee balloting law, made comprehensive changes, in which individuals could have just two witnesses that did not need to be notary publics', being the witnesses to the outside of a ballot. We also allow voting purely by mail, without having any witness or a notary public who have to sign the outside of that ballot.

So, individuals, let's say, someone who is seriously ill, as described by the good Senator from Oxford, Senator Erwin, could either vote entirely by mail without a witness. They could have staff people at the nursing home or hospital be the witnesses and

sign on the outside of the ballot, they could have other members of their family, anyone but a candidate could witness for that particular absentee ballot. So, I think there are plenty of opportunities, including opportunities for privacy and not involving members of the public who the person who is ill would not want to associate themselves with at that time. I urge you to defeat the amendment before you which would allow candidates, then, whose names are listed on the ballot to be active participants in the absentee balloting process in a nursing home.

Senator KANY of Kennebec moved the INDEFINITE

POSTPONEMENT of Senate Amendment "A" (S-19).

THE PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Erwin.

Senator ERWIN: Thank you, Mr. President. Mr. President, Ladies and Gentlemen of the Senate. I have had only one occasion where I have had to do this with an extremely close friend. One of my friends whom I had years ago at Oxford Paper.

I had to go to a nursing home that was some twenty five miles, so when you figure two trips, that is one hundred miles. Many clerks will not do that.

I am a very emotional type of individual and I tell you it just tore me apart. Fortunately, I had asked for and received the nurse in charge of the nursing home to go with me. I was getting permission. As soon as Tony saw me, he was paralyzed and was just getting to where he could speak again, and it was very difficult to understand what he was trying to say. He held my hand and cried for about ten minutes. You can imagine what that did to me. When I went back, I made sure that I found out when his wife visited, and so I arranged to return with the ballot when she would be there where she would handle the complete voting. All that I did was sign the outside of the envelope.

It is something that is very emotional to anybody that is involved in a case where it is a friend. I reiterate that the people in this condition, and all of us have pride, but it seems to come out more then. They do not want strangers coming to see them. They prefer a friend. I ask you not to let current events carry away your decision on this matter.

THE PRESIDENT: The Chair recognizes the Senator

from Cumberland, Senator Dillenback.

Senator DILLENBACK: Thank you, Mr. President, Ladies and Gentlemen of the Senate. I think the lady from Kennebec, Senator Kany, made an excellent presentation, but I would just like to add a few points. First, there is nothing in the world to prevent any relative or any friend to go visit somebody in a nursing home. Secondly, the clerk, himself, does not have to go to the nursing home. They can appoint somebody to handle that job. Three hundred and sixty days a year, you can go and hold somebody's hand. It is the day of the vote that you shouldn't be there if you are a candidate on the ballot. That is the only principle involved here. I think that people appreciate having the opportunity, in a nursing home, to vote like you and I do. If they are in a bed and unable to do it, then a relative or a third party, or a friend can go and help them with the ballot. They can ask for an absentee ballot. It can be mailed to them, it can be brought to them by a friend. Anything along those lines are perfectly permissible. I think this a good Bill. I hope you will support it.

THE PRESIDENT: The pending question before the Senate is the motion of Senator KANY of Kennebec, to INDEFINITELY POSTPONE Senate Amendment "A" (S-19).

Will all those Senators in favor of the motion of Senator KANY of Kennebec, to INDEFINITELY POSTPONE Senate Amendment "A" (S-19), please rise in their places and remain standing until counted.
