THE PRESIDENT PRO TEM: The Chair recognizes the

Senator GOULD: Thank you, Mr. President. ladies and gentlemen of the Senate. I urge you, the Senators of this distinguished Body, to consider not passing the pending motion, and then to accept the Minority Report.

I believe this country is a great country and I realize this is the 200th anniversary of the Constitution of the United States, or of its' being signed. I think, upon this distinguished occasion, marvelous occasion, actually, that we should consider sending a Resolution to our Senators in Washington, to balance our Federal Budget. In doing that, the Congress could avoid the Convention by acting itself. If thirty four states called for a itself. If thirty four states called for a Constitutional Convention on the balanced budget amendment, the Congress would have the option of

proposing such an amendment, itself.

The Congress establishes the Convention procedures. Any confusion about how a Convention would operate would be the fault of the Congress. All thirty two state Convention calls on the balanced budget issue are limited to that topic and no other. That is those states that have called for it already and have asked for that particular topic. The delegates would have a moral and legal obligation to stay on the topic of a balanced budget. There is a long history in the United States of individuals limiting their actions to the job for which they were Members of the Electorial College could, if they wished, elect anyone to the Presidency of United States, even someone who is not a candidate, and have received no popular vote. This has never happened. I believe in the people. Voters, themselves, demand that a convention be limited. Certainly, the convention would be held and each candidate would be asked if he favored limiting the Convention to the subject of the call, even if the voters in some areas did favor a open Convention, or some candidates lied and were elected, it is still improbable that a majority of delegates would be elected who favored opening the Convention on other issues, whether a majority of voters do not.

Congress would have the power to refuse sending a nonconforming amendment to ratification. Congress, as yet of preventing another run away amendment, they could simply refuse such an amendment to the states for ratification. Proposals would stray beyond the Convention call would subject to court challenge. Leaders and legislators, which have petitioned for a Constitutional Convention on the balanced budget issue have indicated that they would institute court rissue have indicated that they would institute court challenge to the proposal which went beyond their original call. After the convention, if it were held, it would take 38 states to ratify the amendment, what ever the amendment may be. The Federal deficit for fiscal year 1986, was 220.7 billion dollars. The estimated fiscal deficit for 1987 is going to be another 173.2 billion dollars. The Federal debt, at the end of 1987, is going to be 1.912.8 billion dollars or 1.9 trillion dollars. 1,912.8 billion dollars or 1.9 trillion dollars. We, the people of the United States, created the Constitution 200 years ago on September 17, 1786. I believe that the people could be in entrusted to amend this great document, now. I would respectively ask for a Roll Call.

Senator TUTTLE: Mr. President, men and women of the Senate. I won't belabor this issue. As Senator Gould has said, L. D. 323 proposes a Joint Resolution to Congress to call for a Constitutional Convention. Presently, 32 states have passed a Resolution Congress requesting to call the proposed Constitutional Convention. Two more states must pass similar resolutions before the Convention can be According to my research, according to the National Tax Payers Union, are considering an appeal of this provision, for many reasons that I will get into later. L. D. 323, specifically declares that a Constitutional Convention will be called explicitly for the purpose of proposing an amendment to the U. S. Constitution for a balanced budget. When the same Joint Resolution was presented to the State Government Committee, in 1985, proponents feared that the Constitutional Convention would address other issues such as abortions, school prayer, busing, etc., and that was brought up at the public hearing. Proponents based their arguments, in part, on the differences among Joint Resolutions presented by various State legislatures. The opponents also pointed out that there is nothing to prevent Congress from calling a Constitutional which other issues could be following Convention, in considered. In other words, the Joint Resolution does not have the force of law. While the Joint Resolution failed passage in the Legislature, it will prove another resolution requesting a moratorium to Congress, and I thought that had addressed the issue. Apparently, this Bill was back again this

I don't feel that I am going to change anyone's mind on this issue. I am sure that most of you have already made up your minds on this issue. This issue has been before us before and probably will be before us again. As I said before, we passed a Resolution last year and I thought it took care of this issue, but it is back before us, this year. The main reason I supported the Majority Report, as did the majority of the Committee, is because we feel we passed the Bill and then the Convention, we feel would do much more than the sponsors would want this Resolution to We are all in favor of a balanced budget. I don't know of anybody who isn't. I am not going to support a Constitutional Convention that might change our Bill of Rights, the right to bear arms and our

fundamental rights as citizens. In this year of our Constitution, our 200th birthday, that has worked so well over the years, let's not do something that we might be sorry for in the long run. For that reason, I hope you will support the Majority Report. Thank

Androscoggin, Senator Gauvreau.

Senator GAUVREAU: Thank you, Mr. President. and women of the Senate. I know it is late on Friday and many of us have plans to Adjourn and attend to our various business, but I feel the issue is solemn enough that I would like to put on the Record a few of my comments, that hopefully might be of some relevance in our deliberations on this issue. We have heard, over and over again, on the possibility of urging the Federal Congress to propose a Constitutional Convention for a limited purpose of addressing the balanced budget issue. I have given this matter some thought, over the years, and it is my judgment, based on reviewing several documents, that there no way in which the Congress can circumscribe a Constitutional Conventional's charge. In other words, clearly, the membership in the Convention, would have the authority to debate and consider any issues, even beyond the reason for which the Conference was convened. We can only look at the famous Constitutional Convention which occurred 200 years ago in Philadelphia. In fact, if you will recall, in the Philadelphia Conference, that was convened for a very narrow purpose. There were convened for a very narrow purpose. There were problems dealing with trade between these 13 original states, and there were severe problems regarding tariffs and what not, and it was felt that the issue of trade had to be addressed.

Nevertheless, there was concern, in the various states as to the advisability for calling the Conference. It was felt that the Conference, might in fact, go beyond its' original charge. As we all know, the Convention did, in fact, address a whole range of other issues, recommending our Constitution as we know it today, and the Bill of Rights which was appended some 4 years later on. So, I think it is somewhat specious to suggest that we could craft an instrument by which we could circumscribe the authority of any Constitutional Convention, we could This is a matter of significant concern to me. As the Senator from York, Senator Tuttle commented, all of us understand the imperative of the Federal Government securing a balanced budget, and yet, it is interesting to note that there is nothing, currently, prohibiting Congress and the President from proposing and adopting a balanced budget. The situation is significantly different than it was some 200 years ago, when the Congress and the President were unable to affectively chart a Federal policy calling for uniform trade relations between the states. So, one could argue, with some force, that there was a necessity of convening the Convention some 200 years ago. That argument cannot be carried forward today with any force. The President. certainly has it in his authority and in his power to recommend a balanced budget. The Congress, likewise, has the authority to do just that.

It is significant to note, that in 1979, the deficit was around 48 billion dollars, in that budget year, and yet, some 6 years later on, the deficit has swollen to 275 billion dollars. So, I would suggest, not withstanding any resolutions the states adopt, it seems to me the Congress and the President have to address the real issue in trying to effect a balanced budget. For these concerns, I really think that it is not appropriate for us to be recommending or lending the State's name to those other states which have called for a Constitutional Convention. I can't help but feel that although, in this particular case, the previous speakers' remarks certainly are noble and their intent is valid, I just can't help but feel that there are political overtures to this whole debate. We certainly have to subordinate political gain to the overriding interests of all the people in our Country, that we preserve the Constitutional heritage that we have today. It for

these reasons, I would go along with recommending the adoption of the Majority Report. Thank you.

THE PRESIDENT PRO TEM: The pending question before the Senate is the motion of Senator TUTTLE of York that the Senate ACCEPT the Majority OUGHT NOT TO PASS Report. A Roll Call has been ordered.

A vote of Yes will be in favor of ACCEPTANCE.
