THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Penobscot, Senator Pearson.

Senator PEARSON: Thank you Madam President and members of the Senate. I understand that this is the Bill that would publicize the names of people who have not paid their support payments in the media. I was actually caught a little off guard here, but I have a thought I would like to share with you. think maybe most of you got a letter, as a matter of fact, at one time or another, from a man in Old Town, who was told by the Department of Human Services that he had to make child support payments for a child that he was alleged to have fathered. I guess it was

fourteen or fifteen years before. At the time that the child was born, he told the mother that he would do what was considered, at that time, the noble thing, which was to marry her and support the child. She said no, she didn't want anything to do with him and I guess, at one point, he even indicated that he wasn't the father. He made a number of appeals to do what he thought was the responsible thing, which was to support the child. He was rebuffed at every turn.

Over a decade later, someone from Human Services said to her, she was on AFDC, who is the father? We can get money from him to pay for your child. She named him as the father and he was told that he had to pay all the back money that had been paid for by the state, plus payments in the future. When I read this particular Bill, that bothered me.

I think that was the jest of what he had to say in the letter. I know that he has seen me two or three times and there seems to be little or nothing that I can do about it. I do sympathize with the fellow who wanted to fulfill what he considered to be his obligations and was rebuffed and then ten years later is told that he must pay all of those back payments. Does a person like that get publicized in the paper for nonsupport for all those years in the He is now remarried and wants to get on with past? his life, this is causing him problems with his present spouse and he is really pretty down about it.

If you publicized his name, does that help the situation? I understand that is only one situation, but it is real thing to him. I think he would be caught up in this publicizing of names, just as he has been caught up in a blanket action of the Department of Human Services to collect on back payments, which he wanted to do, but now can't afford to because it would take so many years back. I am troubled by that.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Cumberland, Senator Brannigan.

Senator BRANNIGAN: Thank you Madam President and members of the Senate. Probably this gentlemen would be caught up in this blanket if he owes over \$5,000 and has not made payments in three years. This Bill, as Amended, would require those people who have not made those payments in those categories, \$5,000 and not made payments for three years, their names would be published in the papers. The reason that all of the Senators in the majority of the Committee agreed that this Bill should not pass, because we felt it would really not do a great deal of good in the collection efforts. Our state, by the way, is doing an excellent job in collecting and we felt that harm would be done to the children whose names would be published. We feel that the chances are that many of the people who have not paid over that length of time have with left the state or are totally unable to pay for financial reasons, and that someone in Seattle Washington or Portland Oregon, would not be much effected by their names being placed in Maine media, but their children's names would be. It was mainly on that issue that our decision turned. I would ask you to defeat the pending motion to Recede and Concur and go on to Insist on our previous action. Thank you.

THE PRESIDENT PRO TEM: The pending question before the Senate is the motion of Senator PERKINS of Hancock to RECEDE and CONCUR.

A Division has been requested.

Will all those Senators in favor of the motion of Senator PERKINS of Hancock to RECEDE and CONCUR, please rise in their places and remain standing until counted.

Will all those Senators opposed please rise in their places and remain standing until counted.

8 Senators having voted in the affirmative and 19 Senators having voted in the negative, the motion of Senator PERKINS of Hancock to RECEDE and CONCUR FAILED.

Senator PERKINS of Hancock moved that the Senate INSIST and ASK FOR A COMMITTEE OF CONFERENCE.

THE PRESIDENT PRO TEM: The Chair would rule that the motion to Insist takes precedence in that it stands alone, without the accompanying request, to ask for a Committee of Conference.
