I hope that we can pause for just a moment in passing this Resolution and recognize a great champion from the other body. For those of you who were not at the funeral of Larry Connolly, yesterday, there was a story which I think characterized him and his spirit, that was told. We worked very hard on a referendum champion of that referendum, dealing with the Portland water front. He worked very hard on it as he worked on anything that he put his heart and soul into. He had his heart attack before the election and he was in his hospital bed, slipping in and out of consciousness. He insisted on having an absentee ballot so he could vote in the election on election day. Then that night, we posted a greater than 2 to victory in that referendum election. Larry was told the results of the election late that night and insisted that he receive a district by district break down of the vote to see exactly how his precincts did, in his own neighborhood. Larry Connolly set a standard for all of us. It is a standard that I can only aspire to. While we buried his body in Portland yesterday, his spirit lives today and whenever we take up the cause of human dignity and social justice. God bless Larry Connolly.

Pursuant to 25 M.R.S.A. §1544, it is my privilege to present you and the Legislature the twelfth annual report on crime in Maine.

This report is based on data presented to this department from all law enforcement agencies in Maine in a style and format as prescribed by law and which is consistent with the other states' efforts. The result is a valuable document by which we can evaluate the occurrence of crime in Maine, compare that situation with past years, and evaluate Maine's record with those of other states.

This year's report offers the encouragement of a substantiated record of a reduced crime rate which has been the trend in Maine over the past few years. There are many explanations which may be offered for this positive development, among which has to be the professionalism of our State's law enforcement officers, the diligence of its prosecutors and the responsiveness of its courts.

Lastly, let me add that this report would have been impossible without the strong commitment of our local, county, and state law enforcement agencies to collecting and forwarding the data necessary to this report each year. I know you join me in thanking them for this careful effort.
