Off Record Remarks

THE PRESIDENT: The Chair recognizes the Senator

from Kennebec, Senator Kany.

Senator KANY: Thank you Mr. President, men and women of the Senate. I oppose the pending motion and ask for a Division. This was a Bill that was debated at length yesterday in which it was brought to the Senate's attention that "An Act relating to Radon Gas" came this way with an amendment which was attached to the House. It seemed to meet with some of the objections as I understood them that a couple of members of this Body had to the original Bill. Now, I am having an amendment prepared because I see one item that I believe should be changed and that is

that we should put into the statute a standard for

radon gas in water.

That is what we are using in this State as 20,000 picoteries per liter. If the Senate does reject the pending motion and goes with the Bill then I will be offering that amendment following that time. I just would like to point out to you that there are four bills that I know of having to do with radon that are before the Legislature this year. Five, really. is the Commission, which I strongly support, not that we need to know more about radon in the State or to find out if it exists because we know that it does exist in abundance and in the homes of our citizens. It is causing a serious health problem to those citizens. The reason that I support that Commission is for the educational value that a commission would The second bill on this topic would put a notice just on the real estate transfer tax form that radon is present in this State in significant amounts and that testing is available through the State. Third, there is a bill that has to do with testing for radon in schools, which I understand has the unanimous support the Committee chaired by the good Senator from Androscoggin, Senator Gauvreau. Then we have this Bill, which has to do with radon gas and which is sponsored by Representative Susan Dorr who is present in the Chamber right now.

I support this Bill, knowing what I know about radon because it would do a number of things at no cost to the taxpayer of the State. It would provide prior notice. It would require real estate agents to give prior notice to those seeking to purchase real estate, that there may be significant amounts of radon in the dwelling that they wish to purchase. That will let them know that they can have a test. If they are dissatisfied with the property at that point, that they could back out of their deal. In exchange for all of this, real estate agents could, having complied with that notice requirement, could gain immunity from liability, the possibility that that significant amount of radon is present in that dwelling. I think that is all very reasonable.

It is an educational thing. It takes the liability off those who have done their jobs in a reasonable manner and perhaps it will save some of citizens from the possible damaging health effects of a significant amount of radon that could be present in their homes. As I mentioned yesterday, that we have the home in the world that has the greatest level of radon in water, and that is in Leeds, Maine. We have found significant, very significant levels of radon in air in homes in the State of Maine. Thirty percent of those tested through our Department of Human Services since they began testing for that radon in the air, which just a year an a half ago. So, we know we have a problem. We have the granite that contains the uranium that decays and eventually becomes that radon gas. We know of the significant health effects, primarily into the lungs from that radon gas. By the way, the radon in water and drinking it directly can cause additional stomach cancer and cancer of the digestive tracts. We know that we have more cancer in the State, particularly among women who are in the enclosed areas of their homes more. I urge you to look at what I distributed to you which was the original Bill, incorporating the House amendment. Keeping in mind that the standard in water would be placed upon us if you do accept this.

I really urge you to do so. Why wait for a commission as important as that commission is and as much as I support it, and I testified in favor of Representative Whitcomb's Bill at that hearing just to show my level of support because of the educational value. Why wait when we know and we have some data to show that we have this in Maine and citizens are not taking it seriously enough. So, I guess if we have a single problem in this State right now, regarding radon, the single greatest problem is probably public apathy more than anything else. I do believe that this Bill is certainly would help cure the problem, both the public apathy, the lack of awareness and it could help improve our citizens living quarters and their future health. I urge you

to reject the motion before you. THE PRESIDENT: The Chair recognizes the Senator

from Penobscot, Senator Baldacci.

Senator BALDACCI: Thank you Mr. President and members of the Senate. I feel that the action that this Body took yesterday was very appropriate. It is very unfortunate that this matter is before this Body today after the Committee had dealt with this Bill and a similar bill that the good Senator from Kennebec, Senator Kany had sponsored on radon. There were two things going on. A commission to study it which we thought appropriate before anything be done. The second thing was that the Real Estate Commission, itself, and the Realtors Association were in the midst of reviewing the matter as they had done with asbestos, wiring and increasing the disclosure laws. We thought it appropriate before anything be done to wait and see what came about through that process. I think it is very important that the Senator from Cumberland, Senator Brannigan, who was very concerned about this and also not speaking for the good Senator from Androscoggin, Senator Whitmore, but it was a unanimous consensus of the members on the Committee that it was the best way to go. The radon problem, I don't like it. I think it does things that are terrible but until we can actually have these things presented to us, it didn't make much sense, plus the work that the Real Estate Commission was doing itself, that it would be very urgent. It is unfortunate that this matter is before this Body, it should have been handled in Committee. It was once and due to an abnormality, it came out a Divided Report, and actually along with the good Senator from Kennebec, Senator Kany's Bill, should have been Ought Not to Pass or Leave to Withdraw. So, I hope that you support the Majority Report.

On motion by Senator KANY of Kennebec supported by a Division of at least one-fifth of the members

present and voting, a Roll Call was ordered.

Senator KANY: Mr. President and members of this Body. I would just like to mention that this Bill really would help the real estate industry too, because it would grant them an immunity if they had performed their duties and they may not even realize it, themselves today. They really are liable, understanding that there is granite below the area in which they are selling something and if they do not let some one know, that they could have a significant radon exposure. I just wanted you to understand that. This could help them as well as providing prior notice to some one so that they could take care of that radon problem, which they probably can do quite inexpensively if they are just aware of it at the proper time when they would take the matter

seriously and into consideration. In fact, if some one is building a home, they just put their foundation in correctly, put the sides of the foundation on top of the base, they can eliminate a great deal of the radon threat, the radon that might ordinarily enter from the soil through the cracks, so there are things like this, so we would be doing every one a huge favor at no cost to the tax bearers. We know the problem exists and we know it today. There is no reason to wait and urge you to vote against the pending motion.
