As I stand here in the last few minutes of the last hour of the last day of a very long session, I hate to do it but I have to remind you that we really have just begun and that, by January, many of the studies that have begun this session will have been completed and we will have the opportunity to fashion new and comprehensive solutions to some of our state's greater challenges, whether it is economic development or restructuring of our tax system or the crafting of a sound state retirement system.

When you return in January, we will also need to confront head-on one of our most important issues and that is the issue of how we are going to protect our environment and manage our growth. We have made important progress this session with a bond issue on land acquisition, with legislation addressing overboard discharge of solid waste and underground tanks. More needs to be done because we cannot ignore the growing pressures that development is placing on our environment. Through the next six months, we must prepare to address these pressures as a top priority of the next session.

In closing, let me just say a few words of thanks, first to my staff and to my cabinet which has worked overtime in these last few weeks, as have all of you, in trying to make sure that we had the kind of communication and the dialogue that is so important to reaching solutions that are going to benefit Maine. I especially want to thank Sawin Millett and to Alan McEwen who were in charge of our legislative office that got to know all of you so well.

I would also like to thank the Republicans in this body for all the support that they have given me during this first six months and to Speaker Martin and to Democratic Leadership, the chairs of the various committees and frankly to all of you on the democratic side of the aisle, for your willingness to work with us during this first six month period. Now, we haven't always agreed but I think that we have always done what we thought was best for this state. It is that spirit of cooperation, the common concerns for the people of this state that has marked this session and bodes well for our future success.

Finally, I would just like to wish the very best to Gennette Ingraham, who I understand will be forming her own Joint Legislative Standing Committee on Marital Relations this summer.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Usher.

Senator USHER: Thank you Mr. President and members of the Senate. Before this Bill is enacted, I just want to make a statement that in all my thirteen years here I have served on quite a few study committees. The study committee that we just

completed regards to this issue is been the most active study committee that I have been on. Everybody was concerned about this issue statewide. Industry was involved, organized groups, Maine Audubon, everybody participated in this study. We held a lot of hearings from the first of the year, it started last year and after we convened at the first of the year, we met almost everyday of the week. Everybody participated, we listened to everybody and it was one of the best studies I have been involved in. I want to say that the Committee Report expresses the committee intent. I want to thank my committee assistant, Tim Glidden. It is not very often that we single out a person who works with us everyday, but this man put in many hours and weekends to work with this issue and to work with all the groups that came before the Committee. I am encouraging everyone here today to move the enactment of this legislation.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Tuttle.

Senator TUTTLE: Thank you Mr. President, men and women of the Senate. I would concur with the comments from the good Senator from Cumberland, Senator Usher. As a members of the Energy and Natural Resources Committee and as a Senator representing an area of which has lived day to day beneath the threat of haphazard solid waste expansion. I am pleased to rise in support of this unanimous Committee Report. I congratulate Senator Usher for his leadership on the Committee. I congratulate both Republicans and Democrats of the Committee for the spirit of compromise. Most importantly I congratulate the dedicated citizens from my area and from other areas of the state who brought this issue to the forefront of state issues. Few times in my career as a Legislator, have I seen such a sincere and organized effort by Maine citizens to resolve a critical state problem. It was a genuine grass roots effort by courageous and persistent citizens of Maine. These people, as I mentioned to you before, are not activists, they are not professional organizers, they are not liberals and they are not conservatives. They are simply a group of courageous citizens who were deeply concerned about the quality of life in their communities and in the state of Maine.

With the passage of this Bill, each of us can return home to our constituents and say that we have responded to this urgent and genuine public concern. And as we know perhaps better than anyone, the Legislature is not often recognized for the speed in which it makes decisions, but in this case we have turned the wheels just as about as efficiently and effectively as they have been turned in the years that I have been here.

Last September, the Governor and the Legislature acted wisely to create a moratorium on new and expanded commercial facilities. The moratorium allowed time for us to study this issue and we made effective use of that time. We learned a great deal about Maine solid waste policy, we learned a great deal about the solid waste policy in other states. During our year of study, it became very clear that any comprehensive waste policy would affect a wide spectrum of interests. Its impact would be felt by the large paper companies and small families living in rural Maine. Members of the Committee realized that all of these interests must be heard and considered. We realized the best way to serve the public good was to put a comprehensive plan in place now. The only way that this could be accomplished was through a compromise. This Bill meets all the requirements of solid compromise. I do not get

everything I wanted, nor did anyone else, but I can assure you that the people who have been living in fear of contaminated water and diminishing property values are much happier today than they were a year ago. Thank you very much.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Pearson.

Senator PEARSON: Thank you Mr. President, men and women of the Senate. A lot of people think that the solid waste problems was a problem that was peculiar to southern Maine. That is not necessarily so. On behalf of the people in the town of Bradford, who are facing this very same problem that they are facing in the area around Senator Tuttle's district, with the fear of their town being turned into a dump that was being used by out of state people, who were trying to use us and use us poorly. I think that Senator Usher and members of his Committee and particularly Mr. Glidden, ought to know that we appreciate what they did very much.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Kany.

Senator KANY: Thank you Mr. President and members of the Senate. I would also like to add my congratulations having served as a member of the Energy and Natural Resources Committee the last two terms, the first of those two terms as Chairman of the Committee, and following this particular study very closely from the beginning of the working group, when Grof Latebo of the Office of Policy and Legal Analysis and Tim Glidden, put together their first working papers, identifying the waste, putting back to back all the legal case history and so on. Getting the various groups together, hour after hour, day after day, week after week, when the special Committee met and then with the Energy and Natural Resources Committee meeting as a whole.

I will say one thing and that is I believe that the legislation is extremely workable and it goes beyond just reacting to the current crisis. There are a lot of elements in there that can help prevent further pollution of ground water and air. I really think that for such a major measure, it is almost as perfect a Bill as I have seen on something so major. I would really like to congratulate all members of the Energy Natural and Resources Committee and to the Maine Legislature as a whole as well as to the outstanding, unusual meritorious work down by staff on this.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Baldacci.

Senator BALDACCI: Mr. President, is there a fiscal note on this Bill or is there any cost for enforcing this?

THE PRESIDENT: The Chair would respond to the inquiry by the Senator from Penobscot, Senator Baldacci, that there is not a fiscal note on this Bill and the Chair has been assured no fiscal note is required.

The Chair would advise the membership that the motion to Recede and Concur would, in essence, Enact the Bill and would require a two-thirds vote.

On motion by Senator KANY of Kennebec, supported by a Division of at least one-fifth of the Members present and voting, a Roll Call was Ordered.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Kany.

Senator KANY: Thank you Mr. President and members of the Senate. Just to review what measure is before us, it is "An Act to Prohibit Drinking of Alcoholic Beverages in Motor Vehicles". What it does is to prohibit drinking while driving a motor vehicle. The passengers in the motor vehicle, still would be able to drink. It is only the driver who would be prohibited from drinking. There is a penalty on the Bill of up to five hundred dollars, unlike operating under the influence, which is and can be a Class D crime, with a fine of up to one thousand dollars and up to a year in jail. This would just be a civil penalty and I believe that the people of the state of Maine would certainly support having us prohibit having a driver drink, while they are actually operating a vehicle on a public way. I urge you to vote in favor of the pending motion, which is to recede and concur.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Dillenback.

Senator DILLENBACK: Thank you Mr. President, I concur with the Senator and what she has said. Also, this Bill is so simple that if you are in a public area drinking in a car, a policeman comes up and asks you not to do so, unless you have permission from the people who own the property. Do we want people drinking in parking lots and all over this state in an automobile and then driving on the road? I don't think so. It is a simple Bill and I think we should pass it. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Baldacci.

Senator BALDACCI: Thank you Mr. President, I appreciate the explanation from the good Senator from

Cumberland, Senator Dillenback. It has made it now crystal clear. The problem with this particular measure is that by prohibiting somebody from drinking in a car or out in public, they are not intoxicated, they are not bothering anybody, they are sipping on a beer or a wine cooler or whatever else and all of a sudden it becomes a Class E crime to be doing that. They are not intoxicated, they are not disorderly, they are not bothering anybody and they may not be picked up for driving, because their level of alcoholic influences isn't high to permit that crime to come in place. Why all of a sudden are we going to make it a crime to be sipping on a wine cooler watching something if you are not bothering anybody? What is the crime there that we are trying to create? That is the question that I would like to pose.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Kany.

Senator KANY: Mr. President and members of the Senate. I would urge the good Senator from Penobscot, to look at the amendment, which really is the Bill. It has a filing number of H-314 and what it does is it addresses just drinking while only operating a motor vehicle, not while it is standing still and only on a public way. We are not even calling it a crime, it would only be a civil violation, it would not be a Class E crime. I don't think this is too harsh at all. Perhaps it can prevent somebody from committing the crime of OUI, which is a crime.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Theriault.

Senator THERIAULT: Thank you Mr. President, I would like to pose a question through the Chair to any Senator who may care to respond. I would like to know if this would stop someone after a real hard days work, in the middle of summer, on the way home from stopping for a beer and enjoying it on the way home?

THE PRESIDENT: The Senator from Aroostook, Senator Theriault, has posed a question through the Chair to any Senator who may care to respond.

The Chair recognizes the Senator from Cumberland, Senator Dillenback.

Senator DILLENBACK: Thank you Mr. President, ladies and gentlemen of the Senate. You certainly can stop and buy your beer, you certainly can drink the beer and if you are in my shopping center or my parking lot and you have my permission, you can drink beer there all day long if you so wish.

Some people think it is perfectly all right to go into a public area and sit in their car and drink. Other people are offended by this and other people do not like to see it. All you have to do is get permission from the owner of the parking lot and you can drink there. If you go on the road after you have been there all day, it may be a different story. This is really a harmless Bill and it really is to protect the people who do not want you drinking in their parking lot.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Baldacci.

Senator BALDACCI: Thank you Mr. President, I would like to thank the good Senator from Cumberland, Senator Dillenback for illustrating the point here today I guess is to push people who are drinking wine coolers or alcoholic beverages of a very small alcoholic content out of those parking lots and onto the roads. So, where they can cause accidents and get into accidents if they are intoxicated. I think there is a better solution to this that the shop owners and the mall owners have the ability to be able to make sure that people are not in their

parking lots. They certainly have other legal recourse. I am sure with all the volumes and statutes that we have in the state of Maine, there have to be some provisions somewhere that those people would be told to move along. If we are make sure that they are out of our parking lot, I submit to you that is not a good enough reason to make this penalty worth up to five hundred dollars. Worth up to five hundred dollars?

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Matthews.

Senator MATTHEWS: Thank you Mr. President, men and women of the Senate. I just want to call your attention to the amendment, let me read the statement of fact. "This amendment makes it a civil violation for any person to drink liquor while operating a motor vehicle on a public way. It does not apply to passengers in the vehicle." Ladies and gentlemen of the Senate, it seems amazing and incredible to me that this Body would be having a hard time with this Bill and this amendment, prohibiting someone from drinking an alcoholic beverage while driving on our Maine roads. We have a hard time with this Bill, but ladies and gentlemen, we have debated drug testing, mandatory random drug testing, we have debated the issue of substance abuse and the need to help our society get away from the evils of drug abuse and drug addiction, but we are going to allow people to drive and drink? Ladies and gentlemen, I am not a prohibitionist and I am not advocating that we change history, but it seems to me that if someone wants to drink, dog gone it, don't be on the road when you do it. Don't take a chance on my life, or on my children's lives. This is an incredible debate this evening. The issue as the good Senator from Cumberland, Senator Dillenback, is very simple. It is very simple and I cannot believe that this Body is going to send mixed messages back out to their constituents back home.

We are going to get tough about alcohol use and abuse. We are going to get tough on drug abuse, we are going to send people down to the prisons, but if you want to drink and drive go ahead.

Ladies and gentlemen, I heard a radio program on my way home from this Chamber not too long ago from some groups that I know all of us here believe in, mothers against drunk driving and students against drunk driving. This was a national radio program. This is a major issue for these organizations, ladies and gentlemen, that are sick and tired of being endangered by people that drink and drive on the roads. It should be prohibited. It is very clear if you want to drink, stop your vehicle, get out of the vehicle and go into the tavern, but get off the roads.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Baldacci.

Senator BALDACCII: Thank you Mr. President and members of the Senate. I appreciate the explanation from the good Senator from Kennebec, Senator Matthews, but the law in the state of Maine is not to eliminate all liquor. It is not to eliminate the state from selling liquor and it is not to eliminate anybody from drinking liquor. We have very tough drunk driving laws in the state of Maine, people are put into prison for drinking while at a certain level of alcoholic consumption in their system. There is not question about that, we have very tough drunk driving laws. We are not talking about drunk, we are not talking about somebody sipping over the limit, we are talking about somebody sipping on a wine cooler in a car going home that is going to be penalized up to five hundred dollars. The way this reads, the liquor is one-half of one percent of alcoholic content. If you remember our debate on wine coolers, we

established it at seven percent alcoholic content, because they were at four, five and six percent. This is what we are talking about. Not about somebody that is not drunk, I think they ought to slam the book at them, they should just put them away. As a matter of fact, they are doing those things today. We are just talking about somebody who is a social drinker, he is going home from work or whatever else and is sipping on a wine cooler and you are going to make him pay five hundred dollars here in the state of Maine. I think that is what is reprehensible.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Dillenback.

Senator DILLENBACK: Thank you Mr. President, ladies and gentlemen of the Senate. I am sorry to take time on this, but I have discovered that it doesn't show the amendment on supplement 21 and I was going back to the Bill, but my statements were still correct. The point is, when we discussed this in Committee, we tried to abolish drinking in a vehicle on the roads. That wasn't practical, so therefore, you people could have one person drive the car and the rest of the people in the car can sit there and drink out of their bottle of scotch or anything they want to drink out of.

Apparently, that is all right. If you think that is all right, then you can vote for this Bill. But if you think it is more correct to have the driver going down the road, with a bottle tipped up drinking, then you have a problem, because I don't think that is correct and I don't think the general public thinks that is correct. I don't think the fellow driving the car should be tipping a bottle. So, that is the position we took, if you don't agree with this, you can vote against it. Thank you very much.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Kany.

Senator KANY: Thank you Mr. President and members of the Senate. I do believe that part of the confusion was the fact that supplement 21 does not show that the accompanying paper is H-314, which really is the entire Bill. It is a Bill which received the unanimous support of the Committee on Legal Affairs and it is a Bill that the law of which thirty-eight states have something very similar to this. I think a lot of people just assumed that Maine have such a law and the truth of the matter is that it has not been clear, even though you are not suppose to drink in public. It is not clear if that applies to inside someone's motor vehicle. Many lawyers believe that is does not apply. The reason for this Bill and the wording as such is we just want to make it absolutely clear to everybody that there would be a penalty and it would be a civil violation if one is actually drinking while they are driving inside a motor vehicle. I hope that you do go along with it, it does not apply to parking lots, it only applies to actually operating the motor vehicle and only on a public way. I urge you to recede and concur.

THE PRESIDENT: The Chair recognizes the Senator from Waldo, Senator Gould.

Senator GOULD: Thank you Mr. President, I would like to pose a question through the Chair to any Senator who may care to respond. Would a cough syrup, consumed in a car be considered as an alcoholic beverage?

THE PRESIDENT: The pending question before the Senate is the motion of Senator KANY of Kennebec to RECEDE and CONCUR.

An Act to Amend the Aquaculture Leasing Statutes

H.P. 1346 L.D. 1840

(S "A" S-280)

THE PRESIDENT: The Chair recognizes the Senator from Sagadahoc, Senator Cahill.

Senator CAHILL: Thank you Mr. President, men and women of the Senate. I will be very brief tonight, but L.D. 1840, "An Act to Amend the Aquaculture Leasing Statutes" is very significant legislation and even though the hour is late, I feel the need to put a few comments on the Record. This legislation is really quite far reaching and it represents the work of many people including staff and the Legislators on the Marine Resources Committee. I think it has been

passed in the best intentions, but I would like to make a few comments. Some people have been led to believe that this Bill will restrict participation in aquaculture to large well financed companies and excluded independent fishermen. This is not the case and the intent to the legislation is to permit independent fishermen and small businesses to obtain aquaculture leases without undue expense or complexity. We have purposely delegated the Department of Marine Resources the task of determining through regulations, specific decision criteria and fees which would not preclude individual entrepreneurs.

The second area of concern is the fear that the wording of the Bill would restrict normal operation of aquaculture farming in the state of Maine. It is also not the intent of the Committee to restrict aquaculture farming on the coast. We understand that planting, feeding, disease control and harvesting are necessary activities in an aquaculture operation. In fact, maintaining environmental quality is very important to the aquaculturist since they require clean water to raise their fish and shell fish.

We also recognize the very existence of aquaculture and the sight may change the ecology in a limited way, but this is acceptable. The Committee's intent is that the productive areas remain productive. This Bill also adds new environmental language to the lease statutes and while the lease applicants might have to conduct expensive environmental impact statements in order to be granted a lease. This is also not the intent of the legislation. We want the applicant to survey plans and to conduct a thorough review of the proposed sight, him or herself. We intend that the Department of Marine Resources regulation urge the use of terms in the applicants description of flora and fauna at the sight. Again, it is not the intent of the Committee to make this application unduly expensive, lengthy or complex. There was also some concern that the lease process removes submerged lands from public domain, this is also not the intent. The law does not restrict fishing of any other species in the leased area, nor does it restrict navigation through the leased area, nor does it preclude recreational use. The lease holder has the right to the planted species named in the lease and nothing more.

Lastly, there is some concern from the public about the hearing process that is currently in existence and certain sections of this Bill gives the Commissioner of Marine Resources regulatory power to change the publication of notices and the order of testimony at the public aquaculture lease hearings. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Matthews.

Senator MATTHEWS: Thank you Mr. President, men and women of the Senate. I too will be very brief. As the good Senator from Sagadahoc, Senator Cahill, has mentioned the Marine Resources Committee has worked very hard and long for the last five months on the major issue before that Committee on aquaculture. In fact, members of the Committee on Marine Resources, both Democrats and Republicans, some who have served on the Committee in the last term, worked on this issue for three years.

The issue, in my estimation, represents what a compromise is all about. The aquaculture industry isn't pleased with everything, the Department of Marine Resources isn't pleased with everything, the commercial fishermen that have had some concerns about this new industry isn't pleased with everything in the Bill and the Legislative Committee isn't pleased with everything in the Bill. That is what a

compromise is, ladies and gentlemen of the Senate. I think the Bill we have come out with will provide some continuity, some process for oversight, by the Department of Marine Resources, room for growth in the aquaculture industry and the opportunity for those in the commercial fishing industry to participate in the process and that is really what the Committee has been trying to do. This is a start and I agree with the good Senator from Sagadahoc, it is far reaching, but it is very vital and very important. I do want to thank the members of that Committee, they have worked tirelessly and I think we have a Bill that is a start and it is a good one.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Collins.

Senator COLLINS: Thank you Mr. President and members of the Senate. First I would ask for a Roll Call on Enactment on this Bill and I would briefly like to tell you a little bit about it, it has not been discussed in this Chamber. I recognize that it has limited interest and yet I think there is a message here that perhaps we ought to consider. The title of the Bill, for example, is "An Act to Give the Aroostook County Budget Committee Final Approval Authority Over the County Budget". The House Amendment, which we adopted earlier this evening, removes in essence the entire thrust of the Bill. It put the responsibility for the approval of the county budget back in the hands of the Legislature.

A few years ago, the Legislature enacted legislation for Aroostook County that set up a budget committee and gave it some authority with respect to fashioning a budget, with the idea, of course, that perhaps the people locally who were more involved in the communities and closer to Aroostook County government, could prepare a budget better, than could Legislators who are dealing with budget from afar. That budget committee worked the last two years and did, in fact, do some yeoman work. However, what has developed is that the work that is done by the budget committee has, in fact, been undone by the Legislative process.

Those of us that feel that home rule and local rule is often the best, I am somewhat disappointed that this Bill, which was intended originally, to increase the role of the budget committee and to eliminate the Legislative oversight entirely, turned up in the fashion in which it did. We have two counties that have had some experience in this matter and it seems to me that it is a direction that we all ought to be taking. Both Waldo County and Cumberland County currently prepare their budgets in this manner, without recourse to the Legislature. I think if you establish a county government whereby you have a county administrator and the county commissioners and have a budget committee that is composed of citizens within the area where the taxes are paid, and I might point out to you once again that county government derives its funding entirely from the municipalities within the county for the property taxes. I think that all of you are aware that the cost of county government from various reasons including the cost of keeping jails has gone up substantially during the last several years. In our own particular case, it has gone up on an average of about 52%. It seems to me that it is appropriate that the people who live in the county, in the municipalities, have the responsibility to prepare a budget that they are going to pay for.

It is with a great deal of disappointment that I note what has happened to this Bill. I should like to tell you that I think the Bill has a tremendous amount of support from the various communities in Aroostook County. I have in front of me a list of communities who have signed the petitions in support of this legislation and that list comprises of a majority of the communities in Aroostook County. I

am aware of the situation that the Bill is now in and I don't expect miracles, but I certainly want to be on Record as opposing the adoption of this Bill, which in my view sets back our proposal many years. Thank you.

On motion by Senator COLLINS of Aroostook, supported by a Division of at least one-fifth of the Members present and voting, a Roll Call was Ordered.

They feel they are in the best position to know how to raise the funds and where they should go. I share his disappointment and I would urge you to vote in favor of the original Bill, without the House Amendment. Thank you.
