A vote of Yes will be in favor of overriding the recommendation of the Committee.

THE PRESIDENT: The Chair recognizes the Senator

from Waldo, Senator Gould. Senator GOULD: Thank you. Mr. President, Ladies and Gentlemen of the Senate. Under the direction of Samuel S. Silsby, Jr., the Maine State Archives has developed as one of the outstanding State Archives in the nation. The James Henderson appointment was opposed by an impressive array of experts who spoke of Maine's need to maintain a high-quality professional and non-partisan archivist. I quote:

"This position is not just a political plum" said Doris Isaacson, Chairman of the Archives Advisory Board. "The Archivist is not to serve a party, but posterity" she further stated. Ann Thomas, a member of the Search Committee, complained the group was instructed to complete its work in only two weeks and to limit its hunt to Maine applicants. "This prevented us from conducting a nationwide search for a qualified Archivist", she said. State Historian, Robert York, echoed the same

objection, saying; "We should have had a bona fide national search."

I have received many letters from experts on this matter. Many of these letters were from certified genealogists who recommended a nationwide search to řill this position.

The law which governs the appointment of the State Archivist reads a follows, and I quote "He shall be chosen without reference to party affiliation and solely on the ground of professional competence to perform the duties of his office." The State of South Carolina requires its Archivist to have a Ph.d. in history and professional training in archival management. It also requires actual experience in archival administration, records management, historic preservation and documentary publication.

North Carolina requires a master's degree in history or related social sciences and three years of experience in archival or records management. They also require a thorough knowledge of the principles and practices of archival and records management and of the methods and techniques used in historical research.

Mr. President and members of the Senate, although this nominee is known to be very intellectually capable, and he has expertise in many areas, and he may be qualified for a number of other position, I question if he has, and I again quote Maine's statutes; "professional competence," end quote, to perform the duties of this particular office. Therefore, I will be voting to override the Committee's recommendation by casting a "yes" vote.

Thank you.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Tuttle.

Senator TUTTLE: Mr. President, Men and Women of the Senate: As Chairman of the Committee on State and Local Government I am speaking today in favor of the nomination of James S. Henderson for the position of State Archivist. The Maine State Archives is hardly the place you would expect to find a political It's essentially a collection of maps, family bibles, antique state documents and legal cases. Its a place most Maine people have never heard of. But a few weeks ago, a number of citizens came before the Committee on State and Local Government talking about politics in the Maine Archives. Who'd have thought it?

As most of you are aware, they were concerned about the nomination of Mr. Henderson, by Secretary of State as the next State Archivist. The Committe The Committee on State and Local Government was told the search was not long enough, but this was easily, in my opinion, iustifiably dismissed because Jim Henderson holds a doctorate at the university level and has many years of experience in areas such as this and during our research the committee found that there isn't a clear job description for this position anyway. When asked who the critics would recommend, most responded by saying we should probably look out-of-state for this position. When asked what this would cost, the figures for the job were about twice what the position is currently paying.

Easily dismissed were the critics assertions that Secretary of State Rodney Quinn was making the Archivist a political pawn; that the Archivist is not to serve a party — but posterity. It was my opinion and the opinion of many others at the committee hearing, while the opponents didn't come right out and say it, that their main objection to Henderson's credentials was that he was an active Democrat.

The only Archivist the state has ever had, Mr. Samuel Silsby, Jr., has announced that he is retiring after twenty-one years of dedicated service. Mr. Silsby was picked by then Secretary of State, Kenneth Curtis, a Democrat who had to deal, for the most part with an opposition Executive Council. While the Archivist job is not supposed to be a political plum, the Deputy Secretary of State's job, which Henderson has held for the last eight years, traditionally is a political appointment and in my opinion, there lies the main problem and confusion. During Jim Henderson's tenure as Deputy Secretary of State, his responsibilities have included overseeing state and county elections, and business corporations.

Among the sensitive tasks that Henderson has handled well, in my opinion, are certifying the eligibility of candidates and initiated referendums, distributing ballots, phrasing referendum questions, making official the election results, and referring ballot recounts in close elections, a job that has sometimes put him at odds with leadership on both sides of the aisle. It is my opinion and the opinion of many others that Jim Henderson has done a very good job. He is always accessible, he is very intelligent, and knows election laws inside out. If he is selected as State Archivist today, which I hope he is, this excellence would continue in that position.

This reminds me of a similar situation that occurred in my home town of Sanford when I was on the Board of Selectmen. Our historical archives had been kept in a vault for over one hundred years and the only people who had access were a few people who had the key. There was only one key. When asked if school children could see our archives, this person said it was inappropriate. When asked if the head librarian in my town could use the archives for research, they said it was not the librarian's domain. When asked if the Board of Selectmen could view the archives, we were told that we were not qualified. So what the Board of Selectmen did was to move the archives to the Sanford Town Hall Annex where they are now kept so that school children, citizens of Sanford and all people who are interested have a chance to view Sanford's historical records. I feel we are addressing a similar situation here. We need to bring the Maine Archives into the twentieth century. When the co-chair of our Committee went down to the State Archives and asked to see them, the person on duty had forgotten the combination to the vault, which I think addresses the issue at hand before us today.

A vote for Mr. Henderson will be a vote to initially bring the Maine State Archives into the twentieth century; and within a short period of time into the twenty first century! It will provide an appropriate way to manage these records and provide access for the public at large, something, not only in my opinion, but the opinion of many others that is long overdue. It is for that reason that I strongly endorse the nomination of Jim Henderson, and in all objectivity, hope you will, too. Thank you very much.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Baldacci.

Senator BALDACCI: Thank you. Mr. President. Mr. President and members of the Senate. As a member

of the Committee on State Government and sitting through four hours of testimony at a confirmation hearing, the most disturbing thing to occur was to have an individual become a victim of circumstances. The individual, James S. Henderson, was presented to the Committee as a nominee for the role of State Archivist. It was our job as a confirming body to review the qualifications of the individual and to see whether we felt that that individual was qualified for that particular position. That was our role. However, the process to get to that particular point, is not an issue before the body. I believe, it was an issue of whether the person was qualified or not. It is very disturbing to me, to listen to someone, who has a history degree from the University of Maine, and I'm very interested in history, to sit there and listen to people talk about somebody who has a doctorate in political science, whose very involved in Maine history and who has been working in Maine history who was a professor at the University of Maine, who was on the Bangor City Council, who was on the State Legislature, being talked about in this type of fashion. Jim Henderson and I have never gotten along politically. Jim Henderson and I don't agree on certain things. But that was not the issue before the body. The issue before the body was Jim Henderson's qualifications. That's what is very disturbing to me. All of a sudden we're talking about a national process. We're talking about 2 or 3 difference states in the south, where, by the way, they combine their Historic Preservation Commission Officer with their State Archivist, which is why they have a strong degree of history requirements, because they're historic preservation officers. To say nothing of the cost of conducting a national search the implementation and finally, ultimately, the person selected. And how many of us here have been stopped on the street and asked: don't we have anybody here in the State of Maine that can do the job? Why do we always have to go out-of-state?

I submit to you that this individual is going to do an excellent job in this particular position. Jim Henderson has very strong professorial qualifications and I think he will do a very good job. And I think that the thing here that we must remember as a Senate, is that we are here to judge an individual, not by the process that they used to get here, but by that individual himself. I think we owe it to that individual, and other individuals that are going to come before other Committees. There are 19 Joint Standing Committees and I think that it's up to us to set the standard here and not get down to a level thats going to cause us not to work together in the future. Thank you Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot. Senator Pearson.

Senator PEARSON: Mr. President, Men and women of the Senate. I don't want this debate to go along without responding to a rather small comment, a rather brief comment that was made with regards to the availability of the archives to any individual that wants to go over there and use it. I have not had occasion to use the archives very much since the time of the Indian Land Claims Settlement. At that time, I did go over and, to the best of my ability, read each and every one of the treaties that was negotiated between the indians and the State of Maine and I couldn't have been afforded any more courtesy at that time. They were very very helpful to me and I'm sure that no one has any desire to suggest that you can't see the archives or use the archives. I'm sure that Senator Tuttle must have been referring to a day that was not normal because, I think the normal

procedure of the archives has been most courteous and most helpful

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Bustin.

Senator BUSTIN: Thank you Mr. President. Ladies and Gentlemen of the Senate: I've just picked up from my desk, and I had not looked through the pile fast enough to know that I had this but I had spoken to another member of the Legislature about his concern over this matter and told him that I would be willing to read into the record a letter to the editor that he wrote. Because of our policy on mentioning the other body, I will not mention his name, but I would like to have permission to read

this letter for the record.
"To the editor: In the recent controversy over the State Archivist's position, it has struck me, as a Maine historian myself, that several dimensions have been missing from what is essentially a very shallow debate.

I speak not only as someone who has written several books on aspects of Maine history (and is in the process of writing a history of Maine) but as a member of the Secretary of State's Advisory Committee and as a State Representative who has been involved in public policy questions regarding the Archives in the past.

First, I must admit to having been astounded at the reaction of some members of the Advisory Committee to what I had regarded as an agreement over how to conduct the search and what we were looking for in a candidate.

I came to my position on this matter from the standpoint of having been embroiled in the fierce controversy before the Audit Committee some eight years ago over the role of the Archives in the management of state records. At that time, because of strong dissatisfaction with the way the management of state records was being handled, there was a concerted effort to take that function away from the Archivist and give it to the Department of Finance and Administration. I fought that move, along with others, and we were successful in keeping the function within Archives. But the experience led me to feel that any new Archivist should have a strong background in Maine state government and the handling of its records, lest future dissatisfaction lead to the same kind of fight we had before.

Quite frankly, Ĭ believe that the hue and cry over this matter is not over the lack of any nationwide search for the best qualified Archivist in the world. I believe it is a carefully orchestrated, highly political attempt to freeze the present Archivist in his position.

As an historian, it would also be interesting to go back over past columns of those newspaper editorialists who are clamoring for a nationwide search and see how many time they wrote (and the Jack Freeman episode comes immediately to mind) "We have just as good talent in Maine. Why don't we pick one of our own?"

THE PRESIDENT: The Chair would advise the Senator from Kennebec, Senator Bustin, that it is not proper to talk about action of the other Body in this Not in reference to particular individuals Chamber. and what it is they may write. Because of the complexity of the agency, I think some of the people on the Committee, and myself included, had difficulty in ascertaining a rational standard by which a nominee for a commissionership should be viewed. We did, refer to our statutes for some guidelines. But unfortunately, our statute, being perhaps a creature of compromise, didn't give us any effective guidance. It tells us that of our five member Commission, at least four members on that Commission have to be consumers and Mrs. Goldblatt was being nominated for one of those positions. Our statute goes on to tell us what a consumer is not but it no where defines what a consumer is.

Beyond that there is an open question as far as whether or not an individual posted to this particular Commission should in his or her background have some degree of experience in matters of finance or health care regulation to assist that individual in addressing the complex workload the Commission is presented with. There is no real background in this area, I did attempt to ascertain the background of other nominees and other commissioners and I did not have all the information available to me when the hearing was held this past Wednesday

The committee split, as you can see, five to three. I cast a negative vote. My vote though was basically a procedural vote. I did not feel comfortable at that time either casting a vote yea to confirm the individual or a true straight no vote meaning that I was opposed to Mrs. Goldblatt's going on the commission. I would have preferred to have the matter tabled for a brief period of time in which I could make an assessment to determine what a fair standard would be. Unfortunately, we didn't have

that option, we had to vote this nomination up or down. I guess we could have abstained so for that reason I cast a negative vote and I indicated that in my remarks just prior to the vote and I must say this caused all of us, myself included, alot of difficulty.

Mrs. Goldblatt is an excellent person. In fact, she is a friend of my family, she is an intelligent woman, she has demonstrated her commitment to community service and I think it is a fair statement that she unfortunately had to go through a rather lengthy hearing and I have alot of sympathy and compassion for the woman because she has a desire, a sincere desire, to serve the citizens of the State of Maine and certainly all of us feel somewhat concerned about having a person sit through that kind of an arduous, torturous process.

In any event, I had hoped that the matter had been resolved. We had a nice discussion after the hearing and I think the issue had been resolved and I certainly have respect for my colleagues on the committee and felt that the committee itself had decided the issue and in fact, I have learned today that under our statutes actually the legislative committees are the confirming authority and not this Body. We can veto a confirmation by a committee but effectively the committees are the entities which confirm a gubernatorial nomination and I have certainly respect for my peers on the committee and had felt that the issue would be put to rest. Well, the next morning, I awoke, got my morning paper, found out that Paul Molitor had hit again and is keeping his batting streak alive, and all was well in the world. At that point, I perused the first page, I read the sports page first obviously, I perused the first page of the paper and read a rather disturbing article and the article contained comments by an individual who was employed in the Executive branch of Government, in fact in the capacity of press officer to the Governor. The comments essentially characterized the committee proceedings as, or at least the actions of those who had cast negative votes against Mrs. Goldblatt's, as being partisan in nature. My first impression was gratuitous jibberish and leave it at that, but it seems to me that it really strikes at a more important issue and thats why I wanted to address that issue in these somewhat extended remarks this afternoon.

There is an essential role which this entity of state government, the Maine Legislature plays. have an obligation to fairly and honestly access each and every nominee that the Governor posts to various agencies of State Government. Sometime our tasks are difficult, especially in cases like Mrs. Goldblatt's nomination where there are really not any discernable criteria by which to assess her nomination. Now certainly reasonable people can disagree in terms of a particular nominee and that is precisely what happened in our committee and Representative Rolde, for example, Senator Gill felt, and Senator Gill, I will point out was one of the authors of our statute and she very clearly understands far better than I the history of this agency and I have a great deal of respect for Senator Gill and she argued eloquently and rationally that Mrs. Goldblatt in fact had the requisite qualifications to serve in this particular I was disturbed because the individual who position. was quoted in the press had not been present in the committee room, had no knowledge, no direct knowledge of what had happened. Had apparently acquired information by hearsay. Imparted to the public, imparted to the people of the State of Maine, the impression that this Body was abusing its responsibilities, that is was acting in an irrational, and arbitrary, capricious, partisan

fashion. I take umbrage at those remarks I think they're irresponsible. Irresponsible because they are not informed, they are irrational. It can not be said strongly enough that in discharging our responsibility we are simply engaging in the coordinate, articulation of public policy.

The Executive branch of government obviously has

to lead by nominating individuals to state agencies and boards but we of the Legislature, acting in a non-partisan fashion have a significant role to play. If that were not the case, then I suggest to you that you simply ought to repeal the statute which would require confirmation of nominees by this entity. It would make no sense whatsoever if we were to simply rubber stamp all nominees. That is an irrational result, I don't think is was intended by the Legislature, it was not intended by the Governor who signed that statute into law and it is that particular value, the coordinate articulation of public policy of which I speak today and I'm certain in todays activities there was a great deal of question about the nomination of the State Archivist and I'm sure that will carry most of the press today. In my perspective, it seem to me, that issue will probably die down in one year or two years or three years, but the value to which I speak that having mutual comity between competing branches of government is an important value. It forces us to pause and consider as we go about making public policy choices and that is a very healthy aspect of the American polity. It sets us apart from other societies. It is not mischievous that the Legislature has its role to play. I would point your attention to Article 1 of the U.S. Constitution are delineated our authorities of the U.S. Congress.

I take this occasion, at some length, to note my extreme displeasure at that type of behavior. Speaking back to the nominee, Mrs. Goldblatt, this is a very difficult choice. It was a difficult choice for the committee. There is no question whatsoever this woman, because of her background, her intelligence and her commitment to public service, would be qualified for a whole range of public boards and commissions. I had a very difficult role to play in trying to assess whether or not she would have the technical expertise to serve on the Health Care Commission. Obviously I view this commission as being a technical one, one that would require some type of experience and background in health care regulation. A majority of my colleagues on the committee do not take that position and I respect their views and I intend today, in fact, to vote to support the committee recommendation. I will be drafting legislation for consideration in the next Session that would consider whether we should have some type of criteria set forth as far as qualifications of commissioners. This will be a difficult issue, but I felt it was important to me at this time to raise my concerns and I hope, I sincerely hope, that my commentary today will cast in a fairer light the actions which were taken by the Committee on Human Resources. Thank you for your patience.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Gill.
Senator GILL: Mr. President and Ladies and

Senator GILL: Mr. President and Ladies and Gentlemen of the Senate. The Committee on Human Resources did go through alot of deliberations during the hearing, we asked alot of questions, we got alot of responses. We recessed to take the vote and then we came back and we had further discussion on the nominee and the criteria set up in the statutes. My good seat mate on Human Resources Committee and my Chairman, Senator Gauvreau, mentioned the archivist

position which we voted on earlier today and I think the differences in the two criteria set up is that the archivist had very little definition about what an archivist in the State of Maine should contain. I think as far as this position, Mrs. Goldblatt came before us as a nominee for, there is some definite definition in the statutes dealing with that particular nomination. It says that a person eligible for appointment to, or to serve on, the commission shall be conversant. It doesn't say with high technical knowledge or technical or having technical conversation about this particular board, the Health Care Finance Commission and if that is indeed, and that was part of the argument that the committee was going through, whether this woman was purely a consumer which the statute calls for. It says that at least four of the five members shall be consumers. When we set this statute in place we deliberately wanted the consumer represented and we fully recognized the fact that as people come on this board, which is an awesome board, I have served in the Legislature for twelve years and in all of my twelve years have been spent on one committee and another committee but I have spent twelve years on Human Resources, Health and Institutional, and I am probably more conversant with the Health Care Finance Commission then anyone in the Legislature and I'm still not considered an expert in that field and neither has any of the nominees in the past before us been an expert in the field so that they could go on the commission and get rolling full swing immediately on their first meeting. It takes a number of meetings, it takes alot of study and I think the statute as written, Mrs. Goldblatt does fill the qualifications.. She has great dedication, she has educational experience to understand what the commission's work would be about, she was diligent she was prepared to spend the time to learn and she went through a very, very difficult hearing. What concerns me about a hearing like that is that we ask people to volunteer to serve on various boards and commissions for no money and when we put them through the paces, and I'm not saying legislators shouldn't put people through paces and ask questions, but when we grill people and put them through the paces that we did on the committee, I wonder why people volunteer their time to serve on any board in state government.

I had no qualms at all about having Mrs. Goldblatt serve in this position. I read the statute and she certainly is conversant. She's got a background in home health care, she's served as Director of the Androscoggin Home Health Care Services, she's spent alot of time volunteering alot of areas in her Lewiston-Auburn area up there and she knows the community needs there and I think she can fulfill this position very well. The Committee did get mixed up in conversation about what should be in the statute versus what is in the statute and I think Mrs. Goldblatt took the brunt of that. I'm sorry for that but I hope that we all vote to sustain the committee's vote. Thank you.
