In Senate Chamber Thursday January 21, 1988

Off Record Remarks

Senator ANDREWS of Cumberland was granted unanimous consent to address the Senate on the Record. Senator ANDREWS: Thank you Mr. President. Mr. President, men and women of the Senate. This week we received on our desks what is called the Telecommunications Access Plan by the Department of Administration and the Office of Information Services. I hope that you will all take a look at this access plan. The plan is designed to make state government accessible to hearing impaired persons. Those people who use telecommunications' devices that allow them to communicate over telephone lines with state government. Part of the package we have before us is a targeted T.D.D. Deployment Program for areas of state government where they think T.D.D.'s should be placed as soon as possible. One of those areas identified is the Legislature. I am sure I speak for everyone in this Chamber when I express my gratification that the Legislature has been identified as one of the deployment areas and we ask the Department to move as quickly as possible to make the Maine Legislature accessible to hearing impaired people by installing T.D.D.'s here for Senators and members of the other Body.

I also want to note while on the subject my great pleasure in witnessing during the State of the State Message this past week, Governor McKernan having his message interpreted for hearing impaired people as they watched in their homes across the State. It was a major step forward and I congratulate him as I am sure we all do for that step. Finally, for those who provided us with this report, they do indicate that there are other public areas in the State that we have required to be accessible to hearing impaired people including hospitals, airport terminals, bus and train depots. They indicate that there has been no state agency or group to ensure that the intent of the law is carried out, but that certainly does not mean that they do not have an obligation to carry out this legislation.

We will be looking at that situation very closely during the course of this Session and if at the end of this Session we find that there is non-compliance with the law, then we may have to take action before we leave to make certain that the law is carried out. Thank you very much.
