- 2. To generate jobs and other economic activity within Maine directly related to the export-import traffic;
- 3. To induce jobs and economic activity in Maine-based industries indirectly benefiting
- proximity to a modern port;

WHEREAS, the encouragement of exporting by United States business and industry is a national priority due to this nation's serious foreign trade imbalance:

WHEREAS, the value of the American dollar is at a record low, offering United States exporters an excellent opportunity to establish new foreign markets and to recapture markets lost when the dollar was at a record high; and

WHEREAS, the Federal Highway Administration, acting as lead agency, has recently issued and approved a Final Environmental Impact Statement on the Sears Island Project and this document now serves as a basis for review of application to the United States Army Corps of Engineers and the United States Coast Guard for permits to proceed with the project; and

WHEREAS, the proposed Sears Island cargo terminal is strongly supported by Governor McKernan, the entire Maine Congressional Delegation, the Waldo County Commissioners and the Town of Searsport and in 2 separate bond issues the voters of Maine have also

given their approval to this project; and
WHEREAS, the proposed dry cargo terminal for
Sears Island would make a valuable contribution
toward the expansion of export trade and thereby greatly assist the Maine and national economy; now, therefore, be it

RESOLVED: That the 113th Maine Legislature calls upon President Ronald W. Reagan to request immediate assistance and support in securing prompt action by the Federal Government on all pending permits and requests for federal aid associated with the construction of the proposed Sears Island Dry Cargo Terminal Project.

RESOLVED: That suitable copies of this Memorial, duly authenticated by the Secretary of State, be transmitted to the President of the Senate and the Speaker of the House of Representatives in the Congress of the United States and to each Member of the Maine Congressional Delegation.

Senator CLARK: Thank you Mr. President, men and women of the Senate. You would be interested to know that the Maine State Museum has recently been cited as having one of the "top three" museum exhibition in the entire United States. The Museum was commended for their "Made in Maine," the large exhibit that explains the history of Maine products and industries. It is the result of a national award competition sponsored by the Society for the History of Technology, and the museum, our museum, shares top honors across the country with such prestigious institutions as the Smithsonian Institution and the Henry Ford Museum. That is quite a compliment to the State of Maine and to the director and people who work in our Maine State Museum.

The Smithsonian, interestingly enough and by sharp contrast, has a staff of six thousand and a budget of three hundred million dollars. The Maine State Museum, under the directorship of Paul Rivard built the "Made in Maine" exhibit with a staff of twenty-seven. The Henry Ford Museum boasts a staff of over eleven hundred during the summer season and has a budget of eighteen million dollars. Of course, our Maine State Museum with its nationally recognized exhibit has a budget which is a tiny fraction of

those two giants.

The Maine State Museum is one of the smallest state museums in the nation, yet we recognize it and it is recognized on a par with the giant museums. The "Made in Maine" exhibit was judged to be superior to a number of other huge museums, among the exhibits nominated but rated in the "top three" were from the Franklin Institute in presentations Philadelphia, the Museum of Science and Industry in Chicago, and the Brooklyn Museum. No other state museum other than our own state museum was nominated. I would urge members of this Senate to acknowledge, in word and perhaps, note that this recognition is entirely due to the commitment of the hard working and talented staff, combined with the moral support in leadership of the citizen commission and this Legislature. Thank you very much.
