Senator WEBSTER: Thank you Mr. President, ladies and gentlemen of the Senate. It is my intention today to oppose this nomination for a number of reasons. I represent a large area in Somerset and Franklin County, part of Kennebec County and a large area which is unorganized. There is some very strong

feelings in my district, particularly among the unorganized areas, that this nominee perhaps would not in the best interest of their concerns.

It is my opinion that people who live in western Maine, the people who live in unorganized territories, are entitled to have jobs and some of the decisions made by LURC over the past few years have not been in the best interest of jobs for rural Maine. For these reasons I would oppose this nominee. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Clark.

Senator CLARK: Thank you Mr. President. Mr. President, men and women of the Senate. I would hope that you would join with the unanimous Committee Report from the Joint Standing Committee on Energy and Natural Resources and resoundingly confirm this candidate for renomination to the Land Use Regulation Commission. Elizabeth Swain experienced. is Elizabeth Swain is dedicated. Elizabeth Swain believes that issues should be addressed with an open mind and with no prejudice or bias beforehand. It is with deep regret this morning that I hear from the Senator from Franklin, Senator Webster, that he is going to vote against her renomination to the Land Use Regulation Commission. Unfortunately, Senator Webster was not present during the confirmation hearing to listen to the testimony and review the credentials of this candidate for reappointment. I would submit to you that Elizabeth Swain, who comes from the town of Pownal one of the smallest towns in Cumberland County and reflects many of the small towns in western Maine, is as sensitive if not more so to the issue of jobs for Maine citizens as well as the responsibilities placed on her as a member of the Land Use Regulation Commission as any other qualified candidate would be. This woman is eminently Let's support this qualified. renomination Élizabeth Swain.

Senator BRANNIGAN: Thank you Mr. President, men and women of the Senate. I just find it very difficult to understand and would like clarification from the Senator from Franklin, Senator Webster, as to why he has made these broad sweeping statements about the lack of qualifications of this appointee. This appointee was appointed by the Governor that came from my party and she has been reappointed by the Governor from his party.

It seems to me that there must some very specific reasons why this person is not qualified and if that is the case I think the Senator should specify what those things are that make her unqualified at this time for this nomination. Thank you.
